This document has been prepared by the key Group A Plaintiffs that are bringing a major Civil RICO, VICAR (Violent Crimes Aiding Racketeering) lawsuit against the Defendants responsible for the crime of September 11, 2001. There are many violations of the US Criminal Code cited within the lawsuit. This lawsuit is being brought by Group A Plaintiffs on behalf of Groups B, C, D and E. There is an army of approximately 2 million Plaintiffs versus 250 or more defendants. During Court Ordered Discovery the number of defendants is expected to rise significantly as Jane Does and John Does are identified.

Last year in 2025, the foregoing groups cited in the document title begged to see a 40-page PowerPoint that discloses some of what you will read below. None of them took a meaningful step on the information disclosed in that PowerPoint document, which represents approximately 1% (one percent) of the evidence the Group A Plaintiffs have amassed since the day of September 11, 2001. Some of the information you will read was known as early as 1992 forward in time. Chronologies are used to solve crimes and identify names along the way. Focusing on just September 11, 2001 does not find the evidence leading up to or after that day.

The years 1992 to 1999 will prove to be as crucial as 2001 itself in understanding the motive for 9-11, why it was done, and most important who did it. The Group A Plaintiffs are thankful that former HASC Vice Chairman Curt Weldon, Captain Raul Angulo and Erik Lawyer have come forward in 2025. They each provided crucial missing links that the Group A Plaintiffs were trying to ascertain, resolve and add to the voluminous evidence. Dr. Aaron Good, PhD had 45 minutes of geopolitical realities to present at "Turning the Tide" and was allotted 15 minutes. September 11, 2001 is inextricably joined like Siamese Twins to geopolitical realities spanning well over a decade and unmitigated greed.

Many dates will be conclusively confirmed in Court Ordered Discovery and additional names. The Plaintiffs have enough names and evidence for certain parties to have already been named as defendants and know exactly where to aim an intensive court ordered discovery for interrogatories, depositions, production of unredacted evidentiary documents for litigation. Many sets of interrogatories are already prepared in advance of the lawsuit being filed. Some of the evidence trails are easy to prove once discovered and exactly who was involved in the crime of September 11, 2001.

Every crime has a motive, and regarding the crime of September 11, 2001 this document reveals the extent of US coverup and deceit to conceal the truth from Americans and the world. It did not take the Group A Plaintiffs until 2006 or later to wake up or two decades to finally declare what the Group A Plaintiffs knew on the day of September 11, 2001 itself. All three towers in NYC, WTC 1, WTC 2 and WTC 7 were destroyed by controlled demolitions. Our investigation as to who did it, why they did it and

track down names, entities, etc. to build a criminal case started on the day the crimes happened in NYC and at the Pentagon.

The following is the opening statement of the Plaintiffs lawsuit as the Overview of Cause of Action.

OVERVIEW OF CAUSE OF ACTION

It has been said by wise and historically knowledgeable people throughout history that the first casualty in any war that is initiated by an aggressor is always the truth. There are previous court cases in multiple states in the US District Court, and state courts, even in two (2) circuits of the US Court of Appeals that shed light on why September 11, 2001 happened, why the World Trade Center was destroyed, and what the real motives and objectives were for creating that day of infamy. In short, that intentional and premeditated casualty named Truth was by the hands of the Defendants in this Lawsuit. It was nothing less than the premeditated and intentional assassination of the Truth in “shock and awe” horror story fashion by the Defendants as their cover story to deflect attention away from their long-planned crimes. Any reader of this document will better understand these words that appear again in this overview: “modern atrocity propaganda”. The United States has used that ploy in many nations since the George H W Bush Administration as an excuse for military intervention based on lies and fabricated “intelligence”, manipulation of facts to justify the inexcusable.

April 3, 1967: David Rockefeller is on the cover of Newsweek magazine about his bold vision for the World Trade Center and a new era in banking. Oddly, his wristwatch is visible and shows the time “9:11” am in New York City.

1969: Congress passes NEPA, the National Environmental Protection Act, and President Richard M. Nixon signs it into law.

1971: The construction was halted on WTC 1 North Tower and WTC 2 South Tower. The reason was the 1969 NEPA (National Environmental Protection Act) banned the use of asbestos. At the time, the steel erection and roof were in place on WTC 1 North Tower. The steel erection on WTC 2 was slightly over 50% complete. Had the asbestos been addressed then, the projected cost was \$1 billion; the Twin Towers cost a total of +\$900 million.

Apparently, Rockefeller and the Port Authority New York & New Jersey selectively decided to disobey US law and continued construction without asbestos remediation. It is horrible enough that close to 3,000 people died on September 11, 2001, including 372 citizens from 61 other nations, but the death toll has

not ceased and is now multiples of how many died on that one day in September 2001 due to asbestos induced cancer. Yet, the PANY&NJ, City of New York and the United States government continue to lie, stall and ignore the damage done that now goes past negligence into criminal law. Hardest hit post-September 11, 2001 have been First Responders, WTC tenants, area residents and businesses in Lower Manhattan, school students, and the clean-up crews. This matter is touched on again due to a 2015 and 2019 article revealed below.

1987: PANY&NJ v Allied Corporation lawsuit filed in New Jersey State Court, Law Division, Newark NJ. Plaintiffs lost the lawsuit in part due to “failure to act timely” for 16 years.

October 1990: A 15-year old Kuwaiti girl Nayirah, tearfully told the Congressional Human Rights Caucus about Iraqi atrocities she allegedly saw in a Kuwait hospital. She did not disclose her last name. She did not see anything in Kuwait, is the daughter of the then Kuwait ambassador to US Saud Nasser Al-Saud Al-Sabah. Her father also made false statements before the same Caucus and did not disclose that Nayirah is his teenage daughter living with him in the United States.

The matter was investigated, and it was disclosed that the public relations firm of Hill & Knowlton coordinated this false message to Americans on behalf of “Free Kuwait”. In the aftermath of the Gulf War, the Nayirah testimony came to be regarded as a classic example of “**modern atrocity propaganda**”.

September 11, 2001 was exactly the same **modern atrocity propaganda** and will be proven in Court before a Jury.

1990 or 1991: The Zionist Israeli Jew Neocon Edward Luttwak, member of JINSA, a known Arab hater, was asked in late 1990 or early 1991 what the US was going to do to Iraq. Also note he is also the author of “Coup d ‘etat: A Practical Handbook” that is almost elevated to the level of The Neocon Game Plan.

"Saddam is not like the Saudi Princes who spend the bulk of their lives outside of their country, and who fritter away the Kingdom's oil profits on prostitutes and bottles of champagne in Paris. No, Saddam is building railways! Creating electrical networks! Highways and other important elements of a serious State infrastructure! After eight years of war against the Iranian regime of Khomeini, he desperately needs to demobilize his Republican Guard, which incorporates so many of this technical elite, in order to rebuild his war-devastated country. These people are his technicians, his engineers. If they are put to work in the way Saddam wishes, they will rapidly make Iraq the most advanced power in the region, and we cannot allow this to happen."

The 4th largest national oil reserves in the world apparently cannot be allowed to be developed for the benefit of the Iraqi people. Many Americans that have read the foregoing have major problems with the “we” because Israel never boots up, locks and loads for battle with the United States in combat.

The entire “anti-Semitic” push is a fraud. Semite does not mean Jew. Semite is a language group that includes Afro-Asiatic as spoken in Ethiopia and part of Sudan, Aramaic, Hebrew and Arabic.

The United States and George H W Bush Administration were completely untruthful. First, US oil companies and the Kuwaitis had stolen a large amount of oil from the Iraq Basra oil field with “slant” or “directional drilling” methods. Saddam Hussein was claiming \$6 to \$7 billion was due. Second, former US ambassador April Glaspie informed Hussein that “the United States has no interest in an Arab-Arab dispute”. Even before Saddam Hussein ordered his army to invade Kuwait and collect what was due, the George H W Bush Administration had US Special Forces in the Persian Gulf posing as Kuwait Navy and

firing on Iran and Iraq positions to stir up tensions. Those US Special Forces soldiers were in hostile action months before Saddam Hussein and the Iraq army took military action and entered Kuwait.

After the Karl Schwarz book was published in 2004 and matters of US policies and fabricating wars was discussed many times on radio shows, a former US Special Forces soldier contacted Schwarz and requested a meeting in Georgia. At the time, Schwarz was living in Alpharetta GA and drove to meet with this former member of US Special Forces. What is stated in the previous paragraph was confirmed by this former soldier and Pentagon sources for Schwarz verified to him that it was all true, including black op names and dates months before Iraq invaded Kuwait to collect the claimed oil theft debt. Such information is hidden so Americans could not know what was done to create a needless and illegal war of aggression. By international law definition, that was a war crime by the George H W Bush Administration as well as criminal level theft of oil.

After the Desert Shield and Desert Storm were levied upon Iraq, George H W Bush made several remarks that infuriated people that knew what really happened. First, "Saddam, get out of Kuwait!" Secondly, after Desert Storm, "Now we can see a New World Order coming into view". Lastly, "If Americans knew what we did, they would chase us down the streets and lynch us."

The harsh sanctions levied on Iraq, killed an additional 500,000 to 600,000 people in cruel ways and many were innocent elderly men and women, and many children. The US "shock & awe" application of excessive use of Depleted Uranium, "DU" left a legacy of high spikes in cancer. The use of DU weapons was banned many years ago by the United Nations due to being "a weapon of indiscriminate harm", because the death toll increases long after real combat was over.

Years later, the Clinton Administration Secretary of State Madeline Albright was asked about this legacy of harm inflicted on another nation. She stated to Leslie Stahl on TV "we think it was worth it". Of course, she is as pro-Israel Arab hating Zionist as Edward Luttwak.

In the lawsuit being prepared by Plaintiffs Group A there are no Saudi defendants, 1 Kuwaiti directly related to Nayirah and her father, and 1 other Afghan Muslim that earned the nickname "The Butcher of Bosnia" as an operative of the US government. That Afghan Muslim recently retired from the US State Department and has a work history of anti-Christian slaughter and anti-Muslim slaughter activity. The historical record per Wikipedia now claims a former Serbian general is now referred to by the same nickname but that is not true as readers will see below regarding events in 2006.

That same corrupt Kuwaiti Defendant was directly involved with Marvin P. Bush, and Bush relative Wirt Dexter Walker, III and others in the World Trade Center security company. That includes the real WTC security company, not the front name Securacom to cover up the real identities and evidence trails.

The real WTC security company was involved in 16 states, not just New Jersey and New York at the World Trade Center.

Even as far back as Desert Shield and Desert Storm there has been colossal damage and harm to the US military lives that were forced to take CBW vaccines that were not needed. The level of birth defects within US military families has been staggeringly high. Deaths and disability to US soldiers due to vaccine injury alone has been staggeringly high. In 2003, when Canada declined joining Bush and Blair for Iraqi Freedom, an underlying reason was the harm those vaccines did to Canadian soldiers. See 2003 regarding former Prime Minister of Canada Stephen Harper.

March 18, 1991: TIME magazine article by George J. Church titled "Soviet Union: Operation Steppe Shield?". This article revealed that even prior to that time the George H W Bush

Administration was developing a contingency plan to invade the USSR in what is now called the CIS region. That is the region referred to as “the Steppes”. Some of the nations, now comprising the CIS are Kazakhstan, Uzbekistan, Turkmenistan and even the Autonomous Republic of Dagestan, that chose to remain part of the new Russia Federation. These nations contain vast oil and natural gas resources and other valuable natural resources. That was a United States plan to seize that area by military force. The purpose of September 11, 2001 was after the exact same prize of which Afghanistan is a key part due to its energy and natural resources and the need for pipelines to get oil and natural gas to ocean ports.

The United States tried forcing its way through to the Arabian Sea in 2001 as “Pipeline Route A”, and again in 2008 Georgia with a midnight assault on South Ossetia as “Pipeline Route B” to the Black Sea. It will be proven in court before a jury that Afghanistan was a totally lost cause by 2002 to 2006. Any reader of this document should take note of the years and window they represent.

When the CIS formally separated from the former USSR in the 1990’s, the Plaintiffs have a list of US companies and names of who went rushing to seize control over oil, natural gas and energy related services as much as they could grab. That entire area is landlocked. What had been standing in the way from Day 1 was the Taliban and later China in a major agreement between that nation and Pakistan. The United States is not welcome in Afghanistan for historical and political reasons. An Argentina company was way ahead of the United States and they were welcomed by the Taliban. See 1992 to 2006.

1991 Desert Storm: There was a noticeable pause on launching Desert Storm that the US has refused to address or explain. In researching the Schwarz book “One Way Ticket to Crawford Texas” the real reason was discovered a full 10 years before September 11, 2001.

A rheumatologist that was still in USAF Reserve medical, was rushed to the Middle East area to determine why many of the US Navy personnel in an aircraft carrier strike group were suffering from arthritic like symptoms and unable to fulfill their duties. The cause was WMD vaccines for smallpox and anthrax, especially the latter. That carrier strike group had to return to port and be replaced with another strike group. This matter came up again in 2003 when Canada Prime Minister refused to commit Canadian troops to Bush’s Iraqi Freedom. It also involves why DynCorp wound up owning the sole source anthrax vaccine provider to the Pentagon BioPort and changed name to DynPort Vaccines, LLC, Reston VA to evade billions in vaccine injury judgment from courts.

DynPort Vaccines, LLC and the harm those vaccines are doing is revealed in Chapter 5 of the Schwarz book. The FBI refused on 3 telephone calls from Schwarz to add DynPort, but the former BioPort Vaccines was on the List of Suspects for the September 18, 2001 anthrax attacks on media and Congress. There were many ill and 5 dead, that are still unsolved murders that will be solved soon with evidence and truth.

1991: PANY&NJ, Trans-Hudson Corporation v Affiliated FM Insurance, et al filed in New Jersey US District Court, Newark NJ. This litigation was seeking \$6 billion from the insurers to reimburse for asbestos remediation in the top 10 floors of offices in WTC 1 North Tower. The main tenants on those floors were Cantor Fitzgerald, Marsh McLennan, Nishi Nippon Bank, and Mitsui Bank. The PANY&NJ plaintiffs were seeking \$4.5 billion for asbestos removal and remediation and the balance was for the 3 airports serving the area Kennedy, La Guardia and Newark. The Plaintiffs lost the lawsuit in part due to “failure to act timely”. The 1987 Allied lawsuit is cited in the final order, again a “failure to act timely” issue all the way back to 1971.

Those 10 floors in WTC 1 North Tower were the only offices spaces in WTC complex that asbestos had been removed per the US law banning asbestos.

Note for the record that former CEO Howard Lutnick of Cantor, next door neighbor to Jeffrey Epstein, and his sister that also survived on 9-11-2001, will be deposed and might wind up defendants due to a \$120 billion bond issue matter that was due on September 12, 2001 and Cantor was to handle that matter.

What was odd about this huge asbestos lawsuit is the PANY&NJ used in-house attorneys rather than retain a major and experienced law firm in such litigation. That suggests to the Plaintiffs that they were trying to keep secret that long list of errors in judgment that have now caused a death toll far higher than 9-11-2001 itself. Said another way, the Kill Zone was not just the WTC site. It was everywhere in Lower Manhattan that asbestos laden dust cloud went.

January 1992: Bidas Corporation of Argentina signs oil and gas development agreement for exploration rights for Yashlar block in eastern Turkmenistan, 50-50 split on revenues. US energy companies coveted getting control of this tract.

February 1993: Bidas Corporation signs second agreement for oil and gas development with Turkmenistan on the Keimir Oil and Gas Block in western Turkmenistan, 75-25% split on revenues in favor of Bidas. US energy companies coveted getting control of this tract.

February 26, 1993: WTC 1 North Tower is bombed. It came out in the trial that the FBI had directly and indirectly aided and abetted that crime. An FBI asset that was recruiting the bomber was recording his conversations with his FBI handlers that were providing the necessary materials for the bomb.

During the 1990's, ENRON was trying to get a pipeline done from Turkmenistan thru Afghanistan, across Pakistan and into New Delhi and further south to Dabhol India. That project failed at some point and the US lost approximately \$1 billion in guarantees.

July 1993: Clinton fires FBI Director William S. Sessions, a former US District Court Judge with an impeccable record. Sessions had opened an internal investigation inside the FBI as to who in the government agency had directly aided, abetted and enabled from within the FBI the February 26, 1993 bombing of WTC 1 North Tower. Former AG Janet Reno (deceased) called Clinton to inform that she no longer had faith that Sessions could effectively run the FBI. It is the Plaintiffs position that former US District Court Judge William S. Sessions was more experienced in law enforcement than Janet Reno was for even 1 day of her life.

If this document and the entire matter is looked at objectively, pragmatically and as a real investigation, the February 26, 1993 bombing may well have been an attempt to demolish WTC 1 to get insurance funds to fix the asbestos problems the PANY&NY have been remiss, criminally negligent, and incompetently dealing with since 1971.

July 1993: Clinton fires with immediate effect FBI Director William S. Sessions. The FBI Director had initiated an internal investigation as to who in the FBI aided and abetted the bombing of WTC 1 North Tower.

1995: Bidas commences negotiations with the Taliban.

1995: Unocal, Delta Oil and US Government attempting to pressure Taliban to abandon contract negotiations with Bidas and pressure Turkmenistan regarding Bidas contracts.

October 1995: President Niyazov (Turkmenistan) signs agreement in New York with Unocal/Delta Oil (Saudi investors). Turkmenistan starts jerking Bidas around on its Oil Contracts with that government.

Jan. 1996: Bidas signs agreement with Taliban and General Dostum for Trans-Afghanistan pipeline, generally referred to as TAP.

Feb. 1996: Bidas v. Unocal, Delta Oil, et al, \$15.0 billion interference of contract lawsuit filed in Fort Bend Texas. Dismissed, was appealed to Texas State Court of Appeals. One of the co-owners of Delta Oil is Khalid bin Mahfouz, the brother-in-law of Osama bin Laden. In short, the Saudis were business partners in what the US objectives and intentions were regarding the TAP and Afghanistan. Not named as defendant was the United States government and certain instrumentalities and proxies thereof for initiating, aiding and abetting that interference of contract.

March 1996: U.S. Ambassador to Pakistan, Tom Simons, urges Prime Minister Bhutto to give exclusive rights to Unocal. Bhutto offended and demands apology.

November 1997: Unocal tries to woo Taliban away from Bidas and are rejected by Taliban. This also included rejection of Saudi controlled Delta Oil. Delta Oil were business partners with Unocal to get control of the Bidas Corporation TAP (Trans-Afghanistan Pipeline) and also directly in bed with Amerada Hess east of Azerbaijan in the Delta-Hess joint venture, Cayman Islands domicile. That Thomas Kean, the CEO of Amerada Hess at the time was handpicked by George W. Bush to head the 9-11 Commission is highly questionable. It also raises a valid question of: "Why would the Saudis as US partners attack the US when they were business partners in the targeted Caspian basin region?"

There is a correct answer, but it does not involve the Saudis.

Another key question will be how did radical Islamic males wire WTC 1, WTC 2 and WTC 7 for controlled demolitions and then hijack and fly jets into them for effect on TV and cover up those controlled demolitions?

November 21, 1997: The company pretending to be the WTC security company was Securacom of New Jersey. That firm was sued for trademark violation and the Defendant Securacom lost. It was appealed twice to keep the matter tied up until the 1997 final order from US District Court Newark and until 2000 on 2 appeals at Third Circuit US Court of Appeals in Philadelphia. The real WTC security company was based in Delaware, registered as a foreign corporation in 16 states years before the use of the name Securacom. In all 16 states and Delaware, the real WTC security company predates Securacom and wrongful use of that name by years. Many of those registrations and names are named defendants in the lawsuit the Plaintiffs are bringing against the US government and other entities and persons. Securacom went to US District Court for trademark violation and included defendants KuwAm Corporation, Mishaly S. Sabah, related to Nayirah, and Bush relative Wirt Dexter Walker III. There are many other names lurking behind the scenes across 16 states as the real WTC security company.

The opening statement of the US District Court judge in the final order of the Newark NJ lawsuit is as follows:

"This action in one of its aspects is for trademark infringement and unfair competition brought under the Lanham Act and the statutes and common law of the State of New Jersey. In another disturbing aspect, this action is part of the ruthless abuse of the litigation process by an arrogant venture capitalist and his investment vehicle to prevent a trademark claimant from seeking to pursue his rights under his trademark. November 21, 1997."

The arrogant venture capitalist is Kuwaiti, a direct shareholder in the real WTC security company while the Securacom charade was going on to conceal the real identity or who was the real WTC security company. Also involved in the New Jersey lawsuit and 2 appeals to Third Circuit US Court of Appeals was Bush relative Wirt Dexter Walker III. Wirt was also involved in the put options on United Airlines and American Airlines and FBI did nothing about it. The lawsuit records and corporate records are clear as to who was involved in 16 states as the real WTC security company. The person the US District Court judge is referring to is related to Nayirah al-Sabah and a close friend and co-investor with the Bush Family.

Aug. 1998: Clinton launched cruise missiles at Afghanistan. Al Qaeda or bust up that Bidas contract? Zalmay Khalilzad involved in Bosnia, Afghanistan and interference of contract aimed at blocking Bidas until the United States could create a reason to attack Afghanistan if all else fails.

Oct. 1998: A Texas judge dismisses Bidas' US\$15 billion lawsuit against Unocal and Delta Oil for preventing them from developing gas fields in Turkmenistan. The Argentina company appeals to the Texas State Court of Appeals.

January 20, 1999: First appeal to Third Circuit by defendant Securacom. Argued on June 26, 1998. Opinion Filed: January 20, 1999. Amended February 8, 1999. Remanded back to US District Court, New Jersey.

August 1999 – April 2000: Chechnya War 2; Main phase: 7 August 1999 – 30 April 2000, (8 months and 24 days)

Insurgency phase: 1 May 2000 – 16 April 2009, (8 years, 11 months and 15 days). This included both Clinton Administration and Bush Administration waging covert war inside of Russia Federation.

After Chechnya realized that it was the CIA and their proxies that were stirring up the problems in their home, in Chechnya War 2 that region aligned with Russia Federation and they easily won the war. However, as revealed at Kiev Maidan 2013-2014, it was about to start again as an overall “anti-Russia agenda” by the United States, CIA proxies and Ukraine Neo-Nazis in bed with the CIA since 1947.

November 1999: Karl Schwarz, author of 2004 book “One Way Ticket to Crawford Texas, A Conservative Republican Speaks Out” meets 2 men of Bidas Corporation. The entire details of Turkmenistan, Afghanistan, Pakistan and Port of Gwadar, Balochistan are revealed and the lawsuit matters in State of Texas, Bidas v Unocal, Delta Oil, et al, \$15 billion interference of contract. Those details included the change of strategy for arbitration claim that amounted to \$495,000,000 in reimbursement due to contract interference by US and proxies, Unocal, and Saudi controlled Delta Oil.

1999: Former Vice Chairman of House Armed Services Curt Weldon, and Chairman of a subcommittee overseeing a \$180 billion per year defense research budget had completed what is referred to as the Fusion meta-data software. Every US agency wanted it, except the CIA. The Plaintiffs in this action know that the CIA had already polluted the meta-data to create the cover story that “radical Islamic males were going to attack the US with hijacked commercial jets”. The Schwarz book “One Way Ticket to Crawford Texas” addressed this sort of CIA meddling in Chapter 8 titled “Planting Weeds in America’s Rose Garden”. The George W. Bush Administration and former CIA Director George W. Tenet planted lots of weeds to cover up their crimes and create diversion trails in many directions.

1999: FBI counterterrorism had detected that the CIA was illegally operating inside the United States and using a Saudi GDI office in Los Angeles CA to do so. Probably due to FBI the CIA suddenly stops sharing crucial information with the FBI counterterrorism and the CIA did not want the Fusion program that could have detected what they did. Most of the alleged hijacker visas that were either declined at the Jeddah Saudi Arabia US Consulate office but overridden by the CIA, or were pushed through quickly by John Brennan while he was stationed in Jeddah. It is a relatively easy conclusion to make that George Tenet and John Brennan know each other and were working on the same diversion plan.

2000: Bridas loses the appeal in Texas State Court of Appeals, seeks a review by the International Chamber of Commerce for damages due to contract interference that cost them a lot of money. That ICC awarded \$495,000,000 was due as reimbursement.

2000: CIA was operating drones over Afghanistan supposedly looking for Osama bin Laden, who was in Ladiz Iran and being treated for kidney failure at an Iran military base. Uzbekistan declined their request to operate Predator drones from their nation. Discuss the Ladiz matter with former Vice Chairman House Armed Services Committee Curt Weldon. He had learned to not trust the CIA and had his own intelligence sources. See late 2002 regarding another meta-data program that was presented by Schwarz associates at CENTCOM in Tampa, FL.

April 2000: Pentagon conducts “mass casualty drill” due to a hijacked jet hitting the Pentagon. That simulation had full scale airplane parts in the interior Pentagon courtyard. A commercial jet cannot penetrate five rings of the Pentagon and be strewn in the innermost area of the Pentagon.

2000: In the 2000 Project for a New American Century (PNAC) document ‘Rebuilding America’s Defenses’ is the following policy recommendation. The Plaintiffs maintain that any decent, humane and sane person would read this part of the PNAC statement and wonder what sort of evil lurks in that group and those in Washington DC they have access to and influence. “The report states, **“advanced forms of biological warfare that can 'target' specific genotypes may transform biological warfare from the realm of terror to a politically useful tool”.**” There are now many illegal bioweapons labs positioned near Russia, China, in Africa and South America. They are being hidden on the Pentagon budget because testing on humans without clinical trial approval is illegal in the United States, as it should be. See 2012, Richard Lugar Lab, Tblisi Georgia. See February 24, 2022 SMO commences in Ukraine.

June 5, 2000: The US District Court Newark NJ grants partial summary judgment against PANY&NJ in favor of many of the participants in Affiliated FM Insurance, et al. That statement is in the final order dated May 17, 2001.

2000: The two most common explosives used for controlled demolition are RDX and Gelitin. The RDX also has another use in detonating thermonuclear warheads, and is therefore heavily and carefully regulated by the US government. Most controlled demolition experts prefer Gelitin.

The Austria art group that was originally named “Gelitin” conducted a project they named “B Thing”. They apparently got permission from PANY&NJ to remove 1 window and extend a wooden balcony out of WTC 1, North Tower. They rented helicopters, took many videos from various angles, heights, etc. After that was done, all videos were surrendered or confiscated by someone. These events and the following are highly suggestive of foreknowledge that 9-11-2001 was going to happen on some date and WTC would be destroyed.

In addition to the “B Thing”, the website of Gelitin showed 3 men in WTC and there were boxes labeled “BB 18”. Those devices are fuse holders and are used in controlled demolitions. The Plaintiffs have 2 such photos with the “BB 18” boxes in clear view. This group, whoever they are, later changed their name to Gelatin, which is not a powerful explosive used in controlled demolitions.

Furthermore, the Austria art group drew sketches of their exploits and posted them on their website. One sketch shows a WTC tower unharmed, a jet headed at the higher floors, and a handwritten comment: “Last chance to parachute.” Below that was WTC tower shattered and collapsing. Those photos are available if a person knows how they have now hidden them on their website.

Lastly, the “Gelitin B Thing” art work was scheduled to debut at a Jewish owned NYC art gallery on September 11, 2001.

August 21, 2000: On Appeal from the United States District Court for the District of New Jersey, (D.C. Civil No. 95-cv-05393) (Senior District Judge: Honorable Dickinson R. Debevoise), See SecuraComm Consulting Inc. v. Securacom Inc., 166 F.3d 182 (3d Cir. 1999) (“SecuraComm Consulting I”), No. 99-5326. Argued: February 8, 2000. Filed August 21, 2000.

Second appeal to Third Circuit by defendant Securacom. After the remand in 1999, the Defendants appealed again and kept the matter tied up in court until 2000 as indicated above and what follows below. On Appeal from the United States District Court for the District of New Jersey District Judge: Honorable Dickinson R. Debevoise (D.C. No. 95-cv-05393) (D.C. Civil No. 95-5393) (D.C. Civil No. 96-3247); SLOVITER, Circuit Judge.

“This appeal marks the second time the remedial portion of this trademark case has come before us. In the first appeal, defendants Securacom Incorporated, KuwAm Corporation, and Wirt D. Walker, III (collectively “Securacom New Jersey”) sought reversal of the District Court’s award of profits, treble damages, and attorney’s fees after the court found that Securacom New Jersey had willfully infringed the trademark of SecuraComm Consulting, Inc. We reversed the award of profits and treble damages on the ground that the record did not support a finding of willful infringement and remanded as to the award of attorney’s fees. See SecuraComm Consulting Inc. v. Securacom Inc., 166 F.3d 182 (3d Cir. 1999) (“SecuraComm Consulting I”).

On remand, the District Court again awarded attorney’s fees and denied Securacom New Jersey’s motion for the judge’s recusal.”

The real WTC Security Company was hiding behind the name Securacom. That will be proven before Court and Jury.

2001: The original Bidas Corporation plan after signing 2 major agreements with Turkmenistan was the TAP (Trans-Afghanistan Pipeline) from Ashgabat Turkmenistan, through Afghanistan with approved and signed contracts with General Rashid Dostum and the Taliban. The TAP would have continued further south and southwest to the port city of Gwadar, Balochistan Province Pakistan on the Arabian Sea. At some point in 2001 and what appears to be well before September 11, 2001, China and Pakistan initiated negotiations on CPEC, the China Pakistan Economic Corridor that is part of the China Belt & Road initiatives around the world. The Belt & Road concept includes roads, rail and maritime to make the necessary interconnections. The CPEC is from Gwadar Pakistan thru that nation to China as a much shorter route from the Middle East and Africa than going all the way around India, Singapore, Southeast Asia, etc. to China. That would be considered by most to be good business sense.

The plaintiff's lawsuit naming who did September 11, 2001, will prove that common sense in Washington DC is not so common.

January 20, 2001: George W. Bush and Richard B. Cheney sworn in as President and Vice President of the United States.

March 2001: Former President of Yugoslavia, Serbian Slobodan Milosevic was arrested and charged with genocide and war crimes for the slaughter of Bosnian Muslims. The exact opposite was true. The United States was arming Bosnia Muslims to slaughter Christians in Bosnia and Serbia to justify the US and NATO bombing of Serbia in 1999 during the Clinton Administration. Until the US and others started trying to re-write history to conceal crimes, former Afghan Zalmay Khalilzad, former US State Department, directly involved in trying to upend that Bidas Corporation achievements in Turkmenistan, Afghanistan and Pakistan earned the nickname "The Butcher of Bosnia". Bush appointed him as US Envoy to Afghanistan and later the same role in Iraq after the 2003 invasion that Bush and many others literally fabricated exactly as the George H W Bush Administration did in 1990-1991 as Desert Shield – Desert Storm. See March 2006.

Due to the extensive use of DU weapons by the United States and NATO, Serbia has experienced significant spikes in cancer cases as happened in Iraq after Desert Storm 1991. Depleted Uranium is a misnomer and the Pentagon knows it and why the UN banned it due to it being a "weapon of indiscriminate harm". It will blow a hole into a tank but keep killing many years later. The reason is there is no technology available to completely remove all radioactive U234 and U235 from U238 that they are saying is "depleted". U238 itself is a deadly toxic heavy metal, add in the 2 radioactive isotopes it is much deadlier for a long time.

Spring 2001: The US Army 10th Mountain Division is mobilized to train for invasion of Afghanistan. The first military engagements against the Taliban after October 7, 2001 were 10th Mountain, Green Berets, and CIA Special Activities Division. The Plaintiffs have uncovered information that CIA Special Activities Division was active in Afghanistan prior to September 11, 2001. That matter will be addressed in Court before a Jury.

Exact date on this matter to be verified in court ordered discovery. Supposedly the CIA's Alec Station was conducting a huge effort to find Osama bin Laden. A CNN crew found him and interviewed. An ABC crew found him and interviewed, yet the CIA with the biggest budget plus illegal drug money slush funds and proxies failed to find him. When the whole truth about September 11, 2001 is known, why the CIA failed to find Osama will be clear to see for much of the world.

Late Spring 2001: Donald J. Rumsfeld and CENTCOM General Tommy Franks are before Armed Services Committee. When asked what the primary mission in Afghanistan General Franks quickly stated: "the pipeline and access to the regions resources". Rumsfeld quickly intervened to change the subject to Osama bin Laden and "fighting terrorism". Neither admitted "The Bidas TAP pipeline and access to the regions resources" was the primary mission.

April 1, 2001: US Navy EP-3E reconnaissance plane collides with Chinese fighter jet and the EP-3E is forced to land on Hainan Island. China stripped the plane of sensitive US military technology. It is very likely that the US military had to change a lot of equipment to different modes and models, so China could not use US technology to spy on the US. If that did in fact happen and FAA radars were not upgraded, some planes equipped with new military grade hardware and software would have been invisible as of September 11, 2001 to anything not able to detect the new mode versions. Such a quick upgrade may well be where much of the missing \$2.3 trillion disappeared to from the Pentagon.

The Plaintiffs are aware of the multiple NORAD hijacking drills and other matters. Those will be dealt with in court ordered discovery and trial. The Plaintiffs are also aware that some of the most key military positions were conveniently unavailable the morning of September 11, 2001. At least 1 high ranking officer left and did not even appoint anyone to be in charge in his absence.

April 2001: Persons in the Pentagon wanted to conduct another “mass casualty drill” regarding a jet hitting the Pentagon. That was not approved due to being “too unlikely”.

May 17, 2001: PANY&NJ, Trans-Hudson Corporation lose the \$6 billion asbestos lawsuit.

May 9, 2001: Bush appointed former Texas Supreme Court judge Priscilla Owen (nee Redman) to Fifth Circuit US Court of Appeals. That court just happened to be where the Bidas Corporation appeal was pending to enforce a \$495,000,000 million ICC (International Chamber of Commerce) arbitration award. Note April 21, 2006 the name Owen in the PDF of the final order. She is the same judge that Senator Patrick Leahy intentionally delayed her confirmation hearings until after Bidas prevailed at Fifth Circuit US Court of Appeals on September 9, 2003. She has now returned to her maiden name Redman. See late August 2003.

Senator Patrick Leahy (D-VT) may have intentionally delayed her confirmation hearing further after the September 18, 2001 anthrax attacks were aimed at him, former Senator Russ Feingold (D-MN) and Speaker of the House Tom Daschle (D-SD). The ‘anthrax’ was acting like it was partisan political and only went after liberals in media and Democrats. That included Editor NY Post for detailed reporting of EPA coverup and false statements.

Early June 2001: Secretary of Defense Donald Rumsfeld modifies the ROE (rules of engagement) for US jets confronting hijackings, enemy jets, or other unauthorized penetrations of US airspace. Deleted was the hostile armed approach of follow orders or be shot down. Only option jet fighter pilots had on September 11, 2001 was come up from behind, follow to observe and intervene only if ordered to do so.

July 24, 2001: Larry Silverstein and Australia real estate developer Frank Lowy, now resides in Israel, sign 99-year lease on World Trade Center. Note for the record that the \$4.5 billion the PANY&NJ were seeking to fix the asbestos problems was the “magic number” that Lucky Larry got for the “two terrorist attacks” on WTC 1 and WTC 2. It was a terrorist attack, but not by Saudis or “radical Islamic males”. Once the preponderance of evidence clearly shows that WTC 1, 2 and 7 were controlled demolitions, the “double terrorist attack” and Lucky Larry gets \$4.5 billion from insurance companies is extremely problematic as in insurance fraud similar to arson.

August 2, 2001: Bush renews negotiations with Taliban to take over the Bidas accomplishments while the Argentine firm is tied up in US courts. The negotiations are more like threats of military force and Taliban declined.

August 6, 2001: Bush asleep at the helm regarding President’s Daily Briefing [PDB] and attack on U.S.

September 9, 2001: The most powerful and respected warlord in Afghanistan, Ahmad Shah Massoud, a Pashtun, was assassinated by a camera crew. That Jordanian crew was recruited by the CIA. During the Russia-Afghan War 1980-1988, Russia nicknamed Massoud “The Lion of Pansjhir”, which equates to never enter the Pansjhir Valley with hostile intent. Massoud had already informed the United States they were not welcome in Afghanistan. Whatever position he took, most or all warlords would do

the same because he and his army is who sent the USSR troops home permanently dead or alive. Massoud was considered to be a National Hero for the key role he and his army played in ending the Russia-Afghan War.

September 10, 2001: “Most experts agree that the Caspian Basin and Central Asia are the keys to energy in the 21st century”, said energy expert James Dorian (Oil & Gas Journal, 9/10/01), "Those who control the oil routes out of Central Asia will impact all future direction and quantities of flow and the distribution of revenues from new production." The Plaintiffs have enough information to prove in Court before a Jury that the above written statement in an article is the real motive as to why George W. Bush and many others blamed Afghanistan for September 11, 2001. Deep research into what US companies, law firms and persons were rushing after Kazakhstan, Uzbekistan, Turkmenistan and other adjacent nations that have vast reserves of oil and natural gas, that belongs to those nations, has revealed names and actions that are now named defendants in the lawsuit the Plaintiffs are filing against the US government and others.

This was also the real reason for the George H W Bush strategy of “Operation Steppe Shield” as reported by Time magazine in March 1991. Every crime has a motive. The crime of September 11, 2001 involved trillions of dollars of oil and trillions of dollars of natural gas that belong to other nations. Missing was the US in control of the Bidas SAPIC TAP to get oil and gas to Gwadar until CPEC blocked what Bush and PM Tony Blair were after.

September 10, 2001: Donald Rumsfeld admits in a Pentagon press briefing that the Pentagon cannot account for \$2.3 trillion dollars. The next day the team of US military and private contractor experts investigating that matter were murdered at the Pentagon.

September 11, 2001: At 8am Larry Silverstein had a scheduled meeting with bomb experts from Fort Monmouth AMC about preventing a terrorist attack on his WTC 7. That meeting was purportedly set up by the NYC field office of the Secret Service. Since the Silverstein side cancelled the meeting at the last minute, the Fort Monmouth AMC team saw 9-11-2001 unfold from a nearby café. The problem with Larry Silverstein’s mythology is WTC 7 was already wired to be destroyed by controlled demolition at approximately 5:20pm.

September 11, 2001: There was another 8am meeting across the street at WTC 1, North Tower in the offices of Marsh McLennan. Attendees were a high-level Marsh executive, Marsh IT people and 1 person who was running late. His name is Richard Andrew Grove, a software specialist with a company that sold a very advanced system to Marsh and he had been collaborating with the Marsh IT people to get it up, running, and fully functional. Mr. Grove noticed considerable amounts of statistical glitches that had every appearance of significant amounts of money laundering Marsh was doing. This meeting was to address that matter. Mr. Grove saw WTC 1 get hit but he also noticed something else. He saw certain types of vans, like in the movie “Enemy of the State” where NSA had mobile command and spying centers. All of the Marsh people perished in WTC 1 North Tower.

September 11, 2001: A powerful bomb exploded in the basement levels of WTC 1 North Tower before the alleged hijacked Flight 11 hit the WTC tower. The sinister objective of this explosion was to disable the freight elevators, which are not on the fire alarm system like the 3 banks of passenger elevators and eliminated any ability by NYFD to get to the higher levels to fight that fire, rescue people or evacuate wounded or the dead.

September 11, 2001: A powerful bomb exploded in the basement level of WTC 2 South Tower before Flight 11 allegedly hit the North Tower and before Flight 175 allegedly hit WTC 2. The

sinister objective of this explosion was to disable the freight elevators, which are not on the fire alarm system like the 3 banks of passenger elevators and eliminated any ability by NYFD to get to the higher levels to fight that fire, rescue people or evacuate wounded or the dead.

The Plaintiffs have evidence that what really hit WTC 2 was not a hijacked Boeing 767. The “kill shot” on WTC 2 South Tower was a Boeing 737. That will be proven in court before a jury and reduces the US Official Story to be a blatant lie.

September 11, 2001: A WTC Twin Towers design reality as to the two preceding comments about the freight elevators. The Twin Towers had 3 banks of passenger elevators. One bank went from the ground floor lobby to the 40th Floor. The middle bank went from the ground floor lobby to the 78th Floor. The third bank went express from the ground floor lobby to the 81st to 110th Floors. The 79th and 80th Floors were mechanical rooms that serviced heating, air conditioning, electrical, communications, domestic water, fire sprinkler system, etc.

On impact of the alleged Flight 11 on WTC 1, the fire alarm system automatically shut off the elevators servicing Floors 81 to 110. Without the freight elevators that go to all floors and are not disabled by fire alarm system, the NY Fire Department was unable to get to the higher floors. On impact of the alleged Flight 175 on WTC 2 on the 78th Floor, all elevators from 41st to 78th and all elevators from 81st to 110th floors were shut off when the fire alarm system activated.

It is a known fact that a NY Fire Department team rode the elevators to the 40th Floor of WTC 2 and then had to walk up to the 78th Floor. NYFD team leader Orio Palmer radioed precinct that there were 2 small fires, and both were containable. Within 1 to 2 minutes after that message, WTC 2 collapsed killing all remaining in the building.

September 11, 2001: ACE Elevator had been given the Otis contract well before September 11, 2001. On the day of September 11, 2001, that company reportedly had approximately 80 employees at WTC and left. They did not help free people that were trapped in WTC 1 and WTC 2 when the jets hit, and the fire alarm system disabled the banks of elevators previously mentioned.

The reason this is important is because the only way to get to the superstructure center core of the WTC towers is via the elevator shafts. Most laymen do not know the elevator shafts are a separate structure from the building itself that is carrying all dead loads and live loads except the elevators. In fact, it is standard operating procedure to take out the elevator shafts before the building itself. The elevator shaft structure is intended to carry the live loads (people, freight, office supplies, etc.) and its own dead load. The elevator shafts are anchored to the main structure but merely by welded angle irons or steel plates and will sheer easily when the much greater loads of the building collapse are coming down entirely and completely into a rubble pile. The elevator shafts are merely braced to the superstructure to prevent the elevator and counterweights from creating a sway in any direction, left, right, forward and back, while ascending or descending. It would not do to have say 10-20 stories, or more, of elevator shaft still standing when the goal was to rubble pile everything in the building. In high rise buildings, 110 stories tall like WTC 1 and 2 and 47 stories tall like WTC 7 and then have to contend with a steel skeleton tree that might prove to be dangerous trying to complete the controlled demolition.

September 11, 2001: The alleged hijacked American Airlines Flight 11, a Boeing 767-200ER, hits WTC 1 North Tower at 8:46am at approximately the 92nd Floor. There was one video that captured the jet all the way to impact, but from a distance it was not possible to identify the jet as being American Airlines or a Boeing 767-200.

September 11, 2001: From the New Jersey side of the Hudson River, 5 Israelis had a tripod and camcorder set up and recording the events at the World Trade Center. They were nicknamed “the Dancing Israelis” because they were celebrating, dancing and doing High 5’s gleefully celebrating that the United States was under attack.

September 11, 2001: The alleged hijacked United Airlines Flight 175, a Boeing 767-200, hits WTC 2, South Tower at 9:03am. That will be proven in Court before a Jury to be a colossal lie by the United States government. There is video and still photo evidence that the jet that hit the 78th Floor was a Boeing 737 painted to look like a United Airlines plane. For readers unaware of a 1950’s plot involving Cuba named Operation Northwoods, they should read what the CIA and Pentagon plan was to fabricate a war with Cuba.

The Schwarz teamed proved what really hit by still photos and wing span. In 2025, Brad Zerbo of Badlands Media presented another way to prove that what hit WTC 2 was not a hijacked Boeing 767 by length of the jet in “CODEX 911”. Maybe all of Congress needs to watch that and get their heads around what is coming at Washington DC.

Kroll Associates is a named defendant. That company had stepped in late as the alleged WTC security company and was telling everyone in WTC 2 South Tower that everything was under control so return to their offices. There are many survivors of WTC 2 tenants that can attest to the erroneous instructions they were given by Kroll. What was the purpose of such ludicrous instructions? Increase the number of dead on September 11, 2001?

Kroll Associates had also hired former FBI counterterrorism expert John Patrick O’Neill reported in August 2001. His first day on the job was reportedly September 10, 2001. He died the next day trying to get people out of WTC 2 when that was the first building to suffer global collapse from very minor fires.

John Patrick O’Neill left the FBI because he had been conducting his own research into the bombing of WTC 1 North Tower and had been ostracized and ridiculed for doing that.

September 11, 2001: The first person to be on MSNBC and directly blaming Osama bin Laden and Afghanistan was L. Paul Bremer of Marsh McLennan. His office was in WTC 2, all of Marsh McLennan in WTC 1 North Tower died on this day. Supposedly, Bremer did not go to the office that morning, went to MSNBC instead. In 2003, Bush appointed him to head Iraq and his right hand was Bernard Kerik, former NYC police commissioner and convicted felon on matters later that do not involve September 11, 2001.

September 11, 2001: Allegedly hijacked American Airlines Flight 77 allegedly attacked the Pentagon at 9:37am. However, there are both time line discrepancies and flight path discrepancies that are not consistent with provable facts in Court. There is evidence that Flight 77, a Boeing 757-200 did not hit the Pentagon and was nowhere close to the Washington DC – Arlington VA area.

There is photographic evidence of shattered jet pieces that were quickly removed from outside and inside that Pentagon that what hit was an A3 Skywarrior painted to look like a small American Airlines jet and what blew the 14 to 16-foot hole 3 rings deep into the Pentagon. No jet fuselage can do that. Some at the Pentagon reported the entire area reeked of cordite. That is a propellant for air-to-air and air-to-ground missiles including what are called “bunker busters” that do leave a sign consistent with the hole 3 rings deep on the Pentagon. Multiple sources have identified that the shattered jet pieces are not Boeing 757, are A3 Skywarrior origin.

Another extremely problematic matter is who was targeted at the Pentagon were investigating where \$2.3 trillion had disappeared to from the Department of Defense coffers.

September 11, 2001: WTC 2 South Tower collapsed at 9:59am. There is now sufficient evidence to prove that WTC 2 was a controlled demolition that required thermitic reactions and powerful bombs to destroy the massive superstructure core that each tower had to be 110 stories tall.

September 11, 2001: WTC 1 North Tower collapsed at 10:28am. There is now sufficient evidence to prove that WTC 1 was a controlled demolition that required thermitic reactions and powerful bombs to destroy the massive superstructure core that each tower had to be 110 stories tall.

September 11, 2001: At approximately 5pm, the BBC announced live on TV “we have just learned that the Salomon Building has collapsed”. BBC reporter Jane Stanley was online live with London. The WTC 7 was visible on that TV announcement and still standing in the background in lower Manhattan.

September 11, 2001: At approximately 5:20pm, WTC 7 was brought down in a controlled demolition. Former NYC employee Barry Jennings, now deceased, is on the record that while he was in WTC 7 making sure the building had been evacuated bombs started going off. He had to walk down many flights of stairs because those bombs took out the elevators and shafts. There are technical reasons why the elevators and shafts are taken out before the rest of the bombs are detonated on heavier beams and columns to bring the building down in a controlled demolition.

September 11-12, 2001: Approximately 1 hour after WTC 7 was destroyed, a flight left Kosovo with crates. Part of the security team were with UNMIK, which is controlled by the US government. Others on the flight did not identify themselves and as to the crates said it was a “Need to Know” matter. When the plane landed the crates were offloaded and transferred to Chinook helicopters and flown into Northern Afghanistan. The destination was an old Russia military base. General Rashid Dostum’s headquarters and home is that old base. The crates were opened to inspect the delivery. That is when UNMIK personnel knew it was hundreds of millions of US dollars. This matter was reported by Karl Schwarz in “Part VI: Pop Goes the Bush Mythology Bubble”. Parts 1 and 2 of that same series revealed colossal conflicts of interests of some of the 9-11 Commission members and why Bush hand-picked them for that coverup.

After the 9-11 Commission concluded and proved nothing, former US Senator from Nebraska Bob Kerrey was asked on video, and he stated: “September 11 is a 30-year conspiracy”. Well, this PDF and facts prove that 1971 to 2001 is 30 years of endless lies and coverups.

Post 9-11 lawsuits: After 9/11, Securicor, currently named G4S, faced about 30 lawsuits from victim’s families. Another director that Condon supervised at Securicor, former Group CFO Trevor Dighton, said of the company’s liability – “I’m not worried about it one little bit. The two planes involved weren’t those that crashed into the towers – that’s the first thing.”

September 12, 2001: Rumsfeld reinstated the hostile approach for ROE.

September 11-14, 2001: The US Secret Service and the Fort Monmouth AMC bomb experts stayed onsite 3 additional days looking for “unexploded bombs”, when allegedly the WTC towers collapsed due to hijacked jets and minimal fires. Why would the US Secret Service and Fort Monmouth AMC bomb experts be looking for bombs when the alleged hijacked jets and small fires caused the disaster and thousands of deaths in NYC?

September 18, 2001: Anthrax attack, many very ill, 5 dead. Three members of Congress were targeted and certain liberal media voices and reporters. Senator Patrick Leahy (D-VT), chairman Senate Judiciary Committee; and Senator Russ Feingold (D-MN), only US senator to vote “No” on the Patriot Act and Senator Tom Daschle (D-SD). Note who Bush appointed in May 2001 to the Fifth Circuit US Court of Appeals and really pay attention reading further.

The FBI had BioPort Vaccines LLC on the suspect list but refused 3 times on phone calls between Schwarz and the FBI to add to that list their new owners DynPort Vaccines LLC, Reston VA. DynCorp was busted in the UK and State of Texas for sex trafficking underage females to UK and USA. Some reports estimated up to 200,000 Bosnian and Serbian females after their parents or entire families were killed by USA and NATO in Bosnia and Serbia, so Clinton and NATO could go play Wag the Dog in 1999 and after.

See May 2001 regarding Bush appointment Priscilla Owens. Her confirmation hearing was intentionally delayed by Senator Leahy. Also, see August 2003 and September 9, 2003.

September 11 – October 7: When it was apparent to former Vice Chairman of House Armed Services Curt Weldon that Bush intended to launch military action against Afghanistan, Mr. Weldon took a delegation to Rome to meet with the exiled King of Afghanistan Mohammad Zahir Shah. The NY Times reported on October 1, 2001 that 11 members of Congress and representatives of anti-Taliban Northern Alliance attended that meeting to seek approval from the warlords that the US could come into their nation peacefully. Note in previous text and especially the assassination of Pashtun Ahmad Shah Massoud on September 9, 2001, the most powerful warlord in Afghanistan and the Kosovo flight mentioned at September 11-12, 2001.

It is doubtful that former highly respected Congressman Curt Weldon’s effort had positive results for 2 reasons. First, the most powerful and respected part of the Northern Alliance was Pashtun “Lion of Panjshir” Ahmad Shah Massoud. The US assassinated him on September 9, 2001, just 2 days before September 11, 2001. Massoud had made it clear that the United States was not welcome in Afghanistan. Secondly, see November 25, 2001 below. The CIA Special Activities Division was rounding up anyone in Afghanistan that would or was resisting US presence in that nation. Bidas Corporation was welcome, the United States was not. Over time the US lost against the Taliban, case closed.

October 7, 2001: The US and UK attack Afghanistan with September 11, 2001 as the excuse. At a minimum the US had been practicing, provisioning, and moving war support equipment to US bases close to Afghanistan most of 2001 all the way to September 11, 2001.

November 22, 2001: The following is in the Schwarz book published in 2004. It was both in the text, the footnote and even the footnote was a copy and paste so the United States could not delete it as the truth it is.

The following is copied and pasted from the Schwarz book (January 2004) as it appeared in a foreign newspaper and in the book, Chapter 3, pages 88-89. The link to this article was blocked on the Internet shortly after it was published and was posted on the newspaper website in English:

11:01 2001-11-22

Bin Laden: Not all Americans are bad

“Mohammed Omar predicted the current campaign by the USA in Afghanistan 5 years ago, claiming that when the Taliban would not allow the US to build a pipeline they will begin to attack

us, justifying it with Bin Laden. [Plaintiff's notice to the Court is those 5 years leading up to September 11, 2001 is when Bidas Corporation was under full assault from multiple US and Saudi parties to block the Bidas SAPIC TAP.] [emphasis added].

Omar's words are reported by Hamid Mir, who made the last interview with Osama Bin Laden, who declared that he is not against the American people, only the politicians and the state.

In the first interviews, Osama Bin Laden had declared himself against all the American people, but he had changed. He admitted that there were many good people in the United States and it was the politicians and State, which he despised. He told Mir that he had seen many western people on television protesting at the bombing in Afghanistan and concluded, "They are good people. They are not Moslems, but they condemn the bombing".

November 25, 2001: The first claimed US casualty in Afghanistan was Johnny Micheal Spann, former US Marine, joined CIA Special Activities division. He was reportedly killed in a prison uprising. However, combat engagements with the Taliban by Green Berets, 10th Mountain and CIA Special Activities Division happened weeks before this alleged "first US death in Afghanistan".

December 2001: The Enron collapse was a major accounting scandal that led to the bankruptcy of Enron Corporation in December 2001, revealing widespread fraud and unethical financial practices. This scandal resulted in significant financial losses for investors and employees, and it prompted new regulations like the Sarbanes-Oxley Act to improve corporate governance and financial reporting standards.

After Unocal withdrew from the Unocal and Saudi controlled Delta Oil, interference of contract aimed at Bidas Corporation that led to a series of lawsuits in Texas courts, US District Court SD Houston and eventually Fifth Circuit US Court of Appeals, the Bush Administration was urgently trying to get a Hail Mary done with ENRON as the "US energy giant" to step forward. See February 2003.

December 31, 2001: President Bush appointed a former aide to Unocal, Afghan-born Zalmay Khalilzad, as special envoy to Afghanistan. The nomination was announced nine days after the US-backed interim government of Hamid Karzai took office in Kabul.

Early 2002: China and Pakistan sign the CPEC agreement and China commences construction on the Gwadar Port improvements. It would take court orders and Pentagon compliance to admit that George W. Bush had a "war planning team" evaluating ways to take that port back from China so the US could have it. It was probably impossible to do that without having Pakistan and China join the Taliban and send boat loads of body bags back to the United States and their buddies headed dead or maimed to UK.

February 8, 2002: Afghanistan's interim leader Hamid Karzai said he and Pakistani President Pervez Musharraf had agreed to revive a plan for a trans-Caspian gas pipeline from Turkmenistan to Pakistan. That plan is what Bush intended to steal from Bidas Corporation with military force.

December 27, 2002: Central Asia pipeline deal signed; An agreement has been signed in the Turkmen capital, Ashgabat, paving the way for construction of a gas pipeline from the Central Asian republic through Afghanistan to Pakistan. Note for the record, the ocean terminal end of that pipeline was to be Gwadar but had been blocked by CPEC.

November 14, 2002: PANY&NJ appealed the May 17, 2001 decision by US District Court, Newark NJ to Third District US Court of Appeals in Philadelphia and lost the appeal on this date. Note the PANY&NJ is based in NYC, which is under Second Circuit US Court of Appeals in Connecticut, and New Jersey is under Third Circuit in Philadelphia. What was odd about this appeal is PANY&NJ used in-house attorneys again rather than retain experienced counsel in such matters. However, this was way too late to stop what George W. Bush and former PM Tony Blair did to Afghanistan commencing October 7, 2001.

2003 – 2004: Schwarz and his original team of non-US scientists were called upon by DARPA and Pentagon TSWG (Technical Science Working Group) to provide solutions for the failing Global War on Terror. Even though solutions were provided, the Bush Administration killed every one of those projects including one for Iraq that was in response to an ONS (Operational Needs Statement) from the commanding general in Iraq. That project was approved for REF (Rapid Equipping Force) and went nowhere. It would have saved a lot of American and Iraqi lives. This matter is included in the Schwarz book that was published in 2004.

February 23, 2003: OPIC agrees to fund the pipeline and Bush has guaranteed to protect it with U.S. troops (without telling the United States citizens). “23-02-03 Turkmenistan, Afghanistan and Pakistan (TAP) have signed a protocol for trans-Afghanistan Gas Pipeline Project... However, some recent reports had indicated that the United States was willing to police the pipeline infrastructure through permanent stationing of its troops in the region. The US ExIm Bank, the Trade and Development Agency (TDA) and the Overseas Private Insurance Corporation (OPIC) had also shown readiness to finance such a project, if leading American energy giants come forward.” ENRON collapsed before they could be that energy giant to step forward.

February 2003: Bush announces in the State of the Union address to Congress his “Project BioShield”. By the end of 2003, a compliant Congress had created and passed the law enabling Project BioShield. The initial intent was to force vaccinate up to 10,000,000 First Responders for smallpox and anthrax, even though neither of those illnesses are anywhere in the United States. Later the intent was to force vaccinate all Americans with the same vaccines that are known to be harmful to humans. Only about 38,000 First Responders accepted the Project BioShield concept. The health outcomes have not been good for many of them.

March 2003: Based on fabricated intelligence and political lies, the Bush Administration and the Coalition of the Willing attacked Iraq in an illegal war of aggression. It can be proven in Court before a Jury that Iraq was in discussions with other nations to co-develop its 4th largest known oil and natural gas reserves in the world.

April 11, 2003: Pages 535 to 540 of the Schwarz reveals Bob Herbert, NY Times contacted Bechtel about the Aqaba Pipeline. Jock Covey sent an April 11, 2003 fax to George Schulz with advice as to how Schulz and Bechtel should “spin it” for the response to the article that was about to be published. The exact wording of the fax is in the Schwarz book less the last 4 digits of Covey’s phone number.

Please note the date, less than 1 month after the Bush Administration assaulted Iraq again on falsified information and justification. Mr. Covey’s fax to George Schulz pointed out that even during the Reagan-Bush Administration the US was after the same pipeline from Iraq to Aqaba to bypass the Persian Gulf.

Note for the record, Jock Covey was formerly the head of UNMIK. See September 11-12, 2001 regarding the flight that left Kosovo about 1 hour after WTC 7 was destroyed by controlled demolition.

Spring 2003: The FBI issues a 100% bogus “Saudi Dirty Bomb Suspect” alert on every US television network with photograph. Allegedly seeking “Adnan Gulshair el Shukrijumah” who is not Saudi or related to Saudis. This matter was revealed in Chapter 7 of the Schwarz book.

Long before Adnan was born, his grandparents and his father as a child moved from Yemen to Guyana South America where he was born. His father married a woman from Trinidad & Tobago and Adnan held a Guyana passport. Due to acute asthma since birth, the family moved to Miramar Florida for better medical care. His father was not a radical Iman of an Islamic mosque. He was a skilled trade worker in Guyana and the United States.

Adnan’s asthma was so acute at times, he was never a pilot as Wikipedia, the lie machine for USA claims. In fact, on Wikipedia that only truth on that website is stated was by the Saudis and Adnan’s mother. The rest is 100% FBI and Wikipedia lies. At least 1 time, seen by Schwarz, FBI blasted out another alert “Saudi Dirty Bomb suspect seen in Maine” and showed the FBI hotline number on every US TV station.

Karl Schwarz was dating a Canadian woman from Hamilton Ontario. Within 10 minutes the FBI knew exactly where their alleged suspect was and never, not once ever bothered to go talk to him. Adnan lived near her in Hamilton Ontario, had known him for 3 years as he was a medical student at McMaster University.

The phone call to the FBI was from the Schwarz home because she was in Little Rock AR for surgery that Canada was denying her due to a totally botched diagnosis in Canada. Karl Schwarz flew her on a private jet charter to Little Rock because she was in extreme pain. While she was recovering in the Schwarz home is when the FBI ran a 100% lie on every TV network in the US and she called them on the FBI 1-800 Hotline.

What was utterly disgusting is the FBI interrogated her for 15-20 minutes as to why she was in the US.

The US government are liars and agenda players and no problem with huge coverups.

August 2003: Previously mentioned Priscilla Owen, Bush appointee to Fifth Circuit US Court of Appeals in May 2001 where the Bidas appeal is in progress, calls Karl Schwarz at his home. She stated she was a senior aide to Karen Hughes. The subject matter was capital markets fraud, Williams Communications Group, Global Crossing and a crime in progress that the White House admitted was occurring and did nothing about it. Schwarz was the high bidder in US Bankruptcy Court, SDNY and it was Bush Pioneer backers that stole that huge network for \$250,000,000 and the Schwarz bid was far higher. Chapter 14 of the Schwarz book reveals what that conversation with Priscilla Owen was about.

September 9, 2003: Bidas prevails at 5th Circuit, U.S. Court of Appeals after years of being jerked around in Texas courts. \$495 million arbitration award upheld. This appeal was from US District Court SD Houston. Note for the record, Mayer Brown represented the Turkmenistan parties that went from state court to federal court seeking to vacate the arbitration award, and senior partner Richard ben Veniste is handpicked by George W. Bush to sit on the 9-11 Commission with that glaring but unreported conflict of interests.

February 2003: Canada Prime Minister Stephen Harper refused to send Canadian troops to Iraqi Freedom. As a NATO member, neighbor of the USA, Canada has sent troops into peace keeping missions or combat when asked to do so by the United States but declined to join in March 2003.

Direct from Canadian military sources including both soldiers and military medical doctors the reason was clear when the people were contacted and asked the right questions.

Of all the Canadian soldiers sent into Desert Storm in 1991, and came home without being injured or killed in combat, those who were forced to take the CBW vaccines mandated by the US Pentagon the statistics were both glaring and alarming. For those injured only by vaccines, most were seriously disabled, many in the range of 50% to 100% or had died between 1991 and 2003. PM Stephen Harper was not willing to make the same mistake again based on US lies and demands that have devastating long term effects on the military personnel of many nations.

March 22, 2004: U.S. Supreme Court denies Writ of Certiorari, upholding 5th Circuit. State Concern Turkmenneft v. Bidas, 03-1018 (Remember, Unocal / Delta (Saudi owned) started this blockade, aided by Clinton and Bush Administrations and Texas judges. Also, in bed with Amerada Hess [Delta / Hess] in the Caspian Sea east of Azerbaijan and Amerada Hess CEO Thomas Kean is handpicked by George W. Bush to chair the 9-11 Commission.) Note that the Mayer Brown law firm represented Turkmenistan and Turkmenneft in US District Court, Southern Division Houston and at Fifth Circuit US Court of Appeals. That law firm also shared offices in the Uzbekistan capital with ENRON, and created the SPE's that were used by ENRON in accounting fraud and its collapse, plus Senior Partner Richard ben Veniste was handpicked by George Bush to sit on the 9-11 Commission.

Spring 2004: Schwarz was informed by a DARPA PhD that the only way that Schwarz and his non-US scientists could continue forward was to subordinate to Battelle Corporation. That was declined by Schwarz and all 7 of his original non-US scientists. The Battelle matter surfaces again in Ukraine 2022 below.

2004: In 2004 it was revealed that the Pentagon's Office of Special Plans was literally The Lie Factory to create false justifications to attack Iraq in 2003 in yet again an illegal war of aggression. Iraq, WMD lies, Imminent Threat lies, Saddam – Al Qaeda lies, The Office of Special Plans at the Pentagon, aka: The Lie Factory.

September 11, 2004: Jimmy Walter puts on the NYC event "9-11: Confronting the Evidence". There were 1,286 people in attendance plus the recording company, cameramen, and people on 4 different panels. Some of the members of the Schwarz panel were retired General Robert Bowman, Star Wars program, Jenna Orkin that has done battle with the EPA for years over the asbestos issues, and deceased Kristina Borjesson, investigative reporter that focused on the shooting down of TWA Flight 800 (NY John F. Kennedy International to Charles de Gaulle Paris and continuing to Rome) on July 17, 1996.

While backstage Schwarz and Borjesson were discussing why TWA Flight 800 had any touch point on September 11, 2001. The reply from Kristina was "that the United States government kills at the drop of a hat, including Americans." Many years later the US Navy admitted they were ordered to shoot that commercial jet down, but not why.

Author of "One Way Ticket to Crawford Texas" Karl Schwarz was one of the main panelists to speak to the audience. Schwarz had prepared a PowerPoint to be presented on a big screen on the stage but the crew that recorded the event and later produced DVD's that were distributed free of charge forgot to bring the interface for a laptop and remote control to present to the audience.

Before that panel took the stage, 2 CIA people threatened to terminate Schwarz in NYC if he revealed what he knew about the WTC and asbestos issues that are presented in this document and will be in Court

before a jury, too. Schwarz was not in NYC to present that matter. He disclosed the Afghanistan, Bidas matters and the colossal amounts of oil and natural gas that the USA was intent on seizing and controlling with military force.

At the end of a 9:19 presentation, Schwarz glared at the 2 CIA people, and they went storming out of the auditorium as a standing ovation was in progress. Everyone in the auditorium saw those 2 federal agents go storming out of the building.

The panelists that did know what the confrontation was about back stage thought it curious, odd, possibly incriminating that the CIA was so concerned about WTC asbestos. The CIA agents were furious that Schwarz revealed what the real motive was in blaming Afghanistan for which that nation is completely innocent.

In addition to the previously mentioned US Army Special Forces soldier and pertaining only to the lead up to Desert Shield – Desert Storm, Schwarz was contacted by two other people that had credible information.

First, an air traffic controller that stated their job, pension, health care and even life was threatened if they talked or went public. This person drove to another state knowing their mobile and home phone were probably tapped. The call was from a friend's landline in another state.

The allegedly hijacked jets that hit WTC 1 and 2, took off and headed northeast towards Europe and away from NYC and WTC. Both of those jets disappeared from radar at almost the exact same second. Both jets were too far out over the Atlantic Ocean to be what hit WTC 1 or 2. Even if the transponders had been turned off, they should have still been visible on radar but were not.

Second, Schwarz was contacted by a former Official Photographer for WTC. He was in the offices of Emory Roth & Sons Architects in WTC 1 when armed federal agents came and confiscated all plans and specifications of the WTC complex, and that included WTC 7. This occurred years before September 11, 2001.

If a person is reading and thinking, the asbestos problems of WTC were known as of 1971 and first lawsuit 1987 on that specific matter. The 1991 lawsuit seeking \$6 billion from the insurers failed and was lost on May 17, 2001 was seeking to remediate all asbestos in WTC and the 3 regional airports. Whoever those armed federal agents were, they did not want the plans to figure out how to fix the asbestos problems. Plans and specifications are absolutely needed for a controlled demolition of buildings having complex structural designs as were WTC 1 North Tower, WTC 2 South Tower and WTC 7.

October 13, 2004: Karl Schwarz sends a Demand for Truth facsimile to President George W. Bush. There was no reply but that was expected. Bidas quietly got a message to Schwarz some of their associates in Afghanistan were missing.

Dec 1994 to August 1996: Chechnya War 1: The following statement about this war is not entirely true as Western governments try to control the narrative, how history is written as a finger pointing political and media blame game. During the Clinton Administration, the First Chechen War occurred from December 11, 1994, to August 31, 1996, between the Chechen Republic of Ichkeria and Russia, primarily over Chechnya's desire for independence following the collapse of the Soviet Union. The conflict resulted in significant casualties and destruction, with estimates of civilian deaths ranging from 20,000 to 100,000.

Simple research reveals that one of the enemy combatants against the new Russia Federation was UNA-UNSO. That is the Neo-Nazi group from Ukraine that the CIA has been in bed with since way back into World War 2 as US Army OSS, and when CIA was created in 1947 has continued to this day. In fact, the Ukraine SBU, sort of their Neo-Nazi Gestapo most responsible for the carnage in Donbas shares office in Kiev with the US Central Intelligence Agency.

When Karl Schwarz started reporting that fact, Wikipedia has now modified their website to exclude UNA-UNSO but both Chechnya and Russia Federation can verify that to be true. Many of that Ukraine Neo-Nazi group were killed in Chechnya. Another combatant group involved Doku Umarov. His name comes up again regarding Kiev Maidan below.

UNA-UNSO was headed by Dimitro Yarosh, who was a key antagonist and speaker at Kiev Maidan when that “regime change” happened. Its current name is Right Sektor, the current Neo-Nazi government in charge in Ukraine. See Kiev Maidan 2013-2014 for further details.

2006: China completes the Gwadar Port and it is inaugurated early 2007. Intermittently, the CIA has waged covert wars in Iran to block the IPI (Iran, Pakistan, India pipeline) and within Pakistan itself to block CPEC. That has included US sponsored terrorism aimed at disrupting the port, roads and rail corridors that are part of CPEC all the way from Gwadar to China.

2006: About 1 year after the December 2004 release of “One Way Ticket to Crawford Texas”, a man contacted Schwarz with important information. He was formerly the official photographer for World Trade Center. He was in the offices of Emory Roth & Sons Architects in WTC 1 when federal agents came and confiscated all plans and specifications for the WTC complex, Buildings 1 through 7. This matter happened years before September 11, 2001. Further details on this will be presented to the Court and Jury.

2006: Around 18 months after the 2004 release of “One Way Ticket to Crawford”, Schwarz received a phone call from an air traffic controller that stated they were on duty at Boston Logan International Airport. This person stated they had been threatened with job, health care, pension and even up to death if they disclosed what was on the radar screens. Further details on this will be presented to the Court and Jury.

What was stated clearly and professionally was that both Flight 11 and Flight 175 took off 16 minutes apart and headed towards Europe. Both flights disappeared from radar at almost the exact second. Even if the transponders had been turned off, both would have still been visible on radar.

Another matter that was discussed in detail was direction travel towards the Great Circle Route to Europe, which is headed away from NYC and distances each plane was NE of Boston. Unless capable of “Mach 1 speeds”, which Boeing 767 jets cannot do, neither Flight 11 nor Flight 175 could have possibly been what hit WTC 1 or WTC 2. The Plaintiffs will be presenting evidence regarding the 737 that did hit WTC 2 to the Court and Jury.

This ATC person made the phone call from another state from a friend’s landline because they knew their mobile phone and home phone were probably tapped.

March 2006: While in prison awaiting trial, Slobodan Milosevic dies after suffering a fatal heart. When the ICC finally got around to doing on the ground research in Bosnia and Serbia, many interviews, the discovery of mass graves of Christians, he was posthumously found to be innocent. Some of the Muslims and Christians informed the ICC that the US had armed Muslims to kill Christians and is how Afghan Zalmay Khalilzad earned the nickname “The Butcher of Bosnia”. Official US statements on

this matter is a former Serbian general is now referred to by that nickname as “The Butcher” to hide US complicity in genocide, without acknowledging that Milosevic was found innocent as well as those who served to defend Christians in Bosnia and Serbia.

April 21, 2006: Even after Bidas prevailed at Fifth Circuit US Court of Appeals, defendant Turkmenistan and their lawyers Mayer Brown sought a second time in US District Court SD Houston to vacate the \$495,000,000 arbitration award and were struck down by Court order in favor of Bidas. Turkmenistan and Mayer Brown lost. The PANY&NJ covered up the asbestos problems, the FBI covered up their complicity in the February 26, 1993 bombing of WTC 1 North Tower, the CIA hid their illegal activity inside the United States with Saudi GDI recruiting radical Islamists that had never flown a jet and did not on September 11, 2001.

2006: The Bush Administration and Congress collaborated on the creation of BARDA, the Biological Advanced Research & Development Agency as a biological mirror of DARPA. This law created a new position at the DHHS as Assistant Secretary for Preparedness & Response (ASPR). That has been staffed with military people since inception and the ASPR has pre-emptive military authority to take over US health care and response to a declared emergency even if fake as was the non-existent SARS CoV-2. In fact, the alleged genome the CDC blasted out all over the world is fake and will be proven in Court before a jury in a separate lawsuit.

July 2008: The Pentagon, some elements of NATO, the nation of Georgia itself and a Ukraine Neo-Nazi light armored brigade conducted war games in Georgia that ending July 31, 2008. August 7, 2008 During the night of August 7, Georgian gun boats attacked a Russian freighter on the Black Sea. The Russian navy destroyed the gunboats. People should read a map and do some research that Abkhazia is on the border of Russia Federation near Sochi. In 1992, Abkhazia voted to remain aligned with Russia, not the EU, NATO or US. Additionally, the peoples of South Ossetia voted in 1992 to remain aligned with Russia Federation. A simple read of a map reveals that just north of South Ossetia are their ethnic kin in North Ossetia Russia Federation. South Ossetia is about 25km from where the Bush Administration was trying to force through Pipeline Route B since the US already knew they were both blocked by CPEC and defeated by the Taliban in Afghanistan well before the illegal war of aggression inflicted on South Ossetia, a part of the Russia Federation by their choice.

August 8, 2008: Shortly after midnight of August 7 to 8, the nation of Georgia, the Ukraine Neo-Nazis, PMC mercenaries representing USA, and others opened fire on South Ossetia killing +2,200 people. A little more than 1 week prior to this happening, Schwarz was on a US radio show and predicted that the Bush Administration would try a Plan B Pipeline route and it might be through Georgia. Apparently, the United States had planned the July war games and left behind a lot of military equipment and ammunition for this assault on South Ossetia. Abkhazia was also assaulted but not to the extent

South Ossetia was. One of the Bush and US objectives was one of the main ports in Abkhazia that was to be 1 of 3 had the plan succeeded to route oil from the Caspian Basin region to the Black Sea and beyond.

For those readers that never knew or do not have good memories, the Bush Administration reactions were:

Condoleezza Rice as Secretary of State rather than National Security Advisor: “Russia is an outlaw.” Several members of the House and Senate acted as Mynah birds on what Rice and Bush were saying.

Bush had the audacity to state: “Nations are not supposed to attack other nations in the 21st Century.” That was even though he attacked 3, Afghanistan, Iraq and last South Ossetia. It is a known fact from multiple sources that Bush – Cheney came into office in 2001 fully intent on regime change in 7 nations over 5 years. That game plan was totally derailed by the Taliban and the Iraqi Resistance defending their nations from a liar and war criminal.

Schwarz wrote several articles about this flare up in Georgia v South Ossetia that prompted the OSCE to call him asking for more details to verify that it was not Russia that was the aggressor. After that investigation, the OSCE informed Bush and Condoleezza Rice that their lies would not be listened to and OSCE would put its own people on the ground to get at the truth. It was a devastating Russia counterstrike, not Russian aggression.

If people would do the research and pay attention, during Chechnya War 1, even Dagestan, Russia Federation was attacked, and the regime change attempt failed multiple times. Dagestan Russia is just East of the nation of Georgia and no pipeline is coming across there without the approval of Russia Federation and Dagestan. It never seems to dawn on Washington DC to change abhorrent policies or to discuss joint ventures with non-US entities.

August 1999 – April 2000: Chechnya War 2; Main phase: 7 August 1999 – 30 April 2000, (8 months and 24 days)

Insurgency phase: 1 May 2000 – 16 April 2009, (8 years, 11 months and 15 days). Note that this involved both Clinton and Bush Administrations as US sponsored terrorism while pretending to be fighting terrorism.

After Chechnya realized that it was the CIA and their proxies that were stirring up the problems, in Chechnya War 2 that region aligned with Russia Federation and they won the war. However, as revealed at Kiev Maidan 2013-2014, it was about to start again as an overall “anti-Russia agenda” by the United States.

December 30, 2009: A suicide bombing at Forward Operating Base Chapman in Khost, Afghanistan, killed seven CIA officers and one Jordanian intelligence officer. The attack was carried out by Humam Khalil al-Balawi, a double agent who had gained the trust of U.S. and Jordanian intelligence.

Jennifer Matthews deceased: She led the UBL and al Qaeda tracking unit right after 9/11 and later became the chief of base at the CIA's station in Khost, Afghanistan. She'd been one of the original Alec Station members. She was seen by her colleagues as a hard ass and as a serious and vigilant analyst and operative. A CIA report criticized her for not sharing information with the FBI before 9/11, a charge she found ridiculous and insulting; after 9/11, she became a senior liaison officer to the Brits, and then volunteered for the Khost downrange assignment, partly to expiate the guilt she felt at being blamed for the 9/11 failure. An al Qaeda double agent (a Jordanian recruited by the U.S.) entered the base without being searched and blew himself up. Matthews and eight other CIA officers were killed.

Note for the record on September 9, 2001 the most powerful warlord Ahmad Shah Massoud was assassinated by a Jordanian TV cameraman, and was also recruited by the CIA. Massoud had already warned the US that it was not welcome in Afghanistan. Also note for the record, former HASC Curt Weldon already knew Osama bin Laden was not in Afghanistan.

June 9, 2010, 11:15am: Karl Schwarz was the keynote speaker at ILA Berlin 2010 air show regarding nanotechnology applications in aerospace and outer space. He was invited by the Germany Russia Business Alliance. Lockheed violated the air show schedule to show off the Raptor F-22 fighter jet in an obvious attempt to drown out the Schwarz presentation. Announced at that air show by Schwarz was the fastest space propulsion system ever invented on Earth by humans.

Schwarz had clashes with Lockheed while trying to help DARPA and Pentagon TSWG solve difficult problems in Iraq due to total lack of planning by Bush Administration and CENTCOM. For example, the IED's that maimed and killed so many US and coalition soldiers were from Iraqi weapons depots that the US military did not seize and have control over well into Iraq Invasion 2.

March 2012: Schwarz's nanotechnology company was invited to be the anchor tenant of a new Nanotechnology City in India. After months of discussions the Malaysia Central Bank and Singapore each funded \$200,000,000 USD, \$400,000,000 total because the Schwarz project was going to help thousands of battered Hindu women and children. When those wire transfers were in route to a London branch of in India bank they were stolen by the US Department of Homeland Security and routed to a US government account at JPMorgan Chase, NYC. The rest of this matter and how it will be dealt with in Court and Jury is an attorney-client privilege matter. \$200,000,000 was to be deposited at a Schwarz account to get the India project moving ahead.

Former Deputy Director of DHS Noah Kroloff is a named defendant in the Plaintiff's lawsuit. He can explain to the Court and Jury why DHS stole \$400,000,000 on a matter that was no threat to the USA whatsoever and \$200,000,000 of that was to be directed to Schwarz when the contract negotiations were completed and executed.

2012: The Obama Administration pushed hard on the nation of Georgia to locate the Richard Lugar Lab in 2012. That is a US bioweapons lab close to Russia and located at near the capital city of Tblisi. A Bulgarian investigative reporter named Dilyana Gaytandzhieva has reported on this lab many times. She has talked to persons that were seriously harmed with drug testing on them, and has talked to relatives of persons that died at Richard B Lugar Lab due to illegal testing on humans. Those coming and going to this lab carry diplomatic passports and even drive diplomatic license plate cars to keep the bioweapons research from being touchable by the government of Georgia. Due to what is revealed at February 24, 2022, the same has been happening across much of Ukraine.

2012: William F. Browder, Hermitage Capital. The grandson of former President of US Communist Party, who was also a Communist candidate for President of the United States. Browder renounced US citizenship and now holds a UK passport. Sergey Magnitsky, Browder, Hermitage Capital, and others were caught conducting illegal activity in Russia Federation.

Due to that article, Schwarz was interviewed by the owner of Russia Hour TV, Alexander Korobko for over 2 hours on the record on May 17, 2014 in Zurich. Mr. Korobko's office is in London. That interview aired in Russia in 2 parts with subtitles in Russian. The entire interview was in English.

2012: Magnitsky Act 2012. This is a preposterous law by the Obama Administration and Congress. William F. Browder and his partner in crime Sergey Magnitsky were caught violating Russia Federation law, which the US government has no say over whatsoever. This law was used by the US and EU as “anti-Russia” and sanctioning Russians for no reason and no jurisdiction over them whatsoever. The Magnitsky Act should be abolished due to being beyond the jurisdiction of Washington DC.

2012: Smith Mundt Modernization Act 2012. This law has basically allowed the US government and media to lie to Americans with impunity without any repercussions. It should be abolished.

2013-2014: Kiev Maidan 2013-2014. The previously mentioned Dimitro Yarosh, head of UNA-UNSO, now the Neo-Nazi Right Sektor government in Ukraine, full aided and abetted by the CIA since 1947, urged his co-terrorist Doku Umarov to initiate the terrorism inside of Russia again. May 17, 2014: Russia Hour TV interviews Schwarz for over 2 hours on the record in Zurich. That was recorded by a Swiss team that were stunned at the subject matter. Discussions lasting close to 3 hours were off the record and addresses many of the matters detailed in this document.

June 30, 2014: BNP Paribas was cornered, plead guilty to the US Department of Justice and paid a fine of close to \$9 billion. Two additional fines to the Manhattan District Attorney Office and NY Financial Service brought the total fine to about \$14 billion.

The US Department of Justice has been using that \$9 billion as the 9-11 Victims Compensation fund to the family survivors. Problem is the DoJ has only paid out \$1.8 billion with conditions they sign what is the equivalent of an NDA or No Action Agreement and barred from suing the airlines or the US government. The DoJ has paid out \$2.0 billion to the attorneys that assisted in cornering their clients to sign off and this has every appearance of the DoJ and those attorneys collaborating on a continuing coverup.

The Plaintiffs intend to seek in Court the revocation of all such prior agreements as being null and void and part of the coverup of a commission of the crime of September 11, 2001. Additionally, it is illegal to classify documents to conceal the commission of a crime.

This is an excerpt from the Plaintiff’s lawsuit that is in preparation to be filed against the criminals that did September 11, 2001.

“After 9/11, Securicor, currently named G4S, not to be confused with Bush, Wirt Dexter Walker III and Mishaly Sabah fake ID Securacom, faced about 30 lawsuits from victim’s families. Another director that Condon supervised at Securicor, former Group CFO Trevor Dighton, said of the company’s liability – “I’m not worried about it (sic the litigation) one little bit. The two planes involved weren’t those that crashed into the towers – that’s the first thing.” [emphasis added]. Refer to Exhibit A and Exhibit B.”

2014-2022: The Obama Administration via the Pentagon and hidden on their budget by the NDAA installed many illegal bioweapon labs in Ukraine. Reported 14 total and other sites totaling 46 were seized by Russian airborne troops on February 24, 2022. The US Embassy in Kiev had posted 9 documents about such labs and showed the names of Pentagon and the contractor Black & Veatch. Those were immediately removed when Putin took action and the US Embassy claimed, “Russia disinformation”. When Washington DC was open for business 7 hours later, the same claim was made by Washington. The Plaintiffs have the 9 documents that used to be on the Kiev US Embassy website and more.

August 11, 2015: Sputnik article: “Nearly 4 Thousand 9/11 First Responders Have Been Diagnosed with Cancer”

Note that this article is citing information that was published by the NY Post and includes, WTC tenants, area residents and business owners. NY Post: New York Fire Department (1,100), police and other Ground Zero responders (2,134), and survivors such as downtown workers and residents (467), the New York Post reported. Note that on September 18, 2001, the Editor of the NY Post was one of the offices targeted with the anthrax attack. The NY Post also did extensive reporting on the former EPA Administrator lies about the air quality in and around the WTC site due to asbestos.

November 2016: Former EPA Administrator Christine Todd Whitman apologizes for misleading everyone about the air quality issues that have made so many people ill and dying of asbestos exposure. The article did not mention the word asbestos.

2016 to 2021: Former DEA agent Donald C. Canestraro investigated and extensive interviews with all living CIA and FBI agents that were involved in Alec Station purportedly hunting for Osama bin Laden, CIA counterterrorism and FBI counterterrorism on behalf Military Commissions.

His 774 lines, multiple page Declaration is very revealing. The Plaintiffs will be seeking some key matters under court ordered discovery including a document designated as “AE827”. There are many instances in the declaration such as “CS” for confidential source as FBI, or “HHH”, “VVV” etc. that appear to be CIA names he did not disclose but knows who they are.

September 12, 2019: Sputnik article: “‘There's No End to This’: 18 Years Later, 9/11 First Responders Still Seek Medical Support.”

Sept – October 2019: Schwarz had known for years that the United States had put an illegal FISA 705(b) warrant on him to spy constantly, but it took years to have written proof of that. Schwarz has lived in Europe working nanotechnology and financing for his company, only to be blocked at the last step by US interference and bullying that started in Hungary when George W. Bush appointed his cousin George Herbert Walker III as US Ambassador to that nation in 2004. The US ambassador bribed 2 Hungarian ministers to kill a €250,000,000 transaction. A Hungarian investigative reporter revealed that in August 2006 and the ambassador had to be rushed out of that nation because such an act is criminal and has no diplomatic immunity under Hungarian law. To date, the damages inflicted in such a manner on Schwarz and his company have topped €2,300,000,000 in interference of financing contracts.

From mid-September to October 12, 2019, someone out of the Pacific Time Zone was trying to extort Schwarz into being Witness #8 in that sham impeachment against Donald J. Trump. Schwarz was living in Prague but was in Ontario Canada on business when this occurred. All emails are saved because that

illegal FISA 705(b) will be addressed in this RICO Act lawsuit that includes VICAR and many other violations of US criminal law. The US government regularly punishes anyone speaking truth to power.

February 25, 2020: Readers should compare back to June 30, 2014 to have a better understand of the link between that date and this date. Schwarz was designated as Durable Power of Attorney for a Belgian heiress who is almost 100% disabled and unable to fight back on what BNP Paribas bank and their subsidiary BNP Paribas Fortis in Netherlands, Belgium and Luxembourg did to her father and her. Her father was the largest single depositor of Fortis Bank when BNP Paribas acquire that Belgium government-controlled bank. His estate is somewhere north of \$35 billion and all of it disappeared after he was murdered and died of poisoning by 2 BNP executives on March 27, 2016.

On July 12, 2011, he loaned \$1.3 billion to BNP Paribas when they kept failing ECB and EBA stress tests. That loan was due in full to be repaid July 11, 2016 but he was murdered March 2016. That bank has yet to pay back \$1.

On August 23, 2013, he loaned another \$2.0 billion to BNP Paribas for the same reason stated above in the preceding paragraph. That loan has never been paid back plus his deposits at BNP Paribas Fortis were disappeared and moved to the BNP Paribas ledger.

Regarding the June 30, 2014 plea of guilty and \$14 billion in fines to DoJ, Manhattan DA, NY DFS, the DoJ let BNP Paribas operate under a Self-Administered Remediation Plan to clean up their act. In his role as Durable Power of Attorney, Schwarz has amassed a considerable amount of evidence that does not relate directly to September 11, 2001 other than there are corrupt and self-serving elements in the US government.

February 24, 2022: Ukraine labs MetaBiota and Battelle Corporation. On the same day Russia Federation President Vladimir Putin launched the SMO (Special Military Operation) at Neo-Nazi Ukraine, the Ukraine Military HQ and Ukraine SBU, sharing offices with the CIA, issued an order instructing the destruction of all records showing Ukraine affiliation with MetaBiota and Battelle Corporation. Hunter Biden is, or was, the largest single shareholder of MetaBiota. Battelle is a CIA contractor and runs all illegal bioweapon labs. It was George W. Bush that handed over control of all such labs to Battelle during his administration. He also tripled the number of US labs doing risky biological research under the pretense of counterterrorism.

Russia seized a lot of evidence before safely destroying the labs. There were 310 pages of evidence submitted to the UN Security Council demanding a full and immediate investigation. Either individually or collectively, the US, UK and France have vetoed such an investigation. All three have been major antagonists and aiding and abetting Zelensky and Neo-Nazi Ukraine.

This sort of illegal activity is focusing on what PNAC recommended in the 2000 “Rebuilding America’s Defenses” and developing a “politically useful tool”.

August 27, 2022: Negotiations between Schwarz as Durable POA and BNP Paribas Group in Paris were terminated. As of this date the bank owed over \$5.75 billion on the 2011 loan and the 2013 loan. A major DC law firm has already cleared conflicts check and will handle this case for Schwarz and who he represents. However, there have been repeated instances of direct US interference at one of the Group A Plaintiff in the September 11, 2001 lawsuit to note the matter here because it continued all of February 2023 to December 2025.

Jan 2 to Dec 14, 2025: One of Schwarz’s main associates was kidnapped 5 times, forced to miss a 5:10am flight Yerevan, Frankfurt to Toronto. When route changed to get him to Prague, he was

severely beaten and robbed by US proxies. On the third encounter an employee of the US government was in his face issuing orders no one would find acceptable about handing over their assets. Even before that 2 US people paid a burka clad woman \$200 to steal his passport and Canada business visa to harass and cause yet more delays. Both were identified by local police and airport security as US government employees in the area of Abu Dhabi.

2025: During the second Trump Administration, Elon Musk and others were tasked with tracking where did the USAID send all of the money? It was disclosed that USAID sent two large amounts of \$300,000,000 and \$330,000,000 to “Afghan farmers”. The real purpose of those funds was to increase poppy fields for heroin production.

Consider the foregoing facts, especially that the CPEC by 2002-2006 had totally blocked the Bush reasons for blaming Afghanistan for a crime in USA known as September 11, 2001 that they had nothing to do with. Consider that the US should have never stayed until 2022 raising heroin and pretending to be fighting terrorism and defending America.

When the Taliban prevailed, regardless of what you believe about them as fact or US propaganda pushed at you, all of the poppy fields were destroyed, and Afghanistan via the CIA was no longer supplying the world with heroin from their nation. Shame on USA and CIA for that separate crime.

On September 11, 2001 to 2025, the US has committed many crimes to avoid justice that they will now face in Court before a Jury. There are about 2 million Plaintiffs, this case is going to go to trial regarding September 11, 2001.

There are two more major lawsuits, Senator.

First, the BNP Paribas – BNP Paribas Fortis matters where Schwarz is the Durable Power of Attorney. A major DC law firm has agreed to take on that case under RICO, VICAR and murder and has passed conflicts check. They have known Schwarz since 1991 when his office was in DC and just 1 block from their office for a reason that involved Schwarz Investment Group, LLC and Wall Street firm Smith Barney. They cannot handle the September 11, 2001 lawsuit due to a conflict of interest, so the Plaintiffs found a RICO Plaintiff attorney. There are too many coincidences from February 2020 to 2025 to rule out US interference.

Secondly, a huge group are moving against the US, Pentagon, NATO, et al for SARS CoV-2 / Covid 19 Fraud against humanity. The public should be made aware that the Covid-19 deaths in the US alone exceed the total US deaths in World War 1, World War 2, and Vietnam. Close to 400 FOI responses from all over the world have clearly stated no SARS CoV-2 virus has yet to be found.

There was a scientific paper based on 1,795 alleged Covid-19 cases and was refused publishing in the United States. Of those cases, all were allergies, common cold and regular flu, not a single SARS CoV-2 case. The EU website www.EuroMoMo.eu reported for the 2019-2020 flu season close to 187,000 deaths in all age brackets occurred. That figure is far more than the alleged SARS CoV-2 / Covid-19 killed but all of Europe was locked down.
