INTERROGATORIES SUBMITTED TO DONALD J. TRUMP,
FORMER 45th PRESIDENT OF THE UNITED STATES OF AMERICA, and
CURRENT 47th PRESIDENT OF THE UNITED STATES

In a landmark and sweeping majority decision by the United States Supreme Court in Clinton v Jones, the High Court ruled that a sitting President is not immune from civil law process for matters that occurred prior to being elected and sworn in as President of the United States. Majority: Stevens, joined by Rehnquist, O'Connor, Scalia, Kennedy, Souter, Thomas, Ginsburg; Concurrence with the majority ruling was Clinton appointee Breyer who abstained, effectively a 9-0 decision. Citations: 520 U.S. 681 (more) 117 S. Ct. 1636, 137 L. Ed. 2d 945, 1997. Whether or not you volunteer information by answering the interrogatory questions below that relate to the time you were sitting as President is entirely up to you. The Plaintiffs maintain that after January 20, 2021 the same rejection of Executive Privilege should apply except in real and legitimate national security matters and should not be an excuse to cover up criminal wrongdoing by the US government or any governmental entity or US government or private sector employee related to the destruction of World Trade Center.

Interrogatory 1: Have you ever read the 1835 book by French author Alexis de Tocqueville 'Democracy in America', and truly understood that part which states "*America is great because she is good. If America ceases to be good, America will cease to be great.*"?

Interrogatory 2: Prior to running for President in 2016 and subsequently being elected over Democrat candidate Hillary Rodham Clinton, did the Trump real estate group entertain at any time the purchase of the World Trade Center complex of buildings from the Port Authority New York & New Jersey (PANY&NJ)?

Interrogatory 3: If yes, did Trump real estate group fully evaluate the potential purchase with knowledge of the asbestos lawsuit that was filed by PANY&NJ in 1987 as PANY&NJ v Allied Corporation?

Interrogatory 4: If the Trump real estate group was conducting due diligence, including any patent or latent defects or other legacy issues for any type of environmental contaminant including asbestos about a possible purchase of the World Trade Center after the PANY&NJ lost the Allied Corporation lawsuit, but during the period 1991 forward after the PANY&NJ filed a \$6 billion lawsuit against the insurers for asbestos remediation, was the Trump real estate group aware of and fully informed of the asbestos issues in the World Trade Center?

Interrogatory 5: If Trump real estate group was not aware of the asbestos issues and the 2 prior lawsuits, was that matter discovered during due diligence or by other means? If by other means, please elaborate specifically on this matter since there was also a 1995 lawsuit filed by the PANY&NJ in US

District Court SDNY rather than the 2 New Jersey lawsuits in New Jersey Superior Court Law Division and US District Court NJ.

Interrogatory 6: Is it true that at some point in the PANY&NJ chronology that entity was attaching to office space leases an asbestos addendum that was in effect a full indemnification, waiver and hold harmless provisions for tenants that wanted to be in the WTC and were willing to take that risk?

Interrogatory 7: Depending on the dates that Trump real estate group had discussions about the purchase of World Trade Center properties in Manhattan, did the PANY&NJ and Trans-Hudson Corporation acknowledge to you that there was an asbestos lawsuit in progress in Newark NJ seeking approximately \$6 billion USD to fix the asbestos problem via normal and customary methods of asbestos remedial mitigation?

Interrogatory 8: If yes on Interrogatory 7, did the PANY&NJ demand a Non-Disclosure Agreement to even discuss the matter with you or evaluate a possible purchase of the WTC buildings due to the asbestos lawsuits?

Interrogatory 9: During 1984 to 1986, the Statue of Liberty was closed for repairs. One of the problems was galvanic corrosion where the exterior copper was in contact with the iron structure that made the statue even possible to build; i.e. the statue has a skeleton. Many French and American scientists, engineers, metallurgical experts, government agencies were involved from 1980 forward to evaluate how to do a restoration effort and repairs of a major landmark.

The PANY&NJ filed a third lawsuit in US District Court SDNY during the Clinton Administration that named additional parties including Tishman Construction and even the supplier of the special aluminum elements on the exterior walls of both WTC 1 and WTC 2. In 1995, the US District Court SDNY ruled against the plaintiffs PANY&NJ v Allied Corp, et al again more along the lines of "construction defects". Decision Date: 29 March 1995; Docket Number No. 91 Civ. 0310.,91 Civ. 0310; Citation 914 F. Supp. 960, Parties: PORT AUTHORITY OF NEW YORK AND NEW JERSEY, et ano., Plaintiffs, v. ALLIED CORPORATION, et al., Defendants. Court: U.S. District Court - Southern District of New York.

It is a known fact that the original design specifications of the Twin Towers were to have been stainless steel rather than aluminum as the vertical elements between the windows. Galvanic corrosion is what happens when dissimilar metals are in contact with each other and causes damage over time.

In addition to asbestos problems, did the WTC Twin Towers have galvanic corrosion problems similar to why the Statue of Liberty had to be closed and fix its interior skeleton and structure plus the damage that had caused to the exterior copper that is the Statue of Liberty?

Interrogatory 10: Have you been aware at any time that one of the unique design features of the WTC Twin Towers was that the 4 exterior walls did not have any horizontal beams or structural steel columns that transferred the dead loads and live loads to footings and bedrock below on the perimeter of the Twin Towers?

Interrogatory 11: Were you aware that the exterior walls were vertical rectangular steel tubes between the windows, horizontal steel plates that only carried one end of the bar joist loads for each floor load. However, that entire load was suspended from the top as if by steel cables (rectangular tubes the entire height of WTC towers) and transferred back to what was a massive superstructure core of both Twin Towers?

Interrogatory 12: Have you been aware at any time that the WTC 1 and 2 structural steel was ASTM 36 ksi up to ASTM 100 ksi as part of the innovative structural design?

Interrogatory 13: Have you been aware at any time that the superstructure core of the WTC Twin Towers was of such dimensions, thicknesses, strength and special design features to further increase strength and load carrying capacity that an ordinary controlled demolition was absolutely not feasible?

Interrogatory 14: Have you been aware at any time that the structural engineers of the Twin Towers had already done an analysis of whether or not the Twin Towers could withstand the impact of a Boeing 707 commercial jet?

Interrogatory 15: Have you been aware at any time that the structural analysis concluded that even with impact damage and fire, neither of the Twin Towers would have collapsed due to such an impact and fires after such an event?

Interrogatory 16: The Architects and Engineers for 9-11 Truth have done an excellent job of analyzing the various NIST (National Institute of Standards and Technology) reports and have found glaring errors, obvious mistakes to the level of incompetence or intentional, and false conclusions that are highly suggestive of a systematic coverup about why the Twin Towers collapsed in controlled demolition fashion. The University of Alaska engineering department also conducted a similar analysis and came to the same conclusions.

If the issue is the US government in massive coverup mode versus competent architects and engineers who have studied the collapse of the Twin Towers in detail, would you believe the professionals or the US government people hiding the truth about what really happened and more importantly why it happened?

Interrogatory 17: Due to the findings of what is stated in interrogatory 16 above, AE911Truth stayed focused on every possible detail to establish the fact that WTC 1, WTC 2 and WTC 7 were all controlled demolitions as other investigators focused on prior to and following that day as to why, how and who did it.

Do have any personal knowledge that no “radical Islamic terrorists” were involved and the real criminals were rogue elements of the US government and certain agencies and people within those groups and wealthy elite insiders pushing a DC political agenda?

Interrogatory 18: If you were and are sufficiently aware that the central steel superstructure of the Twin Towers was by necessity a far stronger and a much more massive structural design in the interior core, are you of the opinion that no “pancake collapse” or standard controlled demolition could have possibly brought both towers down into their footprint as happened on September 11, 2001 without special measures taken to weaken or dismember those colossal columns that were handling all live and dead loads in WTC 1 and WTC 2?

Interrogatory 19: Many eyewitnesses saw molten steel metal flowing out of one of the Twin Towers. Are you knowledgeable enough in high rise steel construction to know that no fire in any high rise in the world has ever reached temperatures that would turn structural steel elements to molten state or have caused a global collapse of any building, anywhere, except the 3 that collapsed at World Trade Center on the same day September 11, 2001?

Interrogatory 20: The only known method that can take structural steel back to molten state is known as “thermitic reaction”. There is a fast and volatile method that cannot be controlled and would be

totally ineffective and unsuitable in a “controlled demolition”. However, a Germany company that has been involved in thermitic reactions for over 120 years did develop a slow, methodical and destructive way to do thermitic reactions. What is suggested here is like turning on an electric range element but rather than reach 400 degrees slowly, some thermitic reactions can now slowly reach 3,000 to 4,000 F and would melt or evaporate part of the steel structural members.

Are you familiar with the process known as thermitic reaction that can produce extremely high heat levels that far exceed the level of any building fire temperatures?

Interrogatory 21: Have you been aware at any time that the purported WTC Security company was directly involved with a US government lab from 1994 forward on thermitic reaction research and that was not long after the FBI assisted February 26, 1993 bombing of WTC 1 North Tower that did no damage whatsoever to the WTC core superstructure?

Interrogatory 22: The slow method of thermitic reaction is a plate that can be attached to a column or beam and once ignited can reach temperature levels that not only weaken steel, turn it into molten state but can also literally evaporate steel due to extremely high temperature. There was evidence in the rubble pile not only of molten steel of WTC 1, 2 and 7, but some of the structural members also showed that some were partially evaporated and seriously degraded on structural load bearing capacity.

Are you personally aware that such a method was used to bring down the WTC towers to first weaken and degrade and then a typical controlled demolition bomb sequence could finish off the WTC Twin Towers and WTC 7?

Interrogatory 23: On September 11, 2001, you reportedly stated that WTC 7 was a controlled demolition. On what basis did you make that observation and comment?

Interrogatory 24: Was your statement about controlled demolition because of what you saw as to how the building collapsed?

Interrogatory 25: Was your statement about controlled demolition because you had foreknowledge the WTC was going to be destroyed because every lawsuit the PANY&NJ filed had been lost and George W Bush wanted to blame it all on Afghanistan because there were trillions of dollars in oil and trillions of dollars of natural gas that needed a pipeline that Bush intended to steal with military force that a non-US energy company had accomplished? If yes, do you know the name of that non-US energy company?

Interrogatory 26: Thermitic reaction panels are not explosive bombs but can cripple a major structure so bombs will work and then keep burning into the steel even after a building has collapsed.

Have you been aware at any time that pools of molten metal that had cooled and re-solidified were found in the WTC 1 and WTC 2 rubble piles and are clear evidence that thermitic reaction was used to destroy the World Trade Center 1 and 2 towers?

Interrogatory 27: Did you know in advance of September 11, 2001 that WTC 7 was to be completely demolished due to asbestos problems that were too expensive to fix?

Interrogatory 28: Were you aware at any time that WTC 7 was intentionally overdesigned to withstand virtually any type of disaster, which is why the NYC Office of Emergency Management and some crucial US government agencies were located in that building?

Interrogatory 29: Were you aware at any time that molten metal was also found in the WTC 7 rubble pile and indicative that thermitic reaction temperatures were also used to bring that 47-story tower down?

Interrogatory 30: Have you been aware at any time that the only 10 floors in the WTC towers that had been renovated to solve the asbestos problems were in the North Tower offices of Marsh McLennan 93rd-100th floors and Cantor Fitzgerald and subsidiary eSpeed 101st-105th and part of the 102nd Floor had offices of Alliance Consulting Group, The Nishi-Nippon Bank Limited, PaineWebber, Kidder Peabody & Co., and one of the Marsh McLennan floors was partially occupied by what is now Sumitomo Mitsui Bank of Japan?

Interrogatory 31: The Plaintiffs are confident you know that Howard Lutnick, former CEO of Cantor Fitzgerald, Secretary of Commerce in your current administration was the only survivor of that firm.

Do you have any personal knowledge that on September 12, 2001 a \$120 billion bond issue was coming due that was a Brady Bonds and fake gold certificates structure done in the George H W Bush Administration of 10 Year Term and September 11, 2001 suddenly aborted the payment on that matter?

Interrogatory 32: Have you been aware at any time that in addition to Howard Lutnick being the sole survivor of Cantor Fitzgerald, Paul Bremmer was the sole survivor of the NYC office of Marsh McLennan and he was the first to be on a US television network that morning pointing the finger of blame at Osama bin Laden and Afghanistan?

Interrogatory 33: Have you been aware at any time that well before September 11, 2001, federal agents confiscated all plans and specifications of the entire complex at the World Trade Center 1 offices of Emory Roth & Sons, Architects?

Interrogatory 34: If you hired a demolition company to implement a controlled demolition of a high-rise property so you could build a new building, would you agree that having the plans and specifications are essential to carry out that controlled demolition?

Interrogatory 35: Since the record is crystal clear, the US government agents did not want those plans to figure out a way to fix the PANY&NJ asbestos problems.

The Plaintiffs are wondering how extensive of a disclosure of “show and tell” do you and Rep Anna Paulina Luna plan on revealing, since the evidence in this lawsuit points at the US government as to who committed the crime of September 11, 2001?

Interrogatory 36: Do you know the exact date or the month and year when Larry Silverstein purchased the World Trade Center 7, or did he really purchase it at a market value amount?

Interrogatory 37: Have you been aware at any time that on August 26, 2022 a New Jersey man named Malcolm Howard, age 79 at the time, terminally ill, now deceased, made what was close to a “death bed confession” that he and 3 other CIA agents covertly wired WTC 7 from May 1997 to September 2001 for controlled demolition in what the CIA designated as operation “New Century” as the code name?

Interrogatory 38: Are you familiar with the Neocons that issued the PNAC manifestos issued in 1997 and again in 2000 by the “Project for a New American Century” as to how the CIA might have

thought “New Century” would give them plausible deniability if anything leaked out about their “covert mission” regarding the World Trade Center 7?

Interrogatory 39: Is it true that the CIA field offices in NYC were in WTC 7 leading up to September 11, 2001 as well as the SEC and other government agencies plus the NYC Office of Emergency Management?

Interrogatory 40: Did you know in advance of September 11, 2001 that a decision had been made by the US government and PANY&NJ to destroy the World Trade Center due to the costs required to completely remove the asbestos and replace with more modern fireproofing materials were prohibitive, plus the PANY&NJ kept losing every lawsuit trying to find a solution and a bailout to their inherent latent defect problem?

Interrogatory 41: If Trump real estate group was entertaining an acquisition of WTC 7, in what year and months did those due diligence activities start and finish?

Interrogatory 42: If the Trump real estate group did consider and evaluate a purchase of the World Trade Center buildings 1, 2, 3, 4 5 and 6 and the hotel, did those due diligence efforts include an EIS and asbestos remediation plan, which are required by law for clear title, financing and insurance?

Interrogatory 43: If yes, when did those evaluation efforts commence and end on any of the WTC buildings 1 through 6, and 7, if involved?

Interrogatory 44: If yes, on the possible acquisition of any of the cited properties, when by month and year were you aware of the asbestos problems in World Trade Center 7 and the other World Trade Center buildings and any form or patent or latent defects?

Interrogatory 45: There was a concerted effort during the Bush Administration to coverup or conceal the facts that Marvin P. Bush, relative Wirt Dexter Walker III, and Mishaly S. Sabah of KuwAm Corporation were directly involved in World Trade Center security via Securacom, later Stratesec after IPO and ordered to cease and desist using the name Securacom in a trademark violation case in US District Court Newark NJ. Marvin Bush was also sitting on the board of directors of Houston Casualty Company until 2000, one of many WTC insurers involved as defendants in the PANY&NJ, Trans-Hudson Corporation v Affiliated FM Insurance, et al, 1987 in New Jersey Superior Court, Law Division, and 1991 to the May 17, 2001 final order in the United States District Court Newark NJ.

What month and year did you learn about this New Jersey lawsuit that PANY&NJ filed in 1991 and was lost on May 17, 2001 that was seeking \$6 billion to fix the asbestos problems at the WTC and the 3 major NY area airports?

Interrogatory 46: Do you know if Lucky Larry Silverstein would have received asbestos relief had PANY&NJ won the asbestos lawsuit, or was Lucky Larry stuck with an asbestos plagued building because he was in control of WTC 7 before the 1991 lawsuit was filed in US District Court, Newark NJ?

Interrogatory 47: Houston Casualty Company issued a public statement following September 11, 2001 that the company took a \$30 million write off loss after September 11, 2001, but apparently no other insurer of the Affiliated FM Insurance, et al consortium has been found that issued such a statement.

Had the insurance policies already been revoked or lapsed due to nonpayment? There were rumors that the insurance consortium increased the premiums by around 300% after the May 17, 2001 final order

effectively condemning the WTC, and possibly those were never paid, since someone had already dreamed up the “Lucky Larry Silverstein” approach to solving the asbestos problems?

Interrogatory 48: Have you been aware at any time that the 99-Year Lease the PANY&NJ did with Larry Silverstein and Australian Frank Lowy was an end around way to get approximately \$4.5 billion due to an “alleged double terrorist attack” as an “insider strawman deal” or a “nesting doll arrangement structure” to rebuild the WTC rather than the same approximate \$4.5 billion amount was needed to do asbestos remediation on the WTC complex without destroying the buildings intentionally and completely?

Interrogatory 49: Do you have any personal knowledge that the February 26, 1993 bombing of WTC 1 North Tower was a failed attempt to collect on the insurance and was well after the lawsuit mentioned in interrogatory 45 and 50 was filed in 1991?

Interrogatory 50: On what approximate or exact date did you know about the May 17, 2001 decision and court order regarding the WTC buildings and that the PANY&NJ lost in US District Court and the decision was later upheld by Third District, US Court of Appeals on November 14, 2002? Specifically: PORT AUTHORITY OF NY AND NJ and Port Authority Trans-Hudson Corporation Plaintiffs v. AFFILIATED FM INS. CO., et al, Defendants, No. CIV.A. 91-2907(JWB). 245 F.Supp.2d 563 (2001); *United States District Court, D. New Jersey. May 17, 2001.*

Interrogatory 51: On May 17, 2001, the US District Court, Newark New Jersey entered its final order that the insurers were not liable to the Port Authority of New York & New Jersey for removal and remediation of asbestos primarily in the World Trade Center buildings and to a lesser extent the three airports in NY and NJ.

In your opinion as a real estate developer and owner, did that final order effectively condemn the WTC complex of buildings?

Interrogatory 52: Have you been aware at any time that PANY&NJ used in-house attorneys for the 1991 lawsuit and the appeal to Third Circuit US Court of Appeals that was also lost November 14, 2002?

Interrogatory 53: The PANY&NJ headquarters were in WTC 1 North Tower. Do you have any personal knowledge as to why the 1987 and 1991 lawsuits were both filed in Newark NJ rather than US District Court, SDNY?

Interrogatory 54: Do you have any personal knowledge that the PANY&NJ filed both of the lawsuits in New Jersey in an attempt to keep the asbestos matters withheld from public scrutiny or public knowledge of that problem?

Interrogatory 55: At what exact time prior to May 17, 2001 did you know that the WTC facilities were approximately 50% occupied due to the asbestos problems and contamination and those environmental facts were before courts starting 1987 New Jersey Superior Court as PANY&NJ v Allied Corp. and a separate case was filed 1991 to US District Court, Newark NJ as PANY&NJ, Trans-Hudson Corp v Affiliated FM Insurance, et al?

Interrogatory 56: Do you have any reason to believe or know that US House Representative Jerrold Nadler (D-NY) should possibly be charged with Misprision of Felony since WTC was in his district as of September 11, 2001 and he has concealed facts that occupancy of WTC had significantly declined as well as his political donor base to solicit for political donations due to the asbestos issues?

Interrogatory 57: There was a major scandal following September 11, 2001 regarding former EPA Administrator Christine Todd Whitman and her multiple assurances and statements about the air quality and surface contamination around the WTC rubble pile and beyond due to the dust clouds with considerable asbestos content covered a much wider area than Ground Zero.

Do you remember the NY Post articles on the matter that were oddly not being covered by other newspapers or TV networks to any significant extent?

Interrogatory 58: Have you been aware at any time since September 11, 2001 that former EPA Administrator Christine Todd Whitman was knowingly lying to the public about “air quality issues” at the WTC rubble pile and the wider area the dust clouds affected?

Interrogatory 59: Do you have any personal knowledge and facts that Christine Todd Whitman knew about the PANY&NJ asbestos problems before she was appointed as Administrator of EPA by George W. Bush?

Interrogatory 60: The Administrator of the EPA Christine Todd Whitman issued a series of statements and press releases as follows in chronological order and some are also from the September 14, 2003 NY Post article and even later in 2016 by British media on this asbestos issue: “FROM THEIR MOUTHS: Sept. 13, 2001: The EPA puts out a press release saying, *“Short-term, low-level exposure [sic to asbestos] of the type that might have been produced by the collapse of the World Trade Center buildings is unlikely to cause significant health effects.”*

Did you see any or all of these 3 articles mentioned in these interrogatories?

Interrogatory 61: Did you know that statement was untrue at the time Christine Whitman made it?

Interrogatory 62: Are you aware of any tests that had been performed by any city, state or federal authority to prove that statement was true?

Interrogatory 63: “Sept. 18, 2001: Whitman announces, *“I am glad to reassure the people of New York ... that the air is safe to breathe.”*

Were you aware at any time prior to September 11, 2001 that the Bush-Cheney Administration had a hidden agenda to make that day happen on purpose as the “Pearl Harbor” excuse to blame it on Afghanistan and Osama bin Laden and that those plans, and schemes originated in the George H W Bush Administration and were put into motion during the Clinton Administration?

Interrogatory 64: Have you been aware at any time since September 11, 2001 that Osama bin Laden was never on the FBI Top 10 Most Wanted list for the crime that was committed on that day?

Interrogatory 65: “October 2001: *Whitman says that considering Ground Zero a major environmental health hazard to area residents and employees would be “inaccurate.”*”

Did you know for certain that such a statement by Christine Todd Whitman was false and an outright political lie in the Bush Administration coverup mode style?

Interrogatory 66: By May 2002, the EPA was quietly cleaning residential units near where WTC once stood but not cleaning businesses, shops, restaurants and offices in the area. By September 14, 2003 it was reported by the NY Post that matters were approaching adversarial level and the Inspector General

got involved. Upon conducting an evaluation, the Inspector General reached the conclusion it was the Bush Administration that was to blame for the misleading information.

Were you aware from well before September 11, 2001 to September 2003 that there was a concerted effort by the US Government, NYC and PANY&NJ to still not admit the asbestos issues related to the destruction of the World Trade Center?

Interrogatory 67: *“May 2002: Under pressure, the EPA begins cleaning contaminated apartments, but not businesses, in lower Manhattan up to Canal Street.”*

It is apparent that the WTC asbestos issues were known, long before September 11, 2001. Why were businesses not included in the environmental clean-up since it was known by around 1982-1986 that asbestos is a deadly carcinogen and the PANY&NJ and Trans-Hudson Corporation lawsuit started in New Jersey Superior Court in 1987 and then filed in US District Court Newark NJ in 1991?

Interrogatory 68: How would you state your opinion or comment for the record about this total aversion to the truth that asbestos was a major problem, and no one wants to face it, talk about it or admit it?

Interrogatory 69: Do you have any knowledge as to who or whom made the decision to clean only contaminated apartments up to Canal Street and not businesses in the area immediately around WTC?

Interrogatory 70: Were any tests done to verify that the homes and businesses north of Canal Street were not contaminated with asbestos? If yes, do you know who performed those tests?

Interrogatory 71: *“December 2002: EPA puts out press release saying, “people who returned to the area around Ground Zero after Sept. 17 were “unlikely to suffer short-term or adverse health effects” from contaminated air.”*

Since the asbestos issues were well known in Courts in 1987 and 1991, do these repeated statements by EPA Administrator Christine Todd Whitman sound like an intentional coverup to you?

Interrogatory 72: Do you remember this specific NY Post article on September 14, 2003 that created outrage with the NY Firefighters? ‘9/11 AIR OUTRAGE: WHITMAN: PIT CREWS BLEW OFF HEALTH WARNING’, By Susan Edelman, September 14, 2003’.

Interrogatory 73: Do you have any personal knowledge either as private citizen or as President that the crime of September 11, 2001 was committed by certain rogue elements of the US government against the citizens of the United States and 372 citizens of 61 other nations? In short, they were murdered by the US government as part of a sweeping and Draconian political agenda that was put into motion years before September 11, 2001?

Interrogatory 74: Do you have any knowledge that Bush appointed Christine Todd Whitman as EPA Administrator because he knew that she was already aware of the asbestos problems and the New Jersey lawsuits while sitting as 50th Governor of New Jersey?

Interrogatory 75: *“Aug. 21, 2003: EPA inspector general Nikki Tinsley releases a report saying the White House pressured the EPA to tell New Yorkers the air was safe before adequate testing had been performed.”*

If the EPA Inspector General Nikki Tinsley was being truthful and in fact the White House and others in the Bush Administration were pressuring Christine Todd Whitman to lie about air quality and the fact that the Ground Zero site and surrounding area were inundated with asbestos contaminated dust, do those facts confirm any knowledge you have that an elaborate coverup was already planned well before September 11, 2001 and implemented that day?

Interrogatory 76: *“Aug. 31, 2003: Whitman says, “There’s no way in hell” she would play games with information related to air quality.”*

Did you know at the time of that statement by the Administrator of EPA was not being truthful, since it was the White House and the Bush-Cheney Administration in general that were lying to cover up why WTC was destroyed and why the Administration attacked 2 nations in 2001 and 2003 that had nothing to do with September 11, 2001?

Interrogatory 77: Even US Representative Jerrold Nadler responded to the September 14, 2003 NY Post article: *“You could end with the EPA killing more people than the terrorists,” added Rep. Jerrold Nadler, a Democrat whose district includes Ground Zero.*

Do you have any personal knowledge that Rep. Jerrold Nadler knew about the WTC asbestos problems well before September 11, 2001?

Interrogatory 78: Do you have any facts and knowledge that US Representative Jerrold Nadler’s comment in the September 14, 2003 NY Post article about EPA killing more people than the alleged terrorists have in fact come true?

Interrogatory 79: Do you have any facts or personal knowledge that US Representative Jerrold Nadler was one of many Democrats that aided and abetted the Bush-Cheney Administration in covering up what really happened on September 11, 2001 including passage of laws that have harmed freedom, liberty, and installed laws, programs and new US government agencies that weaponized and insulate the US government from accountability?

Interrogatory 80: From the same September 14, 2003 NY Post article by Susan Edelman: *“Whitman said that within “days,” the agency provided 30,000 respirators, a claim called “totally false” by the firefighters union.”*

Are you aware of any 30,000 respirators EPA claims to have provided and apparently did not do so according to the firefighters’ union?

Interrogatory 81: If 30,000 respirators were to have been provided but someone failed to get that done, or someone blocked them from being sent, does that suggest to you as more proof that the Bush Cheney Administration did not care about the “modern atrocity propaganda” they unleashed because it was all part of the plan to attack Afghanistan to take over a pipeline ROW that the Clinton Administration, Unocal and Saudi owned Delta Oil had spent years trying to block and even years in US Courts trying to keep the asbestos matter from becoming public knowledge?

Interrogatory 82: Do you think that the Bush White House or their appointees thought that if workmen were forced to wear respirators at the rubble pile it might cause people to inquire as to what was so dangerous at WTC and it was clearly the asbestos matters that were dangerous?

Interrogatory 83: Do you know if the real First Responders, the FEMA team that was in New York City for a ‘terrorist attack drill’ had respirators, since it was supposedly only just a drill?

Interrogatory 84: If you knew about the asbestos, did the workers you hired wear respirators?

Interrogatory 85: If the response to interrogatory 84 is no, why not, since it was a “terrorist attack drill” and terrorist “evil doers” were spreading an asbestos “dirty bomb” all over Lower Manhattan, because the drill was all part of the Bush Administration coverup and intentional obfuscations to avoid being discovered as the real terrorists and the real criminals?

Interrogatory 86: Do you now believe that everything EPA Administrator Christine Todd Whitman uttered for 2 years following September 11, 2001 were premeditated US government lies because the Bush-Cheney Administration were in cover up mode about what they did and why they did the crime?

Interrogatory 87: Does the fact that PANY&NJ lost a \$6 billion lawsuit on May 17, 2001 specifically to fix the asbestos problems and why the WTC was destroyed on September 11, 2001 exposes that everything the Bush Administration and many other people did was based on lies and an evil political agenda based on the greed of an elite few insiders?

Interrogatory 88: The Guardian newspaper, UK, Joanna Walters in New York, Saturday 10 September 2016 11.30 BST: *“EPA head admits she was wrong to tell New Yorkers post-9/11 air was safe.”*

Since there is no statute of limitation on certain crimes including treason or murder, why do you think anyone with the Bush Administration would wait 15 years to admit the mistakes and untruthful statements about asbestos contamination made in 2001-2003?

Interrogatory 89: Cited from The Guardian article: *“Christine Todd Whitman, who reassured the public over Ground Zero air, says: ‘I’m very sorry that people are sick,’ she said. ‘I’m very sorry that people are dying and if the EPA and I in any way contributed to that, I’m sorry. We did the very best we could at the time with the knowledge we had.’”*

In the absence of air sample testing and surface contamination for asbestos and potentially other toxic substances, what exactly do you think Christine Todd Whitman was referring to in the last sentence above in ‘The Guardian’ article regarding “with the knowledge we had”, since everything about September 11, 2001 was intentionally suppressed by the Bush Cheney Administration in coverup mode?

Interrogatory 90: Is it true that the Bush-Cheney agenda was to make sure no one had enough knowledge and facts to solve the crime of September 11, 2001 and the lies were to justify invasion of Afghanistan in 2001 and Iraq in March 2003 as step one and two of a plan to crush and regime change 7 nations in 5 years?

Interrogatory 91: Do you think “knowledge we had” being the asbestos lawsuit the PANY&NJ and Trans-Hudson Corporation lost on May 17, 2001 is sufficient knowledge and adequate forewarning as to where the high concentration of asbestos came from due to September 11, 2001?

Interrogatory 92: It was no secret that you hired workers to help with the cleanup of the WTC Ground Zero and even appeared in person at Ground Zero. Were those people you hired wearing respirators or advised to wear respirators to protect them from asbestos?

Interrogatory 93: Did anyone with your real estate operations ever inquire about the health of those workers at any time since September 11, 2001 and later when the cleanup was completed?

Interrogatory 94: If the answer to interrogatory 93 is yes, did you step in quietly to help those you hired and were seriously harmed by the asbestos exposure?

Interrogatory 95: Do you understand the criminal law concepts of what constitutes gross negligence causing harm or death, misprision of felony, misprision of treason, treason, war crimes inflicted by Americans on the citizens of the United States and other nations on US territory, and crimes against humanity, and abuse of rights under color of law?

Interrogatory 96: Also stated in 'The Guardian' article September 10, 2016: *"She has always maintained that as head of the EPA she was simply passing on what government scientists were telling her, warning those working at Ground Zero itself to wear respirators but dismissing concerns over the surrounding area, which was engulfed in dust and ash."*

Have you been aware at any time that the US government scientists were making statements from the safety of their offices in the absence of actual and potentially dangerous field work to secure samples and laboratory testing in and around the WTC ruins?

Interrogatory 97: Another part of September 10, 2016 The Guardian article. *"On Friday, Whitman questioned the level of proof that the air made people sick, but said: "If this is a direct relation, we all screwed up." She thought she was right at the time, she said, but added: "I can believe that the scientists may not have had all the information they needed."*

Can you understand how people view this issue as being the asbestos lawsuit was a known matter and US government actions spread that out all over Lower Manhattan, lied about it, apparently no testing was done, intentionally delayed or was kept top secret, never admitted that the lawsuit seeking \$6 billion to remove the asbestos was lost on May 17, 2001, and is a despicable act by the US Government and gross criminal negligence for what was not even investigated that inflicted deaths that day on many victims, US and foreign, and left a continuing legacy of more harm and deaths?

Interrogatory 98: Do you think the existence of the \$6 billion asbestos lawsuit that PANY&NJ and Trans-Hudson lost on May 17, 2001 and the specific issue was asbestos mitigation and removal was sufficient basis to have acted prudently, safely and wisely after September 11, 2001 or was that irrelevant compared to the Bush-Cheney war and theft of oil, natural gas and pipeline agenda?

Interrogatory 99: With reference to interrogatories 97 and 98, do you think asbestos is carcinogenic enough to recognize and accept that is why people are sick, dying or already dead due to September 11, 2001 and the only terrorists that killed them was Bush-Cheney, et al?

Interrogatory 100: As a concerned citizen and now as President of the United States, does it concern you that the death toll from September 11, 2001 is now much higher than who died on that day in New York City and the death toll is and will continue to increase until some point in the future?

Interrogatory 101: In 2016, Christine Todd Whitman apologized for misleading people and acknowledged the harm that caused, but still did not admit the asbestos problem that was intentionally spewed out all over Lower Manhattan and potentially and needlessly exposing hundreds of thousands to millions to asbestos.

Do you have any personal knowledge or facts that Christine Todd Whitman was appointed Administrator of EPA, already knew about the asbestos lawsuits, as part of a much bigger coverup as to the real reasons as to why George W. Bush blamed it on Afghanistan?

Interrogatory 102: Immediately after September 11, 2001, you hired additional workers to help with the clean up and did so at your own expense. Who did you hire and how many workers were involved at the WTC rubble pile that you hired? The Plaintiffs would like to talk to them about their outcomes post-9-11 and the cleanup of the WTC rubble pile.

Interrogatory 103: Have you or anyone in Trump real estate group kept in touch with those workers to see if they are also battling asbestos induced cancer due to clean up work at the WTC rubble pile?

Interrogatory 104: If yes, how many of those workers are battling cancer the last time you inquired and how many have already died of asbestos induced cancer?

Interrogatory 105: Former Goldman Sachs executive Lewis M. Eisenberg, New Jersey, was appointed by Christine Todd Whitman to the PANY&NJ as Commissioner in 1994 and was elected PANY&NJ Chairman in 1995. It was Eisenberg that approved and signed the 99-Year Lease with Larry Silverstein and Frank Lowy.

Are you aware of any personal relationship between Defendant Eisenberg and Defendants Larry Silverstein and/or Frank Lowy?

Interrogatory 106: Do you have any personal knowledge that Defendant Lewis M. Eisenberg and the other PANY&NJ Commission members knew about the asbestos lawsuit years before the events of September 11, 2001 and never publicly revealed that problem?

Interrogatory 107: Have you been aware at any time that the Secret Service helped arrange a meeting the morning of September 11, 2001 with Larry Silverstein and bomb experts from Fort Monmouth AMC military base in New Jersey?

Interrogatory 108: What business is it for the Secret Service to arrange an 8am meeting on September 11, 2001 with Larry Silverstein about "terrorist bomb attack" on WTC 7 and the meeting was cancelled from the Silverstein side?

Interrogatory 109: Have you been aware at any time that the stated purpose of that meeting was to discuss ways to prevent a "terrorist bombing attack" of World Trade Center 7?

Interrogatory 110: Are you aware that there is a video that has surfaced that emphatically proves WTC 7 was a controlled demolition and Richard Gage of AE911Truth has featured it in a lengthy video as to why all three, WTC 1, WTC 2 and WTC 7 were controlled demolitions? A NYC employee was making sure WTC 7 had been completely evacuated and while on an upper level floor they started blowing the elevator shafts and he had to walk down many floors due to no elevators.

Interrogatory 111: Do you know why in a controlled demolition they take out the elevator shafts first?

Interrogatory 112: You are an experienced real estate developer as a given. Do you know of any demolition company that could enter WTC 7 after WTC 1 and 2 were hit, and have it completely wired, sequence tested, set explosives to bring down WTC 7 at approximately 5:20pm on September 11, 2001?

Interrogatory 113: Do you think it is hypocritical, deceitful and callous to schedule a meeting the morning of September 11, 2001 to discuss preventing a terrorist bombing attack on WTC 7 when the entire building was already wired, and explosives set to destroy WTC 7 at approximately 5:20pm the same day?

Interrogatory 114: Are you aware that the Secret Service and the Fort Monmouth AMC bomb experts stayed onsite for 3 additional days searching for unexploded bombs in the WTC 1 and WTC 2 rubble pile? That was immediately in advance of George W. Bush appearing at the site and blaming Afghanistan for the crime.

Interrogatory 115: Do you personally think that September 11, 2001 and events after that were an intentional made for TV horror show to conceal the truth?

Interrogatory 116: The Plaintiffs trust that you are aware that BBC's Jane Stanley announced the collapse of WTC approximately 20 minutes before it really happened, and the building was still standing in the background on live TV.

Did the BBC screw up the timing of the made for TV script or did the real criminals screw up?

Interrogatory 117: Do you know how the phrase "modern atrocity propaganda" was first used and how that came about due to the George H W Bush Administration and Desert Shield 1990 and Desert Storm 1991?

Interrogatory 118: Would it surprise you that the same family that has fingerprints on "modern atrocity propaganda" and Desert Shield – Desert Storm, has fingerprints on the destruction of the World Trade Center and they are Kuwaiti, not Saudi?

Interrogatory 119: Many of the NYPD and NYFD reported and have publicly stated that multiple bombs went off in the Twin Towers before they collapsed. Are you aware that there is video evidence taken at less than 1,000 feet distance that no hijacked Boeing 767 from Boston Logan International Airport hit WTC 2?

Interrogatory 120: Are you aware that NYFD firefighters took elevators up to the 40th Floor of WTC 2 South Tower and walked up the 78th Floor where the second jet hit the south face of WTC 2?

Interrogatory 121: Are you aware that there is an audio recording when the lead firefighter radioed in to the precinct that they had reached the 78th floor, there were two small fires and that they could control them?

Interrogatory 122: Are you aware that 1 minute later, with only 2 small containable fires in the entire building, WTC 2 collapsed killing all still in the building?

Interrogatory 123: Have you been aware at any time that John Patrick O'Neill, former FBI and head of the counter terrorism unit left the FBI in August 2001 at the age of 49?

Interrogatory 124: Have you been aware at any time that starting in 1995 John Patrick O'Neill was conducting his own internal investigation in the FBI about what really happened in the February 26, 1993 bombing of WTC 1, North Tower because Clinton fired the FBI Director William Sessions and it came out in the trial that the FBI was directly complicit in that 1993 bombing?

Interrogatory 125: John O'Neill left the FBI due to internal harassment and conflicts due to his inquiries into the February 26, 1993 bombing and the FBI complicity in that crime.

Have you been aware at any time that shortly before September 11, 2001, John Patrick, O'Neill was hired as head of security of the World Trade Center?

Interrogatory 126: Have you been aware at any time that John Patrick O'Neill died on September 11, 2001 helping people to evacuate WTC South Tower, which collapsed first and only 2 minor fires on the 78th Floor that were containable?

Interrogatory 127: The following is an excerpt from the Plaintiffs lawsuit:

“It will be sufficient to say here that no tall structural steel building has ever suffered global

collapse, either before or after 9/11, for any reason other than controlled demolition. [emphasis

added]. On 9/11, the official account says that there were three such instances due to minor low heat

fires – all on the same day and in the same place. That is a very suspicious record that cannot be ignored

when looking at all of the other factors.”

Do you agree with the foregoing statement of fact?

Interrogatory 128: Do you possess any information that rises to evidentiary facts that World Trade Center 1 and 2 were controlled demolitions that leads to the inescapable conclusion that close to 3,000 people were willfully murdered by a US agenda and probably carried out by the US Deep State?

Interrogatory 129: The conduct of the CIA should be put under full scrutiny and investigation for the following reasons.

First, at the September 11, 2004 event in NYC “9-11: Confronting the Evidence”, 2 males claiming to be with the CIA and flashing such credentials threatened the life of one of the presenters if he disclosed the asbestos lawsuit that the PANY&NJ lost on May 17, 2001. The presenter was not there to disclose that on the 3rd anniversary of 9-11-2001, he disclosed exactly what Bush was after in Afghanistan and why the United States committed the September 11, 2001 crime. There were 1,286 people in the auditorium plus the video crew and the other presenters that saw those 2 men go storming out of the auditorium.

Second, the aforementioned camcorder video tape that clearly shows what really hit WTC 2 was recorded by a Canadian banker who was in NYC on business. As he was recording WTC 1 being on fire and heavy smoke pouring out of the building, the second jet came racing into the field of view over the top of the Marriott Downtown, parallel with West Street and slammed into the building. Analysis of still photos captured from that video conclusively prove the jet was not the alleged hijacked Boeing 767, it was a Boeing 737. This was the closest video or photo of what hit WTC 2 and reveals that the Official Story that a hijacked Boeing 767 and minor fires on the 78th Floor is why the WTC 2 collapsed is a fable, a cruel mythology and a huge US government lie that is bereft of truth.

Third, two copies of that camcorder evidence were obtained from the Canadian banker and were in the possession of 2 Americans. On December 2, 2011 there was a robbery in Berlin and that copy of the video was stolen by the CIA. Who was in possession of that video is the author Karl Schwarz of a book that shreds George W. Bush lies and is titled “One Way Ticket to Crawford Texas”. A CIA agent was harassing business efforts in Budapest in 2006, then Vienna in 2008-2009 and was then seen at the scene of the robbery crime in Berlin. The Berlin Police report specifically states CIA involvement. When the Berlin Police called the US Embassy demanding identity of any CIA agents in Berlin, 4 such agents were ordered to exit Germany and Europe immediately. What the CIA did not get were the still photos used to analyze and conclusively proves it was a Boeing 737. In November 2012, the other American in

possession of the 22 still photos and second video was found murdered in her home. Debra K. Simon had not been answering her phone for 2 days because she was dead on the floor, found by her elderly father that went to see if she was OK. A Black male drug addict was arrested, convicted and sent to prison for life. However, money was still in her purse and the only thing missing from her home was 1 knife that was the alleged murder weapon, and the video and still photos proving it was a 737 that hit the WTC 2 South Tower.

Fourth, as revealed in interrogatory 37, former CIA Malcolm Howard, deceased at age 79, revealed on August 26, 2022 that he and 3 other CIA operatives are who covertly wired WTC 7 from 1997 to 2001 to destroy that World Trade Center 7 by controlled demolition.

Fifth, further below in these interrogatories there is additional information that results from 2016 to 2021 interviews with FBI and CIA persons that reveals illegal CIA activities inside the United States 2 to 3 years prior to September 11, 2001.

With those facts now known to you, do you think or know as fact the US government is who committed the crime of September 11, 2001?

Interrogatory 130: Regarding the appeal that was filed by PANY&NJ and Port Authority Trans-Hudson Corporation, United States Court of Appeals, Third Circuit, No. 01-2513, Argued September 9, 2002; Filed November 14, 2002.

"The District Court held that unless asbestos in a building was of such quantity and condition as to make the structure unusable, the expense of correcting the situation was not within the scope of a first party insurance policy covering "physical loss or damage." We agree and will affirm".

Since the entire WTC was completely destroyed on September 11, 2001, the rubble rushed off to disposal sites without any serious forensic analysis of the crime scene, do you think that decision by Third Circuit was already a moot and null point to attempt to quietly close the book on the crimes of the Bush-Cheney Administration and certain US citizens and government agencies that are responsible for the destruction of the World Trade Center by controlled demolition?

Interrogatory 131: Do you think or know that Bush's rushed appointment of Michael Chertoff to Third Circuit US Court of Appeals, as a judge with zero experience on the bench, was a panic move that the PANY&NJ might appeal again to hedge their bets that Lucky Larry Silverstein's "double terrorist attack" insurance scam might fail and all that would be left then is a big hole in the ground in Lower Manhattan and thousands of questions intentionally left unanswered or refused to be answered?

Interrogatory 132: Have you been aware at any time that the FBI had a direct hand in planning and execution of the bombing of World Trade Center 1, North Tower on February 26, 1993?

Interrogatory 133: If yes, at what approximate or exact date did you know that fact?

Interrogatory 134: Have you been aware at any time that former president Bill Clinton fired FBI Director William S. Sessions, a former US District Court judge with impeccable record, because he had initiated an internal investigation as to who in the FBI participated in that February 1993 crime?

Interrogatory 135: Due to evidence that came out in the 1993-1994 trial, the FBI had a helper asset, that helper was recruiting the "terrorist bomber", but he had also been recording his conversations with his FBI handlers. Due to chronology, there are indications that the February 26, 1993 bombing of WTC 1

North Tower actually started during the George H W Bush Administration. Do you have any personal knowledge that corroborates that?

Interrogatory 136: Did you know as of September 11, 2001 that the destruction of the WTC was not a terrorist attack by Islamic terrorist foreigners that supposedly “hate our freedoms”, and it is very doubtful they planted the explosives in the World Trade Center that were heard by many First Responders?

Interrogatory 137: One of George Bush’s stated reasons for assaulting Afghanistan is the Taliban would not hand over Osama bin Laden and he was going to go get him.

Have you been aware as President or private citizen that Osama bin Laden was not in Afghanistan?

Interrogatory 138: Osama bin Laden was in Ladiz Iran, Balochistan Province and was being treated at a military hospital near Tehran. Former House Armed Services Committee Vice Chairman Curt Weldon confirmed interrogatory 137 and this one via his own intelligence sources. Mr. Weldon challenged the CIA on the matter in 137 and this one and they said they had heard about it but would neither confirm nor deny.

Have you ever been aware of what Osama bin Laden was being treated for as a serious and ultimately fatal medical condition?

Interrogatory 139: In 2025 there have been two recorded video interviews done by Tucker Carlson and Clayton Morris of ‘Redacted’ with Curt Weldon. Mr. Weldon (R-PA) is a former high-ranking member of the US House, Vice Chairman of House Armed Services Committee and Chairman of a subcommittee overseeing a \$180 billion Defense Research program. Mr. Weldon had 4 intelligence assets reveal to him personally that Osama bin Laden was in Ladiz Iran. Mr. Weldon also revealed Osama bin Laden was being treated at a military hospital near Tehran, but not what he was being treated for or what exact medical condition. When Curt Weldon started questioning September 11, 2001 and certain actions, the Bush Administration wanted him out of power and out of Congress and used the FBI to attempt to frame him to lose in the 2006 midterm elections. Curt Weldon was in line to be the next Chairman of House Armed Services Committee.

Have you been aware of any of the foregoing in interrogatory 137, 138 or 139 as private citizen or as President?

Interrogatory 140: Who had arranged for Osama bin Laden to come to Iran for treatment was IRG General Qasem Soleimani. Did one of your Neocon advisors provide erroneous actionable intelligence for you to order a drone strike on General Soleimani since one the primary excuses given by George Bush is he was going to Afghanistan to punish an “evil doer” who was not even in that nation?

Interrogatory 141: Did any of your National Security Advisors ever inform you that General Soleimani was a highly respected man in the Middle East because he was trying to restore the order that George H W Bush and George W. Bush totally wrecked with their lies, illegal wars of aggression and their use of “modern atrocity propaganda” to pursue the indefensible and inexcusable?

Even Dick Cheney as Secretary of Defense stated after Desert Storm if Saddam were removed from power, Iraq and the Middle East would descend into chaos and violence. It did but that was due to the USA forcing it to happen.

Interrogatory 142: If yes, you were fed bad information, who gave you the information to authorize General Soleimani be eliminated? The purpose of this question is to corroborate that the name of that person is probably already a named Defendant in this lawsuit.

Interrogatory 143: Have you been aware at any time that the longest serving CIA person on the UBL Station, aka: ALEC Station, the Usama bin Laden hunters was killed in Khost Afghanistan, which is much closer to where Osama bin Laden was than the mountains Bush was bombing, along with 7 other CIA agents as reported by the NY Post on December 20, 2009?

Interrogatory 144: Kidney disease that leads to renal failure and death is what Osama bin Laden was being treated for in Iran. It is not likely he was still alive as of December 2009 or when Barrack Obama and Hillary Clinton allegedly bagged him in Islamabad Pakistan and dumped the body in the ocean, so no one could rely on a positive ID.

Are you aware of who was actually killed by SEAL Team 6 in Pakistan, and shortly thereafter SEAL Team 6 was dead, too?

Interrogatory 145: A well-known Conservative Republican named Karl W. B. Schwarz wrote a book that was published in 2004 named "One Way Ticket to Crawford Texas" that exposed many lies and capital market frauds of Bush, his Texas gang, and his Pioneer political backers. This is a citation from that book and the lawsuit brought by Plaintiff Groups A, B, C, D and E.

"The following is copied and pasted from the Schwarz book (January 2004) as it appeared in a foreign newspaper and in the book, Chapter 3, pages 88-89. The link to this article was blocked on the Internet shortly after it was published and was posted on the newspaper website in English:

11:01 2001-11-22

Bin Laden: Not all Americans are bad

"Mohammed Omar predicted the current campaign by the USA in Afghanistan 5 years ago, claiming that when the Taliban would not allow the US to build a pipeline they will begin to attack us, justifying it with Bin Laden. [Plaintiff's notice to the Court is those 5 years leading up to September 11, 2001 is when Bidas Corporation was under full assault from multiple US and Saudi parties to block the Bidas SAPIC TAP Trans-Afghanistan Pipeline.] [emphasis added].

Omar's words are reported by Hamid Mir, who made the last interview with Osama Bin Laden, who declared that he is not against the American people, only the politicians and the state.

In the first interviews, Osama Bin Laden had declared himself against all the American people, but he had changed. He admitted that there were many good people in the United States and it was the politicians and State, which he despised. He told Mir that he had seen many western people on television protesting at the bombing in Afghanistan and concluded, "They are good people. They are not Moslems, but they condemn the bombing". "

Have you been aware of those foregoing facts either before or after September 11, 2001?

Interrogatory 146: Have you been aware at any time that the most powerful warlord in Afghanistan made it clear to Bush that the USA was not welcome in Afghanistan especially regarding the pipeline right-of-way Bush planned to steal with military force?

Interrogatory 147: His name was Ahmad Shah Massoud, the USSR army nicknamed him “the Lion of Pansjhir” due to his Pashtun army being so lethal to Russian forces in the 1980-1988 Russia Afghan War. He was assassinated on September 9, 2001 by a Jordanian crew who came to interview him and had been recruited by the US. It is the Plaintiffs position that this is another matter of CIA wrongdoing that needs to be fully investigated.

Have you ever been aware of those facts because he was a highly respected man and apparently assassinated by a Jordanian crew with US government assistance and sent along with a digital camera that was a bomb that was remotely detonated during the interview?

Interrogatory 148: The day before on September 10, 2001, Donald Rumsfeld was in a Pentagon press conference and admitted that the Pentagon could not account for \$2.3 trillion when reporters were grilling him about an internal Pentagon investigation that was in progress. The next day on September 11, 2001 that investigation team was eliminated by the attack on the Pentagon.

Have you been aware of that fact at any time after September 11, 2001 or while sitting as President of the United States as Commander-in-Chief?

Interrogatory 149: You own a Boeing 757 and probably are very familiar with that aircraft.

Are you aware that there was not 1 single piece of a 757 at the Pentagon but there were multiple and identifiable components of a Cold War military aircraft named the A3 Skywarrior?

Interrogatory 150: There are no A3 Skywarrior aircraft operating out of Dulles International Airport nor would any “radical Islamic male” be allowed on a military base to steal one. The Pentagon reportedly had 2, operating condition unknown, but Hughes Aircraft had purchased a fleet of them that had been completely refurbished and upgraded and was then acquired by Raytheon Corporation.

Have you ever been aware of this fact?

Interrogatory 151: As Commander in Chief of the US military as President, are you aware of what the USAF and Navy refer to as “Whiskey” zones off the coasts of the United States?

Interrogatory 152: Have you been aware at any time that in June 2001 Donald Rumsfeld changed the rules of engagement for alleged hijacked aircraft or enemy aircraft penetrating US airspace from 2 modes to 1 and the only remaining was just a watch, tail and see mode?

Interrogatory 153: Have you been aware at any time that on September 12, 2001 Donald Rumsfeld reinstated the dual intercept rules of engagement that are both FAA notice and USAF response?

Interrogatory 154: If it can and will be proven in a Court of law that no hijacked Boeing 767 jets from Boston Logan International Airport hit WTC 1 or WTC 2 and no Boeing 757 hit the Pentagon, would you order the US Navy or a private deep ocean search company to search the Whiskey Zone east of Boston for Flights 11 and 175 and search the Whiskey Zone east of Norfolk VA\ for Flight 77?

Interrogatory 155: Are you familiar with the Boeing Uninterruptible Autopilot and once invoked the real pilot of the jet has no control of where that jet is being directed to go?

Interrogatory 156: Did Rudy Giuliani know about the lawsuit, the asbestos, PANY&NJ lost in court May 17, 2001?

Interrogatory 157: Did the Office of the Mayor of New York City have a representative of that office that was either a liaison to or a board member of the PANY&NJ and Trans-Hudson Corporation?

Interrogatory 158: If Trump real estate group was interested in acquiring the World Trade Center, what PANY&NJ person or persons were you in contact with regarding that matter?

Interrogatory 159: The public record is clear that Clinton appointed George Tenet as CIA Director.

Did George Bush let Tenet remain as the Director to brief him on what the CIA did to block the north end of the TAP in Turkmenistan, which led to the Bidas SAPIC lawsuit in Texas courts Bidas SAPIC v. Turkmenistan, Turkmenneft and then Fifth Circuit US Court of Appeals, and then what CIA did in Pakistan to block the South end of the Trans-Afghanistan Pipeline that included Turkmenistan, Afghanistan and Pakistan?

Interrogatory 160: When former Secretary of Defense Donald Rumsfeld, deceased, and CENTCOM commander General Tommy Franks were testifying before Congress months before September 11, 2001, General Franks responded to a direct question about what his primary mission was in Afghanistan as *“the pipeline and access to the regions resources”*. General Franks will be subpoenaed by the Plaintiffs to testify.

Why did George Bush and Dick Cheney lie to America and the world about their real motives in blaming 9-11-2001 on Afghanistan since it sits right in the middle between Turkmenistan and Pakistan to get a pipeline all the way to an ocean port?

Interrogatory 161: The pipeline CENTCOM General Tommy Franks referred to is also a matter of record in US Courts as is the WTC asbestos matters. Bidas SAPIC v Turkmenistan, Turkmenneft, Fifth Circuit, US Court of Appeals, 345 F.3d 347, Filed: September 15th, 2003, and prior to that in Texas state courts.

If the reason to destroy WTC in a manner that it appeared to be a terrorist attack was to justify the attack on Afghanistan to take over the Bidas pipeline right-of-way to get the CIS – Caspian Basin oil and natural gas to the ocean, why did Bush-Cheney lie to America and the world about what really happened on September 11, 2001 and what the real motives and objectives were; i.e. oil, natural gas and Bidas pipeline right-of-way deal across Afghanistan and a long list of Bush insiders already endeavoring in Kazakhstan, Uzbekistan and Turkmenistan to grab onto all of the oil and natural gas they could?

Interrogatory 162: The 10th Mountain Division had been ordered to mobilize and provision for invasion of Afghanistan well in advance of September 11, 2001. The earliest known combat clashes with the Taliban involved Green Berets, CIA Special Activities Division and 10th Mountain Division.

Were you ever aware of those facts?

Interrogatory 163: Presuming that Trump real estate group is a sophisticated investor and precedent US court cases are abundant regarding asbestos liability and what lenders, insurers and even property owners are required to do by law, did Trump real estate group decline the purchase of WTC due its

knowledge prior to conducting due diligence, or was learned during due diligence about the asbestos problems and the huge costs it would require to remediate same?

Interrogatory 164: Did Trump real estate group ever meet with or request records in the form of architectural and engineering plans, specifications, as-built drawings, etc. from the project architect firm of record Emory Roth & Sons or from PANY&NJ?

Interrogatory 165: If such a request was made for documents to evaluate the purchase of WTC commercial office buildings, was that request made prior to or after US Government officials had confiscated all of those documents apparently so a controlled demolition could be planned?

Interrogatory 166: If you were able to obtain WTC plans and specifications and such preceded the US government confiscation of those documents, what month and year did you have those documents?

Interrogatory 167: Do you know when those plans and specifications were confiscated and by what US government agency?

Interrogatory 168: Do you have any personal knowledge that the Bush family animosity towards you is directly related to your knowledge of the WTC asbestos problems and they are afraid you will expose it?

Interrogatory 169: Do you have any personal knowledge that the Clinton family animosity towards you is directly related to your knowledge of the WTC asbestos problems, the February 26, 1996 bombing of WTC 1 North Tower, they know about that and they are afraid you will expose it?

Interrogatory 170: Do you have any personal knowledge that the GOP Establishment is hostile towards you because they backed the entire Global War on Terror including Bush-Cheney actions, \$6 trillion blown literally on a "pipeline dream", and endless lies, and if the public were to learn that they hid the asbestos lawsuit and did September 11, 2001 to launch a now failed GWOT to rush at Afghanistan to steal the Bidas SAPIC pipeline right-of-way it would cost them votes?

Interrogatory 171: Do you have any personal knowledge that former US House member Liz Cheney is hostile towards you because if you tell all you know about World Trade Center her father Dick Cheney will be facing some serious criminal charges and their family name is ruined?

Interrogatory 172: Do you have any personal knowledge before being elected President or while sitting as President of the identity of GOP Representatives and Senators that knew about the WTC asbestos problems and lawsuit, knew exactly why the WTC was destroyed to eliminate asbestos, but backed Bush on his Global War on Terror based on lies and every Draconian law they passed after that using September 11, 2001 as the justification?

Interrogatory 173: If yes, please name as many as you can of those GOP Representatives and Senators for the record whether they are in the House and Senate now or not, but they were in Congress leading up to September 11, 2001.

Interrogatory 174: Is it accurate to state that such GOP Representatives and Senators are both Establishment Republican war hawks and/or Neocons, and/or Deep State actors, or RINO's playing along for their own benefit?

Interrogatory 175: Do you have any personal knowledge before being elected President or while sitting as President of the identity of Democrat Representatives and Senators that knew about the WTC

asbestos problems and lawsuit, but backed Bush on his Global War on Terror based on lies in exchange for a *quid pro quo* like new defense and security related projects in their districts or states, and possibly the creation of PEPFAR as a slush fund the Democrats love to plunder and made President George W Bush the largest AIDS donor in US and world history?

Interrogatory 176: If yes, please name as many as you can of those Democrat Representatives and Senators for the record whether they are in the House and Senate now or not.

Interrogatory 177: Do you have any personal knowledge before being elected President or afterwards that the Republican Party and the Democrat Party were knowledgeable about the WTC asbestos problems and in a real way have aided and abetted in the coverup of the truth about September 11, 2001?

Interrogatory 178: Do you have knowledge that former CIA DDO, Deputy Director Operations, James L. Pavitt (deceased December 23, 2022) was directly involved in the controlled demolition of the WTC and preemptive actions in Afghanistan to clear a path for George Bush and Tony Blair to steal the Bidas accomplishment with military force?

Interrogatory 179: The BBC characterized Pavitt's appearance before the 9-11 Commission as "unprecedented". Do you have reason to believe or firsthand knowledge that Pavitt's appearance was to deflect attention away from US government involvement in September 11, 2001 and the fact that CIA Special Activities Division, a private CIA army were already on the ground in Afghanistan possibly even before September 11, 2001?

Interrogatory 180: The Plaintiffs found evidence that CIA Special Activities Division was in Afghanistan and possibly even before September 11, 2001 and that group was directed by DDO James L. Pavitt. The first alleged US casualty in Afghanistan was a CIA Special Activities Division, former USMC captain and the CIA stated date of his death is not consistent with other known facts and evidence. CIA Director George Tenet even eulogized deceased Johnny Micheal Spann's death in November 2001.

Are you aware of any facts and evidence that George Tenet was directly involved in the destruction of the World Trade Center, the coverup in the US and the coverup in Afghanistan as it being the real objective but a "Pearl Harbor" was needed?

Interrogatory 181: Have you been aware at any time that CIA counter terrorism expert Cofer Black is known to have lied to and misled the 9-11 Commission?

Interrogatory 182: Do you have knowledge that the Chief Operations Officer of Stratesec, Barry McDaniel, former US Army military ordnance command at Fort Monmouth AMC, New Jersey, thought to have been involved in Iran-Contra, provider of security equipment and access systems to World Trade Center was directly involved in the controlled demolition of the WTC?

Interrogatory 183: After Larry Silverstein leased WTC for 99 years, he apparently changed security companies to Kroll Associates and had Dr. Jerome Hauer, PhD as head of the NYC Office of Emergency Management. This is the same man former Mayor Rudy Giuliani had initiate and put into operation the NYC Emergency Management Center in WTC 7, and his PhD is from a UK military academy. Additionally, it was Jerome Hauer that hired former FBI counter terrorism expert John Patrick O'Neill as head of WTC security shortly before September 11, 2001.

Do you have knowledge that Dr. Jerome Hauer, PhD was involved in the controlled demolition of the WTC?

Interrogatory 184: Retired General Wesley Clark, former NATO commander has revealed publicly in several forums that his friends and fellow officers in the Pentagon revealed to him that former Secretary of Defense Donald Rumsfeld had issued a memorandum shortly after September 11, 2001 that the plan was for forced regime change of 7 nations in 5 years.

Do you have personal information that what Retired General Clark stated was true?

Interrogatory 185: Have you discussed the WTC asbestos lawsuit and problems with Rudy Giuliani at any time prior to being elected President or during the time you were sitting as President? Please specify the time frames of any such discussions.

Interrogatory 186: Were any of those discussions related to how to best disclose the truth to America and the world on what really happened on September 11, 2001 and why it happened, and who was really responsible for that horrendous crime as Bush Family “modern atrocity propaganda”?

Interrogatory 187: Were you aware in the proximity of September 11, 2001 that former President George W. Bush promoted Christopher R. Wray from the US Attorney Atlanta office to Assistant Attorney General Criminal Division in 2001 and then appointed Michael Chertoff to Third Circuit US Court of Appeals from 2003 to 2006, Philadelphia PA where the WTC asbestos lawsuit was appealed after the May 17, 2001 court decision against PANY&NJ and then quickly upheld the May 17, 2001 New Jersey US District Court ruling on November 14, 2002?

Interrogatory 188: Have you ever seen another instance where a man that was an attorney, then US Attorney in New Jersey, never elected, appointed or confirmed as a US District Court judge or any other level of court suddenly appointed to Third Circuit US Court of Appeals as Bush did regarding Michael Chertoff?

Interrogatory 189: Do you have information that Christopher R. Wray was directly involved in the September 11, 2001 coverup, including the anthrax attack on Congress on September 18, 2001?

Interrogatory 190: Exactly who by name or names recommended that you appoint Christopher R. Wray to be Director of the FBI?

Interrogatory 191: After Tom Ridge resigned from being the first Director of Department of Homeland Security, Michael Chertoff resigned as a Third District US Court of Appeals judge to become the second Director of the Department of Homeland Security. Have you ever had any confirmed information showing that Michael Chertoff was involved in September 11, 2001 itself or the US government coverup?

Interrogatory 192: Are you aware of the existence of the security and advisory firm Chertoff & Associates?

Interrogatory 193: Are you aware that the managing director of that firm is Chad Sweet, former covert agent of the CIA during the early part of the Bush Administration and he was Chief of Staff under Chertoff at Department of Homeland Security?

Interrogatory 194: Were you aware at any time from the 1993 “terrorist attack” on WTC 1, North Tower to September 11, 2001 that the asbestos lawsuit was in progress since 1987 in the New Jersey Superior Court, later filed as a new case in the US District Court Newark NJ in 1991, where it decided and issued its final ruling on May 17, 2001 that the PANY&NJ and Trans-Hudson Corporation were not

entitled to the approximately \$6,000,000,000 (Six billion and no/100 dollars) they were seeking to fix the asbestos problems?

Interrogatory 195: Were you ever aware that the first alleged “terrorist attack” on WTC 1, North Tower in February 1993 happened after the asbestos lawsuit had been moved from New Jersey Superior Court and filed in 1991 in the US District Court, Newark NJ?

Interrogatory 196: Do you have any personal knowledge that the February 26, 1993 bombing attack on WTC 1, North Tower, was aided and abetted by George H W Bush and/or Clinton operatives in the FBI and/or other US government officials?

Interrogatory 197: Do you have any personal knowledge that former president Bill Clinton fired FBI Director William S. Sessions long before his 10-year term was to expire, a former US District Court judge, on July 19, 1993 because he was conducting an internal investigation as to whether or not FBI agents provided the explosives used in the first attack on WTC 1 and if confirmed exactly what FBI agents and other US government employees were involved?

Interrogatory 198: A Washington Post article dated July 20, 1993 disclosed that it was Attorney General Janet Reno who informed Clinton that Sessions could “no longer effectively lead the bureau and law enforcement community” and Sessions was immediately fired. (Cited from the Washington Post article: *“Clinton telephoned Sessions yesterday afternoon to inform him that he had been fired and then called back several minutes later to remind him that the dismissal was "effective immediately." The president told reporters afterwards that he acted after Attorney General Janet Reno "reported to me in no uncertain terms that he {Sessions} can no longer effectively lead the bureau and law enforcement community" and that he agreed with that assessment.”*

Do you have any personal knowledge that Clinton and former AG Janet Reno were involved in the February 26, 1993 bombing of WTC 1 or a US government coverup of criminal wrongdoing by the FBI?

Interrogatory 199: It is no secret that William S. Sessions had an excellent and flawless record as a US District Court judge and he was not appointed to that position or as FBI Director by Clinton. Under US law he was to have served a 10-year term as Director of the FBI. In your opinion does it smell of hypocrisy and obstruction of justice that a man that dedicated himself to enforcing the law on the bench and then as FBI Director is suddenly deemed by Attorney General Janet Reno "reported to me in no uncertain terms that he {Sessions} can no longer effectively lead the bureau and law enforcement community" because he was investigating what really happened at WTC 1 on February 26, 1993?

Do you have personal knowledge that the February 26, 1993 bombing of WTC 1 North Tower did involve the US government via the FBI?

Interrogatory 200: Cited from the FBI website regarding the history of directors of the FBI: In July 1991, former President George H W Bush appointed Louis Freeh as United States District Court Judge for the Southern District of New York to replace William S. Sessions. While serving in this position he was nominated to be the Director of the FBI by President Clinton on July 20, 1993. It is fact that the PANY&NJ asbestos lawsuit was already in progress in US District Court, New Jersey.

Do you have any personal knowledge that Louis Freeh was appointed as FBI Director to end an internal investigation that William S. Sessions had commenced during the Clinton Administration?

Interrogatory 201: One week before September 11, 2001, Robert S. Mueller III was sworn in as FBI Director and served for 12 years from September 4, 2001 to September 4, 2013 into Obama’s second term

in office. [Cited from FBI website: “Under the Omnibus Crime Control Act and Safe Streets Act of 1968, Public Law 90-3351, the Director is appointed by the U.S. President and confirmed by the Senate. On October 15, 1976, in reaction to the extraordinary 48-year term of J. Edgar Hoover, Congress passed Public Law 94-503, limiting the FBI Director to a single term of no longer than 10 years.” Additional statement on FBI website list of directors: “Robert Mueller headed the FBI for exactly 12 years, the second longest in history, following legislation in 2011 that extended his tenure by two years.”]

Do you have any personal knowledge that Robert S. Mueller III has been involved in the coverup of what really happened on September 11, 2001 and was even allowed to overstay by 2 years with 2011 legislation that allowed him additional time as FBI Director due to the Washington DC establishment’s fears of the repercussions of the truth about September 11, 2001 being known?

Interrogatory 202: It is known that Clinton, Tenet, Bush Administration and Mueller tried to make Louis Freeh the scapegoat for intelligence failures leading up to September 11, 2001 and he did not appreciate that for many reasons that came out later in the 2016 to 2021 inquiry led by former DEA Donald C. Canestraro. More on this matter is addressed later in these interrogatories.

Do you have any personal knowledge that the coverup of September 11, 2001 and the creation of a web of deceit actually started in earnest 2 to 4 years prior to the alleged terrorist attack in NYC, WTC and the Pentagon?

Interrogatory 203: At what time of month and year did you learn that Larry Silverstein was in discussions with PANY&NJ and Trans-Hudson Corporation to lease the WTC complex of buildings for 99-Years?

Interrogatory 204: Are you aware of any due diligence Larry Silverstein did regarding his purchase of the WTC 7 building in Lower Manhattan that would comply with the environmental requirements and his Environmental Remediation Plan for lenders, insurance or clear title ownership regarding asbestos being within the WTC 7 building or the other 6 buildings he and Frank Lowy leased for 99 years on July 24, 2001?

Interrogatory 205: Due to your connections within the NYC real estate developers and owners, did you learn at any time that Larry Silverstein was not insuring WTC on asbestos but did insure WTC against terrorist attack, which conveniently happened a few months later and obliterated the need for asbestos remediation except for the lingering damage it has done to many other humans?

Interrogatory 206: If the answer to Interrogatory 205 is yes, at what approximate time did you learn of the insurance approach on WTC for “terrorist attack” by Larry Silverstein?

Interrogatory 207: Do you have any personal knowledge that Larry Silverstein had information that the entire WTC complex was going to be destroyed due to the PANY&NJ losing the US District Court lawsuit on May 17, 2001?

Interrogatory 208: The chronology is not hard to reconstruct. On May 17, 2001, the US District Court ruled against PANY&NJ, about 2 months later Larry Silverstein leases WTC for 99 years on July 24, 2001, insures the buildings for terrorist attack but not asbestos, and about 2 months later the entire WTC complex is destroyed by an alleged terrorist attack and asbestos problem is removed by force.

Are you aware that it would take months to wire WTC 1, WTC 2 and WTC 7 for controlled demolition due to height of the buildings, complexity of the structure to bring them down as close to footprint at ground level as possible?

Interrogatory 209: Larry Silverstein has stated in a public forum that he personally gave the order “pull it” regarding WTC Building 7. Is the term “pull it” related to controlled demolitions of midrise and high-rise buildings?

Interrogatory 210: Given that it would take months to wire, test explosion sequences, and place explosives, if September 11, 2001 was a “surprise terrorist attack by 19 Saudi and Arabic extremists that hate America’s freedoms”, can you come up with any explanation as to how the WTC 7 got wired and brought down by controlled demolition in less than 8 hours after WTC 1 and WTC 2 lay in ruins?

Interrogatory 211: During your campaign for President you said you would get to the bottom of 9-11-2001 and hold those responsible accountable. Towards the end of your first Administration the lid was kept on the secrecy on the events of September 11, 2001. Who by name or names recommended that “the secrecy is secret” as it was announced and needed to be maintained as classified?

Interrogatory 212: Most Americans reaction to Bob Barr’s “the secrecy is secret” can be summed up easily. There should be no secrets about 19 alleged but dead radical Islamic hijackers since they are allegedly dead. Unless, the coverup is really about rogue elements of the US government are who did September 11, 2001 and that is why “secrecy is secret” is used as an avoidance and evasion ploy to sidestep having to face justice for what they did.

Is that a position you understand and agree with as to what the secrecy is really about?

Interrogatory 213: In your personal opinion based on information you know to be true, do you think William Jefferson Clinton, Janet Reno and certain parties in the FBI and/or other government agencies should face charges of obstruction of justice, commission of terrorism in New York City, murder and treason for what happened at WTC 1 on February 26, 1993?

Interrogatory 214: In your personal opinion based on information you know to be true, do you think George W. Bush, Richard B. Cheney, Donald J. Rumsfeld posthumously, Condoleezza Rice, Retired General Colin Powell acting as Secretary of State, Robert S. Mueller III, Christopher R. Wray, and many others that aided and abetted the coverup relating to the events at WTC and the Pentagon should face charges of obstruction of justice, commission of terrorism against the United States, murder and treason and other violations of US criminal laws for what happened on September 11, 2001?

Interrogatory 215: Did you have any knowledge prior to September 11, 2001 that Mayor Rudi Giuliani and/or Dr. Jerome Hauer had already closed the New York City Emergency Management Office and response center in WTC Building 7 and relocated it elsewhere in New York City due to the asbestos?

Interrogatory 216: It has been reported that within 1 hour after WTC 7 was brought down by controlled demolition a flight left Kosovo with a large amount of US dollars in crates. The destination was an airport in the CIS region north of Afghanistan. The crates were then offloaded onto Chinook helicopters and flown to an old military base in Northern Afghanistan. Who owns that base is General Rashid Dostum, an Uzbek holdover from the Russia-Afghan War 1980-1988. He had already signed a contract with Argentina company Bidas Corporation as did the Taliban. That information was reported by a former UNMIK employee to his wife that was onboard that flight as part of the security team. Todd Engstrom was killed in Iraq while working for Blackwater USA. These details were in an article titled “Pop Goes the Bush Mythology Bubble, Part VI”.

If September 11, 2001 was a surprise and alleged terrorist attack on the WTC and Pentagon, why would the USA rush crates of USD to Afghanistan around midnight Kosovo time, September 11, 2001 and the entire WTC lay in smoldering ruins and close to 3,000 dead?

Interrogatory 217: The Bush Family was overhead at a Houston Golf and Country Club specifically talking about the article that disclosed that flight and its author was even mentioned by name. Basically, the Bush Family was very concerned that anyone knew about that flight from Kosovo to Turkmenistan and then a large amount of USD was delivered to an old Russian military base in Northern Afghanistan.

Would anything surprise or not surprise you about the Bush Family and September 11, 2001 and what happened after that?

Interrogatory 218: Have you ever been aware that TIME magazine ran an article George J. Church March 18, 1991 titled “Soviet Union: Operation Steppe Shield”, which was a George H W Bush and Pentagon plan to possibly invade the USSR regarding the motherlode of oil and natural gas that is in Kazakhstan, Uzbekistan and Turkmenistan?

Interrogatory 219: Can you see the correlation of what George H W Bush was planning in his one-term administration, George W. Bush came into office January 20, 2001 with adamant plans to go after that same objective?

Interrogatory 220: Were you aware when performing due diligence on the WTC buildings and a possible acquisition that the CIA had offices in WTC 7?

Interrogatory 221: If known to you, or can be verified by you as President, was the CIA location in WTC 7 designated as an “Operations Center” and when did the lease term start and was to have expired?

Interrogatory 222: At the time of performing due diligence on the WTC buildings was the CIA still in WTC 7 or had the agency already relocated due to the asbestos problems and the impending controlled demolition of WTC 7?

Interrogatory 223: If the CIA was in the process of relocating its NYC operations, what month and year did you learn that fact?

Interrogatory 224: The Department of Justice and the FBI reportedly also had offices in World Trade Center 7.

When Trump real estate group was evaluating the purchase of the entire WTC complex, were those offices still there or had they been relocated due to the asbestos problems?

Interrogatory 225: Have you been aware at any time since August 2015 that Sputnik International published an article titled ‘Nearly 4 Thousand 9/11 First Responders Have Been Diagnosed with Cancer’ 20:27 GMT 11.08.2015 (Updated: 10:24 GMT 06.08.2022), and that as of August 2015 the total number of First Responders and site cleanup workers that had been diagnosed with cancer or died of cancer had reached 3,700, which is considerably more than died at WTC Ground Zero?

Interrogatory 226: The Plaintiffs have yet to find any US newspaper or magazine article or any TV news report or photo op that picked up on what is an extremely important matter that is a direct result of the crime of September 11, 2001.

Have you ever seen any report that the cancer cases and impending deaths due to asbestos induced cancer had already exceeded the death toll of September 11, 2001 by 2015, and that was just the First Responders?

Interrogatory 227: On September 12, 2019, Sputnik ran another article that got almost zero notice or coverage by any US MSM media outlets whether print or television: “‘There's No End to This’: 18 Years Later, 9/11 First Responders Still Seek Medical Support.”

Do you intend a full, total and complete disclosure of what happened on September 11, 2001, because if not this lawsuit intends to do so on behalf of about 2 million plaintiffs that have had their lives and health ruined or ended by asbestos induced cancer, pathetic and harmful anthrax vaccines forced upon US soldiers, due to what the US did on September 11, 2001?

Interrogatory 228: Are you concerned that the actual death toll due to the events of September 11, 2001 has or will escalate drastically due to the asbestos not being contained and mitigated properly and potentially from tens of thousands to hundreds of thousands to millions of people were exposed?

Interrogatory 229: It is a matter of public and media record that you hired workers to assist in the post-9-11 matters in the search for bodies and help with clean up. Are you aware of any person or persons that have verified if those cleanup crew workers you hired have been diagnosed with cancer as the First Responders and other Ground Zero workers have been?

Interrogatory 230: If yes to the above, who can the Plaintiffs contact regarding the asbestos / cancer matters and any monitoring of the health of all First Responders and the workers you hired?

Interrogatory 231: In evaluating the purchase of the World Trade Center buildings 1, 2, 3, 4, 5, 6 and 7, and possibly the hotel, what was the occupancy rate of the buildings at that time and what month and year was that fact established?

Interrogatory 232: Is it true that the WTC 1 and 2 buildings, and Larry Silverstein's WTC 7 were mostly vacant due to asbestos and most tenants had moved to other office buildings in NYC or even into New Jersey or were waiting to move out of WTC when other buildings were completed?

Interrogatory 233: Were you aware at any time that Bidas Corporation of Argentina had sewed up that TAP pipeline deal from Ashgabat Turkmenistan thru Afghanistan and thru Balochistan Province Pakistan to the port city of Gwadar? Argentina company Bidas was welcome in that area of the world, USA was not due to what the Reagan Bush Admin did during the Russia-Afghan War 1980-1988.

Interrogatory 234: Were you aware at any time that after a decade of planning and scheming, after Bush and Tony Blair assaulted Afghanistan they knew as early as 2002 that they had been blocked on their “Mission Accomplished” and that was not by the Taliban?

Interrogatory 235: The nations of China and Pakistan signed the CPEC agreement after at least 1 year of negotiations in 2002. That is the China Pakistan Economic Corridor, part of the Belt & Road system and that took away the Gwadar Pakistan port on the Arabian Sea that was both Bidas Corporation and Bush-Blair's objective. Construction started in 2002 and ended 2006.

Has anyone informed you of those facts either as private citizen or during your first or second term?

Interrogatory 236: With that as a known and provable fact, plus the excellent work both Elon Musk at DOGE and you are doing that revealed the USAID funding to “Afghan Farmers” in the amounts of \$300,000,000 and \$330,000,000, do you think it is appropriate or even legal for the US to have stayed 20 more years in Afghanistan raising poppy fields for heroin production and directly engaging in heroin trafficking by the CIA, USAID and possibly the US military?

Interrogatory 237: Regardless of what Americans have been led to believe about the Taliban, after Biden quickly exited Afghanistan in 2022 the Taliban destroyed all of those poppy fields.

Do you support the Taliban's actions to destroy those poppy fields and eliminate heroin production from their nation as a US sponsored program for US production and trafficking of heroin?

Interrogatory 238: Have you been aware at any time that what appears to have occurred during the Obama Administration, Mexican Drug Cartel members were being trained at the Fort Bragg School of the Americas that has been used for decades to train people from Central and South America to be armed and violent proxies for the United States objectives in those areas?

Interrogatory 239: After the Taliban put the USA out of the heroin business in their nation, production shifted to the West coast of Mexico and a recent report indicated that heroin trafficking into the USA has increased by at least 30%.

Are you aware of this information and is any agency of the US government involved in that shift of poppy fields from Afghanistan to Mexico for heroin production?

Interrogatory 240: The foregoing interrogatories 236 to 239 raise an interesting question. How can the US wage and win the War on Drugs when certain parts of the US government are a functioning Drug Cartel?

Interrogatory 241: Were you aware at any time that Bidas Corporation prevailed at Fifth Circuit US Court of Appeals (Final Order September 9, 2003, Bidas SAPIC, et al v Turkmenneft, 345 F.3d 347 (5th Cir. 2003)) on an arbitration claim coming out of Texas court in the amount of \$495 million for interference of contract in Turkmenistan during the Clinton Administration and CIA interference that also included Unocal, Saudi owned Delta Oil, former State Department Zalmay Khalilzad who had the nickname "The Butcher of Bosnia" and was Bush's choice as US Envoy to Afghanistan 2001 and later Iraq 2003?

(The original case was in Texas courts as Bridas v Unocal, Delta Oil, et al, a \$15 billion interference of contract lawsuit and George W. Bush was after that pipeline deal and September 11, 2001 was his excuse.)

Interrogatory 242: Were you aware at any time that the law firm of Mayer Brown, Rowe & Maw filed a Writ of Certiorari with the US Supreme Court attempting to reverse the September 9, 2003 decision of Fifth Circuit US Court of Appeals and it was denied on March 22, 2004, Case Number 03-1016, Turkmenneft v Bidas SAPIC? Richard ben Veniste was hand picked by Bush to sit on the 9-11 Commission.

Interrogatory 243: Have you been aware at any time that there are 2 Saudi owners of Delta Oil and one of them is Khalid bin Mahfouz, the brother-in-law of Osama bin Laden?

Interrogatory 244: Have you been aware at any time of the Delta-Hess (Cayman Islands) joint venture off the coast of Azerbaijan in the Caspian Sea, or that "Hess" is Amerada Hess and its former CEO Thomas Kean was handpicked by Bush to be the Chairman of the 9-11 Commission?

Interrogatory 245: Were you aware at any time that the jet engine components found at WTC in New York City are the combustion chambers for a Boeing 737 jet engine, not a Boeing 767 jet engine?

Interrogatory 246: Were you aware at any time that the jet engine and other components found at the Pentagon are from an A3 Skywarrior military jet, definitely not from any Boeing 757 ever built?

Interrogatory 247: During the Bush Administration, Robert Mueller was appointed FBI Director and Christopher R. Wray was elevated to Assistant Attorney General, Criminal Division at the Department of Justice. Exactly 1 week after September 11, 2001 on the date of September 18 were the anthrax attacks on three Democrat leaders in Congress. Specifically, Senator Patrick Leahy (D-VT), chairman of Senate Judiciary Committee, Senator Russ Feingold (D-MN), the only senator that voted against the Patriot Act, and Speaker of the House Tom Daschle (D-SD). Many were extremely ill and 5 dead, still unsolved murders due to Mueller's FBI.

Would it surprise you that the FBI were notified three times by telephone that the list of anthrax attack suspects was missing the key suspect name being DynPort Vaccines, LLC and neither the DoJ nor the FBI did anything about it? DynPort is an acquisition by the private security and mercenary company DynCorp of BioPort, the exclusive anthrax vaccine maker for the Department of Defense and had full access to the weaponized Ames strain of anthrax to even be able to try to develop vaccines to counteract?

The foregoing was revealed in detail in the book "One Way Ticket to Crawford Texas" in Chapter 5.

Interrogatory 248: During the Bush Administration, Robert Mueller was appointed FBI Director and Christopher R. Wray was elevated to Assistant Attorney General, Criminal Division at the Department of Justice. The FBI issued an urgent alert regarding "Saudi dirty bomb suspect Adnan G. El Shukrijumah".

Would it surprise you that when informed that their suspect, alleged dirty bomb suspect, is not Saudi, is son of a Yemeni father, Trinidad & Tobago mother, born in Guyana South America, entire family were residing in Miramar Florida for many years, and Adnan was a nuclear medical student at McMaster University, Hamilton Ontario which is a teaching and medical treatment pioneer in nuclear medicine?

What would be used for a "dirty bomb" is not the type of radioactive materials used in nuclear medicine.

The foregoing was revealed in detail in the book "One Way Ticket to Crawford Texas" in Chapter 7. Both the anthrax matter and the fake Saudi Dirty Bomb Suspect alert were outright terrorism by the FBI and Bush Administration against American citizens.

Interrogatory 249: Would it surprise you that even after defaming and slandering a person for the sole reason of Bush Administration terrorism of Americans, the FBI knew exactly where Adnan G. El Shukrijumah was and did not even bother to interview him?

The only words of truth posted on Wikipedia on this matter are what the Saudis and Adnan's mother had to say.

Interrogatory 250: If it could be proven in a Court of Law that the DoJ and FBI willfully ignored that DynPort Vaccines LLC had access to the Ames strain anthrax that had been weaponized, do you think it is proper for a President of the United States or the DoJ or FBI to be directly engaged in bioterrorism of US citizens and covering it up by willful failure to act to keep "selling the 9-11 Lie" to Americans and the rest of the world?

Interrogatory 251: If it could be proven in a Court of Law that the DoJ and FBI wrongfully initiated a nuclear dirty bomb scare and FBI Alert, then did not even bother to interview their alleged suspect when informed exactly where Adnan G. el Shukrijumah was living, do you think it is proper for a President of the United States or the DoJ or FBI to be directly engaged in fearmongering of US citizens and covering

it up by willful failure to act just to create chaos and obfuscations about what they did September 11, 2001 and why they did it?

Interrogatory 252: The Year of 1999 is going to prove to be pivotal in proving who really did September 11, 2001 and why they murdered US and foreign citizens to go rushing at Afghanistan for oil, natural gas, and pipeline right-of-way. The purported WTC security company was “Securacom” but was an intentional ruse and distraction.

First, the following is an excerpt from the Plaintiffs lawsuit:

“US District Court for the District of New Jersey - 984 F. Supp. 286 (D.N.J. 1997), November 21, 1997, 984 F. Supp. 286 (1997), SECURACOMM CONSULTING, INC., Plaintiff, v. SECURACOM INCORPORATED, KuwAm Corporation and Wirt D. Walker, III, Defendants/Third-Party Plaintiffs, v. Ronald S. LIBENGOOD, Third-Party Defendant. Civil Action No. 95-5393(DRD). United States District Court, D. New Jersey. Libengood was the founder of SecuraComm and should be shown as one of the Plaintiffs.

In the final order against the Defendant Securacom, where they named the real Plaintiff Ronald S. Libengood and owner of SecuraComm as plaintiff and a third-party defendant, the US District Court judge DEBEVOISE, Senior District Judge made the following opening statement in the original order.

“This action in one of its aspects is for trademark infringement and unfair competition brought under the Lanham Act and the statutes and common law of the State of New Jersey. In another disturbing aspect, this action is part of the ruthless abuse of the litigation process by an arrogant venture capitalist and his investment vehicle to prevent a trademark claimant from seeking to pursue his rights under his trademark. November 21, 1997.”

Second, as the foregoing nonsense was going on, the WTC security systems provider Stratesec already existed as a Delaware corporation years before they tried to put themselves forth as “Securacom” and was listed as a foreign corporation in multiple US states well before this SecuraComm v Securacom lawsuit.”

The real WTC security company was “Stratesec” of Delaware, registered as a foreign corporation in 16 US states The most important of which were Massachusetts (alleged origin of Flight 11 and Flight 175 regarding WTC 1 and WTC 2), Virginia (alleged origin of Flight 77 Pentagon), New Jersey (alleged origin of Flight 93 that allegedly crashed in Shanksville PA), Florida, Texas, and New Mexico, where thermitic research was done at the US government lab Los Alamos National Lab to bring down WTC 1,

WTC 2 and WTC 7. All Stratesec dates precede the use of the name “Securacom”. The Defendants in SecuraComm v Securacom kept this matter tied up from 1997 until 2000 with 2 appeals to Third Circuit US Court of Appeals in Philadelphia PA.

The “arrogant venture capitalist” mentioned by the Court above is Kuwaiti Mishaly S. Sabah of KuwAm Corporation (Delaware). His relative Nayirah al-Sabah lied to the Congressional Human Rights Caucus in 1990 to give George H W. Bush, the Senate and House the justification to attack Iraq in Desert Storm in 1991. Her testimony once investigated was deemed “modern atrocity propaganda” because she saw nothing in Kuwait City. She lived in the Washington DC area because her father was Kuwait Ambassador to the US, and spoke no truth with her testimony, yet did provide the gasoline and match for the United States to launch an illegal war of aggression targeting Iraq in 1991.

Stratesec also includes Bush relative Wirt Dexter Walker III and his brother Marvin P. Bush. There were matters uncovered in Florida that point the finger straight at Marvin P. Bush because an attorney in Florida lied in a deposition as to who controlled a certain entity and that lie was part of an Adversarial Proceeding in US Bankruptcy Court SDFL that the Chapter 7 Trustee prevailed on \$10,000,000. The entity named mentioned is controlled by Marvin P. Bush.

Second, Curt Weldon, former US House, Vice Chairman House Armed Services Committee and Chairman of a subcommittee overseeing a \$180 billion budget for defense research has revealed information in 2025. One of the research projects produced a powerful software program known as “Fusion” as of 1999. Everybody wanted it, except George Tenet’s CIA. Curt Weldon has also disclosed “Able Danger”, Lt Colonel Anthony “Tony” Schaeffer that was part of that program and what happened to him after he met Phillip Zelikow, Executive Director of the 9-11 Commission in Afghanistan and when he returned to the US his office was locked and all files had been confiscated. Lt Col Schaeffer wrote a book about “Able Danger” and the US Deep State purchased all 10,000 copies and destroyed them. He was allowed to write a “redacted” book by his commanding officer that deleted all references to Phillip Zelikow. Defendant Phillip Zelikow is the author of the Bush Pre-Emptive War Doctrine that does not change US criminal law but gave the presumptive Green Light for Bush to pursue regime change in 7 nations in 5 years until the Taliban and Iraqi insurgency stopped Bush dead in his tracks.

Third, the FBI both as field officers and counter terrorism detected an illegal CIA operation inside of the United States in 1998 and 1999. The CIA was using the excuse of hiding behind the Saudi GDI (General Directorate of Intelligence) to “recruit radical Islamic males” to “fly jets” but who they were trying to recruit had never flown a jet and most of them were even marginal drivers of an automobile. Once they knew they had been detected, the CIA stopped sharing crucial information with the FBI in 1999 and wanted no part of Fusion to protect America. The FBI deemed what they uncovered was a CIA false flag.

Fourth, author Karl Schwarz of “One Way Ticket to Crawford Texas” published in 2004, met two gentlemen that worked for Argentina Corporation Bidas Corporation. It was not a scheduled meeting, merely just by chance event at a conference that all 3 men were at. The two Bidas Corporation employees related in detail what they had accomplished in Turkmenistan, Afghanistan and Pakistan, were faced with major interference during the Clinton Administration, Unocal, Saudi owned Delta Oil, et al, and why all of that had led to a \$15 billion interference of contract lawsuit in Texas State Court in Fort Bend TX as Bidas v Unocal, Delta Oil, et al. In short, even before September 11, 2001, Schwarz was watching both news in the Caspian Basin region and the lawsuit in Texas since before September 11, 2001.

Were you aware at any time of the foregoing facts before you just read the above?

Interrogatory 253: Are you “read in” on a classified document designated as “AE827”?

Interrogatory 254: From 2016 to 2021 former DEA Donald C. Canestraro was commissioned by Military Commissions to interview the FBI and CIA people who had touch points on Osama bin Laden Station, September 11, 2001 and what they knew before and after September 11, 2001. The classified AE827 is probably available from Military Commissions or the DoD. At the bottom of each page of the Canestraro Declaration it is stated “Not Classified unless attached to AE827” and shows an acronym “CUI”.

Have you ever heard of or seen the Canestraro Declaration, 774 lines each numbered and FBI Confidential Sources are labeled as CS-1, CS-2, etc. and CIA confidential sources are labeled like HHH, VVV, WWW, etc. to protect their identities? There is no mention of the matter that he could not interview the longest serving person of UBL Station since she was killed in the bombing in Khost Afghanistan in 2009.

Interrogatory 255: If the document designated “AE827” is classified, will you as President of the United States declassify that document for the Plaintiffs in this lawsuit to facilitate justice being done?

Interrogatory 256: What is clearly mentioned is CS-3 was fired by Phillip Zelikow from the back office of the 9-11 Commission because she was trying to get the truth before the 10 handpicked members on 9-11 Commission. That is completely consistent with the issues in the Plaintiff’s lawsuit. She was an FBI counter terrorism expert and Zelikow was absolutely not going to allow any truth to be on the record in the 9-11 Commission report, much like happened in the John F. Kennedy assassination and The Warren Commission Report that was a total whitewash and coverup.

Do you personally think Phillip Zelikow is a traitor and should be charged as such? He is a defendant in this lawsuit and cited for multiple Predicate Acts under RICO with civil remedy.

Interrogatory 257: Most thinking and knowledgeable Americans and peoples in foreign nations have clearly seen for almost 3 decades that those in the US that are Neocons have been an aberration, an abomination, and a complete catastrophe disaster for US foreign policy, US war policy and world peace.

The Plaintiffs trust that you are aware that George W. Bush created Project BioShield in 2003 with the goal of force vaccinating 10,000,000 First Responders and then every American. He also tripled the number of US labs doing extremely risky biological research under the pretense of counterterrorism and handed over control of such labs to Battelle Corporation who did the Human Genome Project at ORNL, Oak Ridge National Lab. Additionally, he created BARDA and a new #2 position at DHHS that is a military person with preemptive authority in emergency situations to take over health care in the United States as the Assistant Secretary for Preparedness & Response. Additionally the Obama – Biden Administration put an illegal bioweapon lab Tblisi Georgia and many illegal bioweapon labs in Ukraine near Russia Federation borders, The same was done regarding Africa, South America, and China and all hidden on the Pentagon budget.

On the same day Putin took military action in Ukraine, one of the primary objectives for Russian airborne troops was to seize all Ukraine bioweapon labs, collect evidence and then safely destroy them and their deadly contents. Also, on that same day the Ukraine military HQ and the Ukraine SBU issued an order to destroy all records of Ukraine collaborating with two US companies MetaBiota and Battelle. The largest shareholder of MetaBiota is or was Hunter Biden. The Plaintiffs have a copy of that order.

This is a 2000 PNAC Neocon recommendation for American leadership in their manifesto “Rebuilding America’s Defenses”.

*"In September 2000 PNAC released "Rebuilding America's Defenses" a report that promotes "the belief that America should seek to preserve and extend its position of global leadership by maintaining the preeminence of U.S. military forces". The report states, "**advanced forms of biological warfare that can 'target' specific genotypes may transform biological warfare from the realm of terror to a politically useful tool**". See Exhibit G."*

Does that read like a nation that is great because she is good or more of a statement that America is now as low as any terrorist on Earth? The foregoing is exactly what the Deep State is working on and it is nothing short of evil. If these Neocon and Deep State idiots launch something like this at Russia, the US will be showered with nuclear weapons into oblivion.

Interrogatory 258: Two men barely survived WTC 1 North Tower. Janitor William Rodriquez and Filipe David of Bolivia.

Have you been aware at any time that William Rodriquez has publicly stated that the first bomb that was detonated in WTC 1 North Tower was on below ground level B3 and it took out the freight elevators?

Interrogatory 259: Have you been aware at any time that bomb blast seriously injured Filipe David who had to be taken by EMS ambulance, with Rodriquez assisting him to get out of the building, and was in a coma for 13 weeks?

Interrogatory 260: Have you been aware at any time that the bomb blast occurred even before the first jet hit WTC 1 North Tower?

Interrogatory 261: Referring back to the opening Interrogatory 1. America has been in a steady decline ever since George H W Bush went from CIA Director, to Vice President in Reagan Administration, arms and drug trafficking in Iran Contra, to President and unto this day in 2025. There has been constant decline through George H W Bush, Bill Clinton, Bush-Cheney, Barrack Obama, Trump-Pence, and then the Biden Administration that foreigners see quite clearly what the USA has devolved into due to people serving in multiple levels of offices in Washington DC that do not have the best interests of Americans or the United States of America as a core principle in their head or heart. Apparently the true sentiment of Washington DC is they despise certain cultures, nations and ethnic groups that do not live in America and have no desire to.

Does anyone in Washington DC have the courage to admit that America is no longer a great nation because America is no longer a good nation and that is because Washington DC and the Deep State are greedy, manipulative, abusive and rotten to their core monsters?

Interrogatory 262: Do the foregoing interrogatories pretty well sum up why the Bush-Cheney Administration lied, stalled and created obstacles to avoid facing the truth about September 11, 2001?
