

Truth Action Project and Karl Schwarz

Chronology – This chronology does not address the ludicrous NIST analyses. That will be addressed in court ordered discovery.

1969: Congress passes the National Environmental Protection Act, NEPA. Affects both EPA and OSHA regarding hazardous materials in homes, offices, workplaces, etc. including asbestos and calling for remediation, proper disposal, curb illegal dumping, etc.

1971: Construction of World Trade Center Twin Towers is brought to immediate halt when NEPA is implemented in all 50 US states. The PANY&NJ were using asbestos as fire protection on the WTC 1 and WTC 2 Twin Towers. Price tag of \$1 billion had they addressed the asbestos problem in 1971.

1971 Spring: Karl W. B. Schwarz is in second year architecture – engineering school at the then #3 ranked school in USA. The recruiter and mentor that convinced Schwarz of his architectural and engineering skills at only age 17 was a Frank Lloyd Wright protégé at Taliesin West, a practicing architect and Dean of School of Architecture, University of Arkansas. Entire structural steel design class had to replicate the calculations as to how the entire loads of the WTC Twin Towers were carried by the center core superstructure. The exterior walls were not structural load bearing walls. They were suspended from the top and all loads transferred to the center core superstructure. Thicknesses of steel exceeded what a bomb could destroy, another method was used so the bombs could dismember the WTC towers WTC 1, 2 and 7. That other method is thermitic reaction to weaken the steel, so the bombs could dismember colossal steel structural members.

1981-1985: Schwarz and affiliates at what was then called Prudential Bache Capital Markets plus DCM Corporation were heavily involved during Reagan Admin to get the 21% US Prime rate down 600-700 basis points, 14% to 15% interest rate with a huge 3 nation deal that used US Treasury bonds yielding at the time 11% to 14% and the other 2 nations had 7.0% and 7.25% interest rates.

1987: **PANY&NJ v Allied Corp** filed in New Jersey Superior Court, Law Division regarding asbestos liability in WTC. PANY&NJ lost.

1990-1996: Karl Schwarz office of Schwarz Investment Group, LLC (Virginia) was a direct affiliate of Smith Barney and an outside strategic planner for the RNC Treasurer William McManus. Part of the 1994-1996 assignment was identify all Neocons and their support network. Over 3,800 names are on a PDF, some now deceased, others still wreaking havoc and undue influence in NYC and DC.

1989-1990: George H W Bush Admin concocts a military plan to invade the USSR “steppes region” being Kazakhstan, Uzbekistan, Turkmenistan and the other “stans”.

1990, October 10: False Nayirah testimony to Congressional Human Rights Caucus. Her testimony is later investigated and deemed “**modern atrocity propaganda**” because she willfully lied to launch an illegal war of aggression. She was teenage daughter of Kuwait Ambassador to US and did not see anything in Kuwait City she tearfully told the Congressional Caucus.

1991 March 18: TIME magazine article by George J. Church, March 18, 1991 12:00 AM EST revealed “**USSR: Operation Steppe Shield**”, GHWB Admin plan to invade the USSR to take over the “Steppes”. Colossal amounts of oil and natural gas in those “Steppes”. Problem is that the Steppes

are a landlocked region and USA was not welcome to unlock it after what it did during the Russia – Afghan War 1980-1988.

1991: “Desert Shield” is converted to Desert Storm based on false Nayirah al-Sabah testimony. The real dispute was Kuwait and US oil companies had stolen billions of oil from the Iraq Basra oil fields with directional drilling. US Ambassador to Iraq told Saddam Hussein the US had “no interest in an Arab-Arab dispute” without confessing the US oil companies and Kuwaitis were thieves and started the dispute. In 2004 after Schwarz book came out, a US Special Forces soldier contacted Schwarz, told what happened months before Saddam invaded Kuwait with black ops. Pentagon sources were able to verify to Schwarz, the special forces soldier by name and the black ops by name really happened to create an illegal war by George H W Bush.

1991: There was an unexplained pause before launching Desert Storm. The US government, White House and Pentagon did not admit that an entire aircraft carrier attack group had to return to port in Norfolk VA because the crews and pilots came down with “mystery arthritis” due to Pentagon vaccines for smallpox and anthrax and much of the crews were unable to perform their jobs in the fleet. Desert Storm could not continue until a new aircraft carrier attack force arrived.

1991: After losing PANY&NJ v Allied Corporation lawsuit, a \$6 billion lawsuit is filed in US District Court Newark NJ as **PANY&NJ, Trans-Hudson Corporation v Affiliated FM Insurance, et al** seeking \$6 billion USD from the WTC insurers to remediate asbestos in WTC of approximately \$4.5 billion and balance for same asbestos issues in the three area airports Kennedy, LaGuardia and Newark.

Part of this lawsuit was seeking reimbursement for work done in the highest 10 floors of office space of WTC 1, North Tower. That asbestos removal work was done by LVI Services, now owned by 9-11 Commission member “John F. Lehman & Company”. Those 10 floors were where the first alleged hijacked jet (American Airlines Flight 11) hit the offices of Cantor Fitzgerald, Marsh McLennan, Mitsui Bank and Nishi Nippon Bank of Japan. Only survivors of Cantor were CEO Howard Lutnick, now US Commerce Secretary and his sister Edie Lutnick a corporate attorney. Neither were at work that day, but their brother Gary Lutnick died September 11, 2001.

There were only 1 Marsh McLennan survivor and 1 software specialist who blew the whistle on Marsh months before September 11, 2001. L. Paul Bremer, who was first on US TV (MSNBC) pointing finger of blame at Osama bin Laden and Afghanistan. The other is a Marsh McLennan whistleblower Richard Andrew Grove, the software company he worked for was doing a major install at Marsh. Grove saw massive money laundering related to September 11, 2001. There was a meeting 8am September 11, 2001 with this whistleblower, Marsh IT people and a high-level executive. They are all dead, except the whistleblower who was late for the meeting and survived. It is what he saw in the WTC area that is as important. Government vehicles that were not doing anything to help as First Responders.

1992 January: Bidas Corporation of Argentina signs contract with Turkmenistan. Gas exploration rights for Yashlar block in eastern Turkmenistan awarded to Argentine firm; Bidas Corporation, Bidas SAPIC, et al. Production profits to be split 50-50 between Bidas and Turkmenistan government.

1993 February 10: Bidas awarded Keimir Oil and Gas Block in western Turkmenistan. 75-25 split in profits, in favor of Bidas.

1993 February 26: WTC 1 is bombed, did not collapse or damage the core superstructure at all. FBI is implicated as directly involved during the trial as “FBI handlers” of the man recruiting the “radical Islamic bomber”.

1993, July: Clinton fires FBI Director William Sessions because he had initiated an internal investigation in FBI as to who aided and abetted that bombing.

1993: Louis Freeh replaces Sessions as FBI Director, Oklahoma City bombing, Waco and Rudy Ridge follow during his tenure. The remainder of FBI Director Freeh and AG Janet Reno were marred by one scandal after another.

1994: At some point in 1994 the PANY&NJ eliminates Otis Elevator and hires ACE Elevator purportedly to undertake a huge renovation of the 99 elevators in WTC 1, 99 elevators in WTC 2, 198 total elevators and lifts in the Twin Towers. ACE was onsite from 1994 to September 11, 2001. The only way to get at the structural core superstructure of the WTC 1 and 2 towers is the elevator shafts.

ACE had 80 employees onsite 9-11, people trapped in elevators when the fire alarms automatically shut down all elevators to 110th in WTC 1 and same when the 78th level and 110th level elevators were disabled on WTC 2. The ACE employees just left, did not help anyone. See September 11, 2001 and 2006.

1994: The real WTC security company was registered in 16 states while hiding behind the name Securacom New Jersey as the WTC security company. One of those 16 states was a US government lab where thermitic research was being done to destroy the World Trade Center.

1994 November: Clinton loses both House and Senate in the midterm elections. Joe Biden was the architect of The Patriot Act, even bragged about it later but could not get it passed into law. AG Janet Reno had team in DoJ assisting the drafting of The Patriot Act, during the Clinton Administration. There was a coup d’ etat in the highest echelons of the RNC aided and abetted by former RNC Chairman Haley Barbour and his executive assistant Scott Reed. Schwarz office was in DC 1990-1996.

1995: Bidas Corporation meets Taliban for first time to commence negotiations.

1995: Unocal and US Government attempting to pressure Taliban to abandon contract negotiations with Bidas and pressure Turkmenistan regarding Bidas contracts. Not mentioned by name yet Afghan born Zalmay Khalilzad, US State Dept and CIA were involved. Former US State Department, probably CIA, was lobbying for Unocal as Bidas contract rights were under assault by the US government and corporate interests desiring control of trillions of dollars of oil and natural gas.

1995 October: President Niyazov (Turkmenistan) signs agreement in New York with Unocal/Delta Oil, (Saudi investors). Turkmenistan starts jerking Bidas around on its Oil Contracts with that government.

1995: The US District Court SDNY ruled against the plaintiffs PANY&NJ v Allied Corp, et al again more along the lines of “construction defects”. Decision Date: 29 March 1995; Docket Number No. 91 Civ. 0310.,91 Civ. 0310; Citation 914 F. Supp. 960, Parties: **PORT AUTHORITY OF NEW YORK AND NEW JERSEY, et ano., Plaintiffs, v. ALLIED CORPORATION, et al., Defendants.** Court: U.S. District Court — Southern District of New York.

This lawsuit was a totally different approach to get money to save the WTC but failed. I will explain why on the Zoom call.

1995: FBI Counterterrorism expert John Patrick O'Neill started his own investigation inside the FBI as to who aided and abetted the February 26, 1993 bombing of WTC 1 North Tower. It clearly came out in the trial that the FBI had an "asset" who was both recruiting the "terrorist bomber" and was recording his conversations with his FBI handlers. Evidently the "asset" had grown to not trust the FBI as to why they wanted to blow up WTC 1 North Tower. **See August and September 2001.**

1995: Bibi Netanyahu wrote a book in 1995 warning the US if they did not get their heads focused on "militant Islam they would attack the World Trade Center". Bibi was spinning this yarn to Glenn Beck when Israel turned "60" in 2008. The FBI had already assisted "Militant Islam" on February 26, 1993, and that fact was revealed in the trial.

Remember to ask me about terse 1995 meeting I had with Newt Gingrich, new Speaker of the House, and Majority Whip Dick Armey of Texas after they announced their "Contract with America".

1996, January: Bidas signs agreement with Taliban and General Rashid Dostum for Trans-Afghanistan pipeline. Dostum is an Uzbek holdover after the USSR-Afghan War 1980-1988.

1996 February: **Bridas v. Unocal, Delta Oil, et al**, \$15.0 billion interference of contract lawsuit filed in Texas State Court, 268th District Court, Fort Bend County, Texas, Trial Court Cause No. 94,144. Dismissed, Bidas appealed and lost, re-filed as \$495,000,000 arbitration claim. Remember "Delta Oil, Saudi". This lawsuit reveals tortious interference of contract in both Turkmenistan and Afghanistan, unnamed was US government itself during Clinton Administration. [emphasis added]. At about the same time as this lawsuit was filed in Texas, Unocal tried to file in Turkmenistan for a declaratory ruling in their favor and failed.

1996 March: U.S. Ambassador to Pakistan, Tom Winston Simons, urges Bhutto to give exclusive rights to Unocal. Bhutto offended and demands apology. Clinton Admin interference that apparently involved Zalmay Khalilzad lobbying for Unocal and US. Khalilzad was nicknamed "The Butcher of Bosnia" for his work leading up to US-NATO bombing of Serbia in 1999.

1996 July 17: **We are not disclosing this one except in lawsuit, discovery and trial. There are lots of additional key dates not disclosed in this document and all point at WHO DID SEPTEMBER 11, 2001.**

1997 June 3: PNAC issues their "Statement of Principles" letter to President Clinton. Few paid close enough attention that Jeb Bush was one of the signatories of this warmongering message to President Bill Clinton. Of the twenty-five people who signed PNAC's founding statement of principles, ten went on to serve in the administration of U.S. President George W. Bush, including Dick Cheney, Donald Rumsfeld, and Paul Wolfowitz.

1997 November: Unocal tries to woo Taliban away from Bidas and are rejected by Taliban. (Delta, Saudi). Probably Afghan-born Zalmay Khalilzad involved to lobby for Unocal since he sold out Afghanistan many decades ago. Saudi owned Delta Oil, co-owner Khalid bin Mahfouz is Osama bin Laden's brother-in-law, were offering Taliban \$100,000,000 per year to let Unocal and them own and control the pipeline that Bush came into office fully intent on stealing with military force. Daddy's "Operation Steppe Shield".

1997 November: The World Trade Center security company was supposedly Burns & Rowe Securacom, then Securacom. Suddenly sued by SecuraComm Consulting of Pittsburgh PA for copyright and trademark infringement. **SecuraComm v Securacom** was lost by the New Jersey firm and the US District Court judge in Newark NJ opened his Final Order remarks with:

“This action in one of its aspects is for trademark infringement and unfair competition brought under the Lanham Act and the statutes and common law of the State of New Jersey. In another disturbing aspect, this action is part of the ruthless abuse of the litigation process by an arrogant venture capitalist and his investment vehicle to prevent a trademark claimant from seeking to pursue his rights under his trademark. November 21, 1997.”

The judge was referring to Mishaly Sabah of KuwAm Corporation. The Bush Family and Sabah Family have been buddies, all the way back to the colossal BCCI scandal and drug money laundering and Desert Shield 1990 and Desert Storm 1991.

1997 November 21 US District Court for the District of New Jersey - 984 F. Supp. 286 (D.N.J. 1997), November 21, 1997, 984 F. Supp. 286 (1997), SECURACOMM CONSULTING, INC., Plaintiff, v. SECURACOM INCORPORATED, KuwAm Corporation and Wirt D. Walker, III, Defendants/Third-Party Plaintiffs, v. Ronald S. LIBENGOOD, Third-Party Defendant. Civil Action No. 95-5393(DRD). United States District Court, D. New Jersey. Libengood was the founder of SecuraComm and should be shown as one of the Plaintiffs.

Wirt Dexter Walker III is a Bush relative. KuwAm Corporation is Mishaly Sabah, a relative of Nayirah al-Sabah who lied to the Congressional Human Rights Caucus to justify Desert Shield 1990 and assault Iraq with Desert Storm in 1991 to cover up US and Kuwait theft of Iraqi oil. This was after the US, specifically Donald Rumsfeld, armed Saddam Hussein with WMD chemical weapons for use against Iran in that war that ran from 1980-1988 during the Reagan – Bush Admin.

1997 December: Stratesec IPO. Stratesec had already existing in Delaware as corporation and filed another for the IPO. Stratesec predates Securacom and use of that name by years, including all of the 16 foreign corporations they filed in 16 other US states. The key states Stratesec was registered as Foreign Corporation are New York (WTC), New Jersey (Flight 93), Virginia (Flight 77), Florida (major money laundering), Washington (Boeing), New Mexico (LANL) and Texas.

1997: The entire CIA Alec Station and global spying apparatus cannot find Osama bin Laden, but Peter Arnett of CNN did. Is CIA an intel agency or practicing “Where’s Waldo?” game skill?

1997-1998: After Bridas had been derailed by US interference, Zalmay Khalilzad and others were arming Muslims to kill Christians, so Clinton would have an excuse with NATO to bomb Serbia in 1999 under the pretense of “saving Christians”. That is how Zalmay Khalilzad got the label “the Butcher of Bosnia”. That has now been historically revised “Wikipedia style” to name a Serbian general who was never cited by the ICC for war crimes after President Slobodan Milosevic was posthumously found to be innocent by the ICC in 2006.

1998: Securacom appealed the November 1997 order to Third Circuit US Court of Appeals and lost in 1998. They appealed a second time and lost in 2000.

First appeal to Third Circuit by defendant Securacom. Argued on June 26, 1998. Opinion Filed: **January 20, 1999**. Amended February 8, 1999. On Appeal from the United States District Court for the District of New Jersey, (D.C. Civil No. 95-cv-05393) (Senior District Judge: Honorable Dickinson R. Debevoise), See *SecuraComm Consulting Inc. v. Securacom Inc.*, 166 F.3d 182 (3d Cir. 1999) ("SecuraComm Consulting I"), No. 99-5326. Argued: February 8, 2000. Filed **August 21, 2000**. Second appeal to Third Circuit by defendant Securacom. After the remand in 1999, the Defendants appealed again and kept the matter tied up in court until 2000 as indicated above and what follows below. On Appeal from the United States District Court for the District of New Jersey District Judge: Honorable Dickinson R. Debevoise (D.C. No. 95-cv-05393) (D.C. Civil No. 95-5393) (D.C. Civil No. 96-3247); SLOVITER, Circuit Judge.

"This appeal marks the second time the remedial portion of this trademark case has come before us. In the first appeal, defendants Securacom Incorporated, KuwAm Corporation, and Wirt D. Walker, III (collectively "Securacom New Jersey") sought reversal of the District Court's award of profits, treble damages, and attorney's fees after the court found that Securacom New Jersey had willfully infringed the trademark of SecuraComm Consulting, Inc. We reversed the award of profits and treble damages on the ground that the record did not support a finding of willful infringement and remanded as to the award of attorney's fees. See *SecuraComm Consulting Inc. v. Securacom Inc.*, 166 F.3d 182 (3d Cir. 1999) ("SecuraComm Consulting I").

On remand, the District Court again awarded attorney's fees and denied Securacom New Jersey's motion for the judge's recusal."

1998: George W. Bush is hand picked by George Schultz, former Secretary of State Reagan Admin (Daddy Bush VP days and Iran Contra), then CEO of Bechtel Corporation, Condoleezza Rice and others to run for POTUS in 2000. That is not consistent with Bush statements in 2000 when he announced and why. **See April 11, 2003.**

June 10, 1998: Ted Kopple reporting John Miller of ABC news finds and interviews Osama bin Laden. CIA still playing "Where's Waldo". <https://www.youtube.com/watch?v=uazIg7PwixI>

Years later as a "CNN Expert" John Miller and Kaitlin Collins are concerned about TikTok trending with sympathy for Osama bin Laden. <https://edition.cnn.com/videos/us/2023/11/17/osama-bin-laden-tiktok-trend-sot-miller-src-vpx.cnn> The FBI never added bin Laden for the USS Cole bombing or September 11, 2001 due to no evidence he was involved in either.

1998 August: Clinton launched cruise missiles at Afghanistan. Hitting Al Qaeda or "warning shots" to bust up that Bidas contract? Zalmay Khalilzad involved in Bosnia and Afghanistan 2001-2002, later Iraq 2003 as Bush appointed Special Envoy post US invasions.

1999 Jan 20: Securacom New Jersey loses first appeal to Third Circuit.

1999: FBI Counterterrorism unit detects illegal CIA – Saudi GDI operation in US aimed at "radical Islamic male pilots to attack US with hijacked jets".

1999: CIA stops sharing crucial information with FBI.

1999: Curt Weldon, DIA, Able Danger, Fusion meta data software / analysis system ready to go. Everyone wanted it but... the CIA. (Chapter 8 of the Schwarz book is "Planting Weeds in America's Rose Garden". CIA did not want Fusion because they had planted the exact weeds they wanted FBI Counterterrorism and DIA to find.) Then the CIA cut off everyone as the final

countdown on WTC and attacking Afghanistan had started. CIA operations started in Afghanistan in 2000.

When Curt Weldon ever gets up the nerve to talk to me, I will tell him about our “Hunt for Osama bin Laden” software that totally FREAKED OUT CENTCOM HQ in Tampa to the point a general in the room ordered everyone else: Disregard what you just saw. That is an order!!!” And had us kicked out of CENTCOM. The software and algorithms were not developed for bin Laden, they were a nanotechnology research tool that had a stunning capability in “search”. The algorithms were written by two geniuses formerly with JPL.

1999: Jeddah Saudi Arabia US Consulate office reports CIA for pushing thru visas for “radical Islamic males” or males that were rejected on visas to USA, overruled by CIA. After September 11, 2001 this matter was reported from a former consulate officer directly involved in Jeddah.

1999 June 25: The International Chamber of Commerce (ICC) issues a partial award in arbitration matter in favor of Bridas S.A.P.I.C., et al, v. Government of Turkmenistan and Turkmenneft, ICC Case No 9058/FMS/KGA Case type: Contract Applicable arbitration rules: Law firm of Mayer Brown, of which senior partner Richard ben Veniste is handpicked by Bush to sit on the 9-11 Commission, rushes to US District Court SD Texas Houston to vacate the award.

1999-2000: After the US District Court in Houston attempted to vacate the ICC award of \$495,000,000 the case was appealed to Fifth Circuit, US Court of Appeals in New Orleans.

1999 November: Karl Schwarz meets 2 men from Bridas Corporation and is provided details of what was going on in Turkmenistan, Afghanistan, Pakistan against Bridas and the Texas lawsuit and appeal of Bridas v Unocal, Delta Oil, et al and the ICC arbitration award. Schwarz started watching closely what was going on in Caspian Basin region and Texas courts on this \$15 billion interference of contract lawsuit. The Texas court dismissed the 1996 lawsuit in 1998, Bridas appealed to Texas State Court of Appeals and lost in 2000.

2000: George W, Bush announces his bid for President claiming he is concerned about weak Clinton foreign policy leadership exposing USA, its citizens and allies to “terrorist threat aimed at the United States”.

2000 August 21: Securacom lost second and final time at Third Circuit, US Court of Appeals in Philadelphia. PANY&NJ was based in NYC, WTC 1 North Tower. Third Circuit does not cover US Courts in New York.

2000 March: Austrian art group named “Gelatin” starts a project on upper levels of WTC named “B Thing”. To undertake large controlled demolitions such as WTC 1, WTC 2 and WTC 7 very powerful explosives are used, specifically RDX, HMX or “Gelatin”. However, due to the structural design and sheer thicknesses of steel even those explosives would not work until the metal had been softened by high heat, so the explosives could dismember colossal columns and beams.

2000 Spring: Richard Clarke is strongly suggesting that US commandos be inserted into Afghanistan and hunt down Osama bin Laden. The use of drones continued. Presumably Richard Clarke is sort of upset that CNN and ABC news can find Osama bin Laden, but the CIA cannot. A person really must ponder that CIA glitch and “failure to perform”.

2000 Summer: CIA in secret talks with Uzbekistan to operate the drones from that nation that are purportedly hunting for Osama bin Laden. Uzbekistan refused to cooperate.

2000: Marvin P. Bush is brother of George W. Bush. He was on the board of directors of Houston Casualty Company, HCC. That name does not appear as defendant in PANY&NJ, Trans-Hudson Corporation v Affiliated FM Insurance, et al. HCC issued a public statement that they took a \$30 million loss due to September 11, 2001. Marvin P. Bush and Mishaly Sabah of KuwAm Corporation were also directly involved in Stratesec, Delaware corporation, the World Trade Center security company and 16 foreign corporation registrations in key states in the US that point back to WTC and September 11, 2001.

2000 Summer: CIA was already in Afghanistan hunting for Osama bin Laden and he was not even there, yet CNN and ABC did find him. See 2025 disclosures by Curt Weldon, former Vice Chairman of House Armed Services.

2000 September 1: PNAC issues their second manifesto regarding "Rebuilding America's Defenses for Supremacy in the 21st Century". Within that manifesto is this statement, written probably by a PNAC person that is a tranny male:

"PNAC's first public act was to release a "Statement of Principles" on June 3, 1997. The statement had 25 signers, including project members and outside supporters (see Signatories to Statement of Principles above in list of PNAC Defendants and Appendix A). It described the United States as the "world's pre-eminent power", and said that the nation faced a challenge to "shape a new century favorable to American principles and interests". To this goal, the statement's signers called for significant increases in defense spending, and for the promotion of "political and economic freedom abroad". It said the United States should strengthen ties with its democratic allies, "challenge regimes hostile to our interests and values", and preserve and extend "an international order friendly to our security, our prosperity, and our principles". Calling for a "Reaganite" policy of "military strength and moral clarity", it concluded that PNAC's principles were necessary "if the United States is to build on the successes of this past century and to ensure our security and our greatness in the next".

*In September 2000 PNAC released "Rebuilding America's Defenses" a report that promotes "the belief that America should seek to preserve and extend its position of global leadership by maintaining the preeminence of U.S. military forces". The report states, "**advanced forms of biological warfare that can 'target' specific genotypes may transform biological warfare from the realm of terror to a politically useful tool**". See Exhibit G. SEE SOTU ADDRESS 2003.*

2000 September: CIA has a new toy. They can operate drones over Afghanistan from an operations center in Northern Virginia.

2000 October: Washington DC abruptly ends the CIA drones over Afghanistan program. That was an odd move since CIA and US government are supposedly Hunting for Osama bin Laden.

2000 October 11: CIA issues a warning that attacks on US interests and Jewish tourists in the Middle East region were imminent 1 day before the USS Cole was attacked and bombed and highlighted "the growing threat of the Taliban". Just 1 week after CIA shut down using their new toy, Osama bin Laden is blamed for the USS Cole bombing. Internal US reports indicated that neither FBI nor CIA had any evidence of Osama bin Laden being involved in the USS Cole bombing. The FBI Top 10 Most Wanted list does not mention OBL for the USS Cole bombing or September 11, 2001. Rex Tomb of the FBI was questioned and indicated the bureau had no evidence OBL was involved in the USS Cole bombing or September 11, 2001.

2000, October 24: Pentagon holds "Mass Casualty Drill" of commercial jet hitting the Pentagon. Their second request in April 2001 to do such a drill again was rejected as "too unrealistic".

2001 January 20: Bush Cheney sworn into office after the “chad cliffhanger” in Florida and SCOTUS declares Bush the winner. Majority opinion and Per Curiam Order written by Reagan appointee Associate Justice Sandra Day O’Connor. (Her name surfaces again after she retired as Associate Justice from SCOTUS and was sitting “by designation” on a crucial appeal that involves money laundering, the real WTC security company and September 11, 2001.)

2001 March: Former President of Yugoslavia and Serbia Slobodan Milosevic is arrested by UNMIK and Serbia authorities and handed over to the ICC to face multiple charges of genocide and crimes against humanity. Milosevic was detained in prison awaiting trial until his death March 11, 2006. Posthumously he was found innocent because it was not him slaughtering Christians. It was Bosniak Muslims armed by CIA, the Butcher of Bosnia Zalmay Khalilzad after his anti-Bridas Corporation gig with Unocal and Delta Oil in Turkmenistan and Afghanistan had blocked Bridas and the TAP Trans-Afghanistan Pipeline.

2001 Spring: 10th Mountain Division is activated for invasion of Afghanistan.

2001 Spring: CENTCOM commanding General Tommy Franks is asked before a Congress Armed Services Committee what his primary mission is in Afghanistan. When he responded: **“the pipeline and access to the regions resources”**, Secretary of Defense interrupted that the mission was terrorists and Osama bin Laden.

2001 April: Pentagon email reveals their concern about a hijacked jet being used to attack the Pentagon, but deemed “too unrealistic”. Later Bush feigns no one in his administration could have envisioned commercial jets used to attack American freedoms and targets.

2001 May 9: Bush nominates Texas Supreme Court judge Priscilla Owen to Fifth Circuit US Court of Appeals where the Bridas Corporation, Bridas SAPIC appeal was pending. Senator Patrick Leahy (D-VT), Chairman of Senate Judiciary Committee intentionally delayed her first confirmation hearing until after Bridas Corporation prevailed at Fifth Circuit, US Court of Appeals on September 9, 2003. You will see what Bush Admin did on September 18, 2001 below.

2001 May 17: PANY&NJ loses the \$6 billion asbestos lawsuit on May 17, 2001. What is notable about this lawsuit is PANY&NJ used in-house counsel rather than hiring experienced litigators in such a lawsuit. After the loss, PANY&NJ appealed the decision to Third Circuit, US Court of Appeals in Philadelphia. In the Final Order the judge noted that the PANY&NJ knew about the asbestos problems long before the 1987 lawsuit they filed PANY&NJ v Allied Corp in New Jersey Superior Court.

2001 May 28: We are saving this one for court.

2001 June 1-2: NORAD runs Amalgam Virgo 01 drill of hijacked commercial jets orchestrated by OSAMA bin LADEN and using drone technology and cruise missiles. Was first reported by Arizona radio show host William “Bill” Cooper, not by Alex Jones.

2001 June: Rumsfeld removes one of the rules of engagement for hijacked or enemy jets entering US airspace that is aggressive and in the face. Along the lines: “Follow our instructions and land or we will shoot you down”. The only remaining ROE (rules of engagement) was “follow and watch before intervening with force”.

Late May, June, July 2001: Arizona radio show host William “Bill” Cooper is openly discussing illegal CIA operation inside the USA regarding “radical Islamic males, attack US with hijacked jets” plus

modifications at a Colorado airport for military and commercial jets to function as UAV like a cruise missile. Cooper was a former military intelligence officer.

July 2001: Software specialist Richard Andrew Grove is collaborating with Marsh McLennan IT on install of a powerful new software system named LightStream. Blows the whistle on Marsh McLennan for money laundering related to September 11, 2001.

2001 July 24: PANY&NJ signs 99-Year Lease with Larry Silverstein and Australian real estate developer Frank Lowy, who lives in Israel. Who signed off on the deal for PANY&NJ was Lewis M. Eisenberg, New Jersey, Jewish, Chairman and was appointed in 1995 by then Governor of New Jersey Christine Todd Whitman. (Whitman appointee 1994, elected PANY&NJ Chairman 1995.)

2001 August 2: Bush renews negotiations with the Taliban about the Bidas pipeline from Ashgabat Turkmenistan, thru Afghanistan and Balochistan Province Pakistan to the Arabian Sea port city of Gwadar. Actually, Bush was threatening, yield to US demands or attack is coming.

2001 August 6: Bush ignores the PDB (Presidential Daily Briefing) warning of “radical Islamic males to attack US targets with hijacked jets”.

2001 August: FBI head of counterterrorism gets fed up with being stalled inside the FBI and departs the Bureau. Another False WTC Security company Kroll Associates hires John Patrick O’Neill to be head of WTC Security effective September 10, 2001. Then feigns that no one in the US government could have envisioned such an attack by commercial jets on WTC and Pentagon.

2001 August: For some reason the Bush Admin notifies India, Pakistan and Iraq about the impending invasion of Afghanistan, but not the citizens of the United States of America.

2001: China and Pakistan are in direct negotiations for CPEC, China Pakistan Economic Corridor that is part of the China Belt & Road Initiative that includes land routes and ocean ports for maritime routes.

2001: Weeks and days before September 11, 2001 almost 5,000 put options were taken out on American Airlines and United Airlines. One of the names the SEC detected and referred to the FBI and DoJ was “Wirt Dexter Walker III”, a Bush family member and relative, and part of WTC security company Stratesec and before that the Fake ID Securacom lawsuit and 2 appeals. No action taken. On American Airlines and United Airlines see below September 6 and September 10.

2001 Sept 4: Robert Mueller becomes FBI Director. Just as important was the top national security advisors to George W. Bush endorsed his grand vision of eliminating Al Qaeda because Bush did not want to “swat flies one at a time”. That was Condoleezza Rice’s recollection and statement in an interview. This was the first National Security Directive of the Bush Administration, which was exactly why Condoleezza Rice was involved in the 1998 meeting and after elected made National Security Advisor to President George W. Bush.

2001 Sept 6:

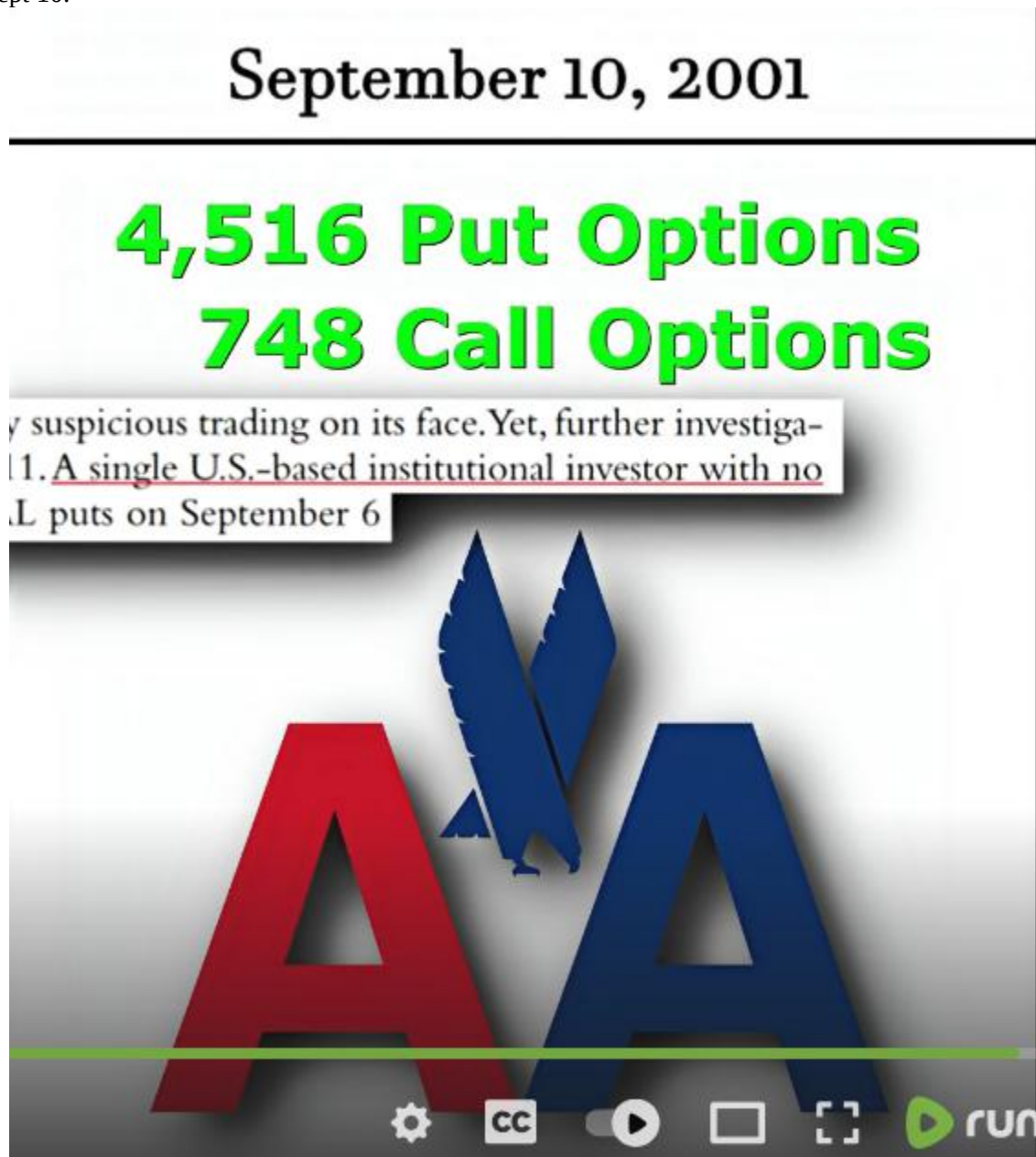

2001 Sept 9: The most powerful warlord in Afghanistan, Pashtun Ahmad Shan Massoud was assassinated by a Jordanian television crew that had been arranged by the US. The video camera was a bomb and killed a man the Afghans considered a National Hero. During the USSR – Afghan War 1980-1988 the Russians nicknamed him the “Lion of Pansjhir” his Pashtun army inflicted so many wounded and dead on Russia they gave up and went home. Massoud had already told Bush he was not welcome to come to Afghanistan to take over the Bidas pipeline. Massoud had tried for years to get US, or NATO or certain NATO members to arm him and he would resolve the Taliban matter in his nation.

2001 Sept 10:



2001 Sept 10: James Dorian of Oil & Gas Journal reports the following is copied and pasted from a Schwarz PowerPoint prepared for September 11, 2004 in NYC “9-11: Confronting the Evidence”:

2001 Sept 10: “The Bush Strategy” is inadvertently revealed at a prophetic time in history. It does not seem so, but it is a “smoking gun”. In Chapter 3, page 97, the Schwarz book revealed a comment from an energy expert that came out September 10, 2001, the day before September 11, 2001.

“Most experts agree that the Caspian Basin and Central Asia are the keys to energy in the 21st century”, said energy expert James Dorian (Oil & Gas Journal, 9/10/01), “Those who control the oil routes out of Central Asia will impact all future direction and quantities of flow and the

distribution of revenues from new production." [Operation Steppe Shield objective of George H W Bush since at least 1990. Refer to TIME magazine article link at previous Slide 2.]

2001 Sept 10: Secretary of Defense Donald Rumsfeld is pinned down in a Pentagon press briefing regarding funds missing from the Pentagon. Rumsfeld admits that the Pentagon cannot account for \$2.3 TRILLION.

2001 Sept 10: John Patrick O'Neill first day on the job as head of WTC Security. He dies the next day trying to help evacuate WTC 2. Kroll Associates employees were telling everyone in WTC 2 to return to their offices, all was OK and under control. In short, a cruel lie to increase the death toll since that building was collapsed first by controlled demolition.

2001 Sept 11 There was to be 8am meeting at Marsh McLennan with their IT people, Richard Andrew Grove and a high-level executive about the money laundering. Grove was late due to being tied up in Manhattan traffic. All others died except L. Paul Bremer who was first to get on TV (MSNBC) and point the finger of blame at Osama bin Laden and Afghanistan.

2001 Sept 11 "Lucky Larry" Silverstein on a televised interview with Charlie Rose on PBS said he was not at his "usual 8am breakfast at Windows on the World getting to know his tenants" due to a corny reason and story he told live on TV.

2001 Sept 11 The NYC field office of Secret Service had arranged an 8am meeting with Silverstein and Fort Monmouth AMC explosives and bomb experts purportedly to discuss how to prevent a terrorist bombing of his WTC 7. Silverstein's side cancelled the meeting. The Fort Monmouth AMC experts watched 9-11 unfold from a nearby café. **(The Secret Service and Fort Monmouth AMC experts stayed onsite for 3 days looking for "unexploded bombs" because Bush was in-bound to Ground Zero to blame it on Afghanistan and Osama bin Laden.)**

2001 Sept 11 WTC 1: Bomb detonates on lower level B3 and disables the Freight Elevators even before the first alleged hijacked jet hits WTC 1 North Tower, 93rd Floor. **Why is this important?**

William Rodriguez has reported this and how he helped Filipe David of Bolivia to an ambulance before the first jet hit WTC 1. Filipe David was in a coma for months. William Rodriguez was late for work on Sept 11, 2001 and has stated he lost 200 friends that worked at WTC who were at breakfast in the WTC 1 Windows on the World restaurant which they did every morning.

2001 Sept 11 WTC 1: Alleged hijacked Flight 11, Boeing 767 hits 93rd Floor of WTC 1 at 8:46am.

2001 Sept 11 WTC 2: Bomb detonates on lower level B3 and disables the Freight Elevators even before the second alleged hijacked jet hits WTC 2 South Tower, 78th Floor. **Why is this important?**

2001 Sept 11 WTC 2: Alleged hijacked Flight 175, Boeing 767 hits 78th Floor of WTC 2 at 9:03am. **Why is this impact level very important?**

The Schwarz team proved by end of 2004 that it was an A3 Skywarrior and bunker buster missile that hit the Pentagon.

The Schwarz team proved by end of 2005 that it was a Boeing 737 that hit WTC 2, which blows a huge hole in The Official 9-11 Lies about 9-11-2001.

2001 Sept 11: **Former architect-engineer, design-build-development CEO Karl Schwarz sees molten metal flowing out of a WTC tower and that was nowhere near any of the fires in WTC 1 or WTC 2. By 2001, Schwarz and a team of scientists were totally focused on nanotechnology and knew that the only way to turn structural steel to molten state was a thermite reaction chemical process. For this single reason is why the Schwarz Team investigation has been much deeper than any other 9-11 Truth group and has identified long ago how they did it, why they did it and most important WHO DID IT.**

2001 Sept 11: Other Kroll Associates employees are telling WTC 2 tenants that everything is under control so return to their offices. That did not include John Patrick O'Neill who was racing to evacuate the building and died trying.

2001 Sept 11: Alleged American Airlines Flight 77 hits Pentagon at 9:37am. Killed at Pentagon were 125 people and purportedly the alleged 64 passengers of Flight 77, which did not hit the Pentagon.

2001 Sept 11: 9:59am, WTC 2 collapsed. NY firefighters had taken the elevators to 40th Floor, walked up to 78th. Radioed precinct that there were 2 small fires, both containable. Within 1 to 2 minutes WTC collapsed killing all remaining in the building. Kroll Associates trying to up the death toll by telling people to return to their offices, everything is under control.

2001 Sept 11: 10:28am, WTC 1 collapsed with no fires below the 93rd floor. However, plenty of bombs were going off in WTC 1 and had already gone off in WTC 2.

2001 Sept 10-11: James A. Baker III, former Secretary of State in GHWB Admin and Frank Carlucci of Carlyle Group spent the morning in meeting with Shafiq bin Laden, brother of Osama bin Laden, at the Ritz Carlton Hotel and the day before on September 10, George H W Bush was in the first day of that meeting on Sept 10. Lear Siegler Services Inc. and United Defense and other Carlyle groups and all US defense contractors raked in tens of billions due to September 11, 2001. Frank Carlucci was Donald Rumsfeld's college roommate, former Chairman of Pentagon JCOS and Secretary of State Colin Powell is a Carlyle Group advisor and when junior kept wrecking companies, George W. Bush was for a time a Carlyle employee.

2001 Sept 11; At approximately 5:00pm, the BBC announced: "We have just learned that the Salomon Building has collapsed". The WTC Building 7 was still standing in the background during the live television announcement.

11 Sept 2001: At approximately 5:21pm the WTC 7 is brought down in an obvious controlled demolition. Silverstein gave the order "pull it", a controlled demolition term.

11 Sept 2001: NYC employee Barry Jennings is speaking to a reporter that he was making sure WTC 7 was vacated and they started blowing the elevator shafts while he was in the building. **Schwarz has challenged AE911Truth and IC911Justice with this question: "In a controlled demolition, why do they take out the elevator shafts first?" No one has replied.**

2001, Sept 11: Bush states later he saw the first jet hit WTC 1 on TV at the school in Florida. That is a lie, the first impact of alleged Flight 11 was not available or known by anyone until the next day unless POTUS had a private feed on that first impact.

2001 Sept 11-12: A flight departs Kosovo (+6 hrs. NYC time) with large crates that were delivered into Northern Afghanistan on September 12. The crates contained hundreds of millions of US

dollars. Probable recipient General Rashid Dostum to renege on the agreement he signed with Bidas Corporation. Part of the “shooters” guarding the delivery of those crates were paramilitary employees of UNMIK (UN Mission in Kosovo). There are anecdotal reports that after Dostum signed the deal with Bidas, he had to flee to Turkey due to CIA after him. Schwarz wrote the article **‘Pop Goes the Bush Mythology Bubble, Part VI’** that revealed those facts. After the Schwarz book came out in 2004, he was contacted by the widow of someone that was on that Kosovo-Turkmenistan-Afghanistan flights. Her husband was killed in Iraq while working for Blackwater USA and EODT.

2001 Sept 12: Rumsfeld reinstates the aggressive “obey orders or will shoot down” ROE.

2001 Sept 12: Schwarz receives email with photos attached and were taken on the Pentagon lawn. All components have been verified as originating from an A3 Skywarrior. More on this matter is under separate section PENTAGON as attachments and photos.

2001 Sept 13: The Administrator of the EPA Christine Todd Whitman issued a series of statements and press releases as follows in chronological order and some are also from the September 14, 2003 NY Post article and even later in 2016 by British media on this asbestos issue: **“FROM THEIR MOUTHS: Sept. 13, 2001: The EPA puts out a press release saying, “Short-term, low-level exposure [sic to asbestos] of the type that might have been produced by the collapse of the World Trade Center buildings is unlikely to cause significant health effects.”**

2001 Sept. 18: Whitman announces, **“I am glad to reassure the people of New York ... that the air is safe to breathe.”**

2001 Sept 18: Anthrax attacks on anti-Bush factions in TV, newspaper and Congress. Targeted in Congress were Senator Patrick Leahy (D-VT), chairman Senate Judiciary Committee, Senator Russ Feingold (D-MN), only Senator to vote “NO” on the Patriot Act, and Speaker of the House Tom Daschle (D-SD).

The FBI called the investigation “Amerithrax”, supposedly “the most intensively investigated crime in US history”. **Mueller lied.**

The anthrax attacks were the Ames strain (US govt lab Ames Iowa) weaponized anthrax. The sole anthrax vaccine provider to the Pentagon was BioPort Vaccines and they were on the list of suspects. Schwarz was already investigating and compiling his book “One Way Ticket to Crawford Texas”. BioPort was facing billions in court judgment liabilities for a vaccine that was causing massive harm, damage and deaths to US military personnel. Suddenly BioPort disappeared and resurfaced as an offshore entity to evade those huge liabilities.

The purchaser was DynCorp, a PMC security and mercenary company that had been close to Bush Family since Iran Contra and Desert Shield 1990 – Desert Storm 1991, active in the Balkans in Clinton’s ‘Wag the Dog’ exercise and made billions during George W. Bush Admin.

The new entity immune from the BioPort court judgements was named **DynPort Vaccines, LLC, Reston VA**. Schwarz called the FBI 3 times and they totally refused to add the name of the most likely suspect to the list. That is revealed in **Chapter 5 of the Schwarz book**.

Founder of DynCorp Herbert “Pug” Winokur, was involved in the Enron scandal, forced to resign from that company and prestige groups affiliated with Harvard and Yale.

Dig one inch deeper, DynCorp was convicted in the UK and State of Texas for sex trafficking underage females to sex predators they had taken from Bosnia and Serbia from 1999 to 2001. Probably after their parents were murdered due to Clinton had a fabricated excuse to attack. Some reports say over 200,000 sex trafficked.

2001 October: Whitman says that **“considering Ground Zero a major environmental health hazard to area residents and employees would be “inaccurate.””**

2001, Sept 18: There was an **anthrax attack also sent to Fort McNair** according to Adam Eisenberg who was at Pentagon. There is no historical record of this until Eisenberg’s statements in 2025 interview.

2001 Sept-Oct: At some point former Vice Chairman of House Armed Services Curt Weldon assembled a small delegation and went to Rome to meet with the exiled King of Afghanistan. The stated subject was to see if the King would go to Afghanistan and meet with the warlords to see if the US could come into Afghanistan peacefully. That answer was probably NO WAY since CIA Special Activities Division were rounding up or killing any and all who would resist US presence in their nation, plus on September 9, 2001 CIA engineered the assassination of a man considered a National Hero Ahmad Shah Massoud.

2001 October 7: USAF and US Navy begin bombing sites in Afghanistan. Initial military engagements with Taliban are done by Green Berets, 10th Mountain Division and CIA Special Activities Division.

2001 November 5: First alleged casualty of an American in Afghanistan was Johnny Micheal Spann, former US Marine Captain, CIA Special Activities Division at Bagram Air Base prison uprising.

2001 November 22: Last known interview with Osama bin Laden is done with Hamid Mir, a noted Pakistani journalist.

Nov 22, 2001: The following is copied and pasted from the Schwarz book (January 2004) as it appeared in a foreign newspaper and in the book, Chapter 3, pages 88-89. The link to this article was blocked on the Internet shortly after it was published and was posted on the newspaper website in English:

11:01 2001-11-22 - Bin Laden: Not all Americans are bad

“Mohammed Omar predicted the current campaign by the USA in Afghanistan 5 years ago, claiming that when the Taliban would not allow the US to build a pipeline they will begin to attack us, justifying it with Bin Laden. [Plaintiff’s notice to the Court is those 5 years leading up to September 11, 2001 is when Bidas Corporation was under full assault from multiple US and Saudi parties to block the Bidas SAPIC TAP. Trans-Afghanistan Pipeline, Turkmenistan, Afghanistan, Pakistan to ocean port of Gwadar Pakistan.] [emphasis added].

Omar’s words are reported by Hamid Mir, who made the last interview with Osama Bin Laden, who declared that he is not against the American people, only the politicians and the state.

In the first interviews, Osama Bin Laden had declared himself against all the American people, but he had changed. He admitted that there were many good people in the United States and it was the politicians and State, which he despised. He told Mir that he had seen many western people on television protesting

at the bombing in Afghanistan and concluded, "They are good people. They are not Moslems, but they condemn the bombing".

2001 November: George Tenet eulogizes Johnny Micheal Spann. We have reasons to believe that the CIA Special Activities Division was active most or all of 2000 and 2001 in Afghanistan.

2001 December 31: President Bush appointed a former aide to Unocal, Afghan-born Zalmay Khalilzad, as special envoy to Afghanistan. The nomination was announced nine days after the US-backed interim government of Hamid Karzai took office in Kabul. Same Khalilzad cited as "The Butcher of Bosnia".

2002: China and Pakistan sign the CPEC agreement (China Pakistan Economic Corridor) and construction starts on the Port of Gwadar Balochistan Province Pakistan. That construction was finished by 2006, the port of inaugurated in 2007 and went into operation. By 2002 the CPEC had completely blocked Bush and Blair on 'mission accomplished' to Mission Failed.

2002 Feb, 8: Afghanistan's interim leader Hamid Karzai said he and Pakistani President Pervez Musharraf had agreed to revive a plan for a trans-Caspian gas pipeline from Turkmenistan to Pakistan. (Only route to do that is across Afghanistan exactly as Bidas Corporation planned and had signed contracts to do.)

May 2002: The EPA was quietly cleaning residential units near where WTC once stood but not cleaning businesses, shops, restaurants and offices in the area. By September 14, 2003 it was reported by the NY Post that matters were approaching adversarial level and the Inspector General got involved. Upon conducting an evaluation, the Inspector General reached the conclusion it was the Bush Administration that was to blame for the misleading information. **"May 2002: Under pressure, the EPA begins cleaning contaminated apartments, but not businesses, in lower Manhattan up to Canal Street."**

2002: Bush has a War Planning Team in the Pentagon trying to figure out how to take back Gwadar without having China and Pakistan join the Taliban and crush the Bush Blair (US-UK) scheme to take over what Bidas Corporation accomplished. The Argentina company was welcome, US and UK were not.

2002 December: EPA puts out press release saying, **"people who returned to the area around Ground Zero after Sept. 17 were 'unlikely to suffer short-term or adverse health effects' from contaminated air."**

2002 Dec 27: Central Asia pipeline deal signed; An agreement has been signed in the Turkmen capital, Ashgabat, paving the way for construction of a gas pipeline from the Central Asian republic through Afghanistan to Pakistan.

2003 February: Bush announces at the State of the Union address **"Project BioShield"**. Plans to force vaccinate 10 million First Responders with smallpox and anthrax vaccines "due to biological threat to US" even though there is not 1 single case on the entire planet of smallpox or anthrax. Dr. Anthony Fauci publicly states that the smallpox vaccine is worthless and dangerous. Only about 38,000 First Responder health workers accept Bush's goal, many of them had major negative health effects, some were career and life ending, same as US soldiers forced to take same vaccines.

2003: Bush increases the number of US labs doing risky biological research by 300% under the pretense of “counterterrorism” and transfers control of all US bioweapon labs to Battelle. Note that **Battelle** did the Human Genome Project at Oak Ridge National Lab, ORNL.

2003 February 23: OPIC agrees to fund the pipeline and Bush has guaranteed to protect it with U.S. troops (without telling the United States citizens). “23-02-03 Turkmenistan, Afghanistan and Pakistan (TAP) have signed a protocol for trans-Afghanistan Gas Pipeline Project... However, some recent reports had indicated that the United States was willing to police the pipeline infrastructure through permanent stationing of its troops in the region. The US ExIm Bank, the Trade and Development Agency (TDA) and the Overseas Private Insurance Corporation (OPIC) had also shown readiness to finance such a project, if leading American energy giants come forward.”

Make sure you ask me why I was focused on OPIC. Dr. Peter Watson, Richard Armitage, Baker & Botts clients Western Acquisitions, LLC and Remington Holdings Ltd. Another name kept coming up, then disappeared, then popped up again regarding Florida and the WTC security company.

2003 Spring: FBI issues a bogus “Saudi Dirty Bomb Suspect” alert involving Adnan Gulshair el Shukrijumah on all US TV stations. The telephone call to the FBI as to the exact whereabouts was made from Schwarz’s home in Little Rock AR by his Canadian girlfriend who had known Adnan for close to 3 years. This matter is in Chapter 7 of the Schwarz book.

See Wikipedia on his name Adnan Gulshair el Shukrijumah. Only truth on their page is what the Saudis and Adnan’s mother said. Rest is CIA and FBI covering their ass since they were told within 15 minutes of exactly where he was and did not even go talk to him.

FBI later issued alerts on all US TV networks “Saudi Dirty Bomb suspect seen in Maine”, etc.

2003 April 11: There was another pipeline in Iraq named “Aqaba” that involved Bechtel, George Schultz and other Bush elite backers. Schwarz has a copy of a facsimile transmission from Defendant Jock Covey, who was part of UNMIK, to George Schultz about how to “spin it” for the NY Times reporter Bob Herbert when information leaked out and the story was about to be published regarding the Aqaba pipeline. The content of that facsimile is in the Schwarz book verbatim.

2003 August 21: **EPA inspector general Nikki Tinsley releases a report saying the White House pressured the EPA to tell New Yorkers the air was safe before adequate testing had been performed.”**

2003 Sept 2: Schwarz receives a telephone call at home from Priscilla Owen, stating she is a senior aide to Karen Hughes. Her confirmation hearings had been intentionally stalled by Senator Patrick Leahy, (D-VT), Chairman Senate Judiciary Committee after the May 9, 2001 appointment and the September 18, 2001 anthrax attack on his office. The subject of the call is in Chapter 14 of the Schwarz book and dealt with huge capital markets fraud relating to Williams Communications Group and Global Crossing, both companies were victims of Bush’s Pioneer backers and capital markets predators running amuck during the Bush – Cheney Admin.

2003 September 9: **Bridas prevails at 5th Circuit, U.S. Court of Appeals after years of being jerked around in Texas courts. \$495 million arbitration award upheld. cited as 345 F.3d 347 (5th Cir. 2003).**

2003 September 14: NY Post article on September 14, 2003 that created outrage with the NY Firefighters? **'9/11 AIR OUTRAGE: WHITMAN: PIT CREWS BLEW OFF HEALTH WARNING', By Susan Edelman, September 14, 2003'.**

2003 September 30: Bush appoints his cousin as US Ambassador to Hungary. George Herbert Walker, III served as the United States Ambassador to Hungary under his cousin from 2003 to 2006. Schwarz moved to Budapest on June 1, 2006 on business.

2003 December 19: On this date 3 independent labs confirmed that the Schwarz + 7 non-US scientists were the #1 nanotechnology team in the world with patents that work in unison as an Industrial Process Patent. Those nanotechnology labs were part of LSU, Rostock University Germany and Itochu Labs in Japan. DARPA and Pentagon TSWG already knew and why the Schwarz group were assisting them when asked or needed. To the current date, no known nanotechnology group can produce >95% to >99.5% nanostructures except the Schwarz team.

22 Mar 2004: U.S. Supreme Court denies Writ of Certiorari, upholding 5th Circuit. State Concern Turkmenneft v. Bidas, 03-1018 (Remember, Unocal / Delta (Saudi owned) started this blockade, aided by Clinton and Bush Administrations and Texas judges. Also, in bed with Amerada Hess [Delta / Hess] and board member Thomas Kean chairs the 9-11 Commission and Richard ben Veniste, Mayer Brown was representing Turkmenistan and Turkmenneft.

April 19, 2004: Peter Jennings is reporting a USA Today article that revealed 2 years prior to September 11, 2001 NORAD conducted war game drills involving hijacked jets targeting the World Trade Center. Brian Ross of ABC ended the discussion with his comments questioning why there were no fighter jets anywhere near the WTC or Washington DC on 9-11-2001?

2004 May: Schwarz is advised by his DARPA liaison that the agency and Pentagon TSWG cannot continue collaborating with Schwarz and his scientists unless they **subordinate to Battelle Corporation**. The attempt to subordinate the team under Battelle and the PNAC 2000 "Rebuilding America's Defenses" as biological war criminals was declined.

September 11, 2004: Schwarz was the surprise and unexpected guest at Jimmy Walter's NYC event "9-11: Confronting the Evidence". The Schwarz book 'One Way Ticket to Crawford Texas' was published, selling fast. Two CIA goons barged into the backstage area and threatened Schwarz he would be terminated in NYC if he disclosed the PANY&NJ asbestos lawsuits they lost 3 times, especially the May 17, 2001 loss. They must have received a "heads up" when Schwarz called the US District Court in Newark NJ requesting a full copy of that May 17, 2001 final order and was denied. Schwarz was not in NYC to disclose that, he was in NYC to reveal why Bush blamed September 11, 2001 on Afghanistan when they did not have anything to do with that horrible day in US history.

2004 November: A Canadian banker was in NYC on September 11, 2001 and from South of WTC was using camcorder aimed at WTC 1 North Tower. He was standing near Rector Place when a jet flew over the Marriott Downtown on West Street and hit the south wall of WTC 2. The Canadian got in touch with Schwarz associate Debra Simon who traveled to Ontario to get 2 copies of what the camcorder had seen. A full analysis of 25 still photos including onsite verification of distances and elevations (altitude) revealed that the wing span was that of a Boeing 737, not Flight 175 Boeing 767 from Boston Logan. (Debra Simon provided some of the initial funds to make the videos 'Loose Change' and "Loose Change Second Edition". Schwarz on Pentagon matters is mentioned in both videos. When Jason Bermas and Alex Jones got involved in later issues of 'Loose Change', Schwarz and Pentagon were deleted.)

March 2005: Schwarz sends RFP documents to 17 EU nations regarding location of headquarters, R&D Center and corporate operational units to relocate in EU due to 50 Hz electric grid. That is essential in nanotechnology excellence and is why China has outpaced USA in new nanotechnology patents every month and year for over 20 years by margins of 4:1 to 6:1. Five nations responded, Austria and Hungary tied for 1st place, Slovakia placed 3rd, Germany 4th and Italy 5th.

July 2005: Schwarz was in Budapest Hungary and 8 other locations in that nation, plus meetings with the top scientists of Hungary Academy of Sciences. The Academy voted unanimously to support Schwarz and his team, which included 1 renowned Hungarian mathematical chemistry genius and pioneer Dr. Istvan Lukovits, PhD, Chemical Research Institute in Budapest. Dr. Lukovits was part of the original 7 scientists Schwarz retained for landmark research and got it done.

Aug-Sept 2005: Schwarz returned to Budapest for intensive meetings with 5 key ministries before returning in June 2006 to conclude a Phase 1, €250,000,000 financing that was a standing offer from EIB [European Investment Bank] of €125,000,000 and nations had to match that.

2005 Sept-Nov: The US government tried to block Schwarz from leaving the US with what the government deems is “nationally strategic sensitive technology”, but lost.

2005-2007: Zalmay Khalilzad is appointed by Bush to help fix his dirty diaper in Iraq. Even later he was appointed as US Ambassador to the UN 2007-2009 after John Bolton managed to infuriate everyone pushing his Neocon agenda.

Zalmay Khalilzad, also referred to in former Yugoslavia as “The Butcher of Bosnia” for CIA collaboration in arming Muslims to kill Christians to justify Clinton and NATO intervention and the bombing of Serbia in 1999, former advisor to Unocal in CIS / Caspian Basin region 1997, Ambassador to Afghanistan (2003-2005), Ambassador to Iraq (2005-2007), Ambassador to United Nations (2007-2009); and Khalilzad, Zalmay - Ambassador to Afghanistan, Special Presidential Envoy to Afghanistan, and Special Presidential Envoy to the Free Iraqis; and

2006: BARDA was established in 2006 through the Pandemic and All-Hazards Preparedness Act (PAHPA). The law created a new position at DHHS that is the actual parent agency: Office of the Assistant Secretary for Preparedness and Response, which is a military position with pre-emptive control over US health responses such as the SARS CoV-2 / Covid-19 fraud.

2006, April 21: The Texas defendants kept trying to run to US District Court Houston to vacate the ICC award of \$495,000,000 but lost again. No. 04-20842, April 21, 2006, cited as 447 F.3d 411 (5th Cir. 2006). Bidas won again.

2006 May 31: Schwarz left Atlanta Hartsfield airport for Europe.

2006 June 1: Schwarz arrived in Budapest and moved into a newly renovated flat as his new home. From 2006 all the way to September 2015 was still doing radio shows and articles on 9-11 Truth.

2006 late June: George W. Bush is facing major heat in the USA due to his 9-11-2001 lies, the total train wreck in Afghanistan and the total train wreck in Iraq. Both train wrecks due to egregious lies of the Bush Administration. A delegation of 1,100 people descended on Budapest as the George W. Bush escape from DC to celebrate the 50th Hungarian Uprising against the USSR. President Dwight D. Eisenhower urged the Hungarians to stand up and then sat back while over 22,000 Hungarians

died. Problem with Bush trip was the 50th Anniversary of that uprising was months later on OCTOBER 23, 2006.

2006 Summer: Schwarz had his own CIA Goon trying to tail him everywhere to see who he was meeting with and then bully them into not cooperating. That same man was later arrested in Vienna in 2009 and was then in Berlin on December 2, 2011 to oversee a robbery of Schwarz to get something the CIA wanted suppressed. See 2009 and December 2, 2011 in this chronology.

2006 late June: Schwarz got forewarning of this Bush trip and confronted his "Secret Service escorts" at two 5-star hotels wearing a black t-shirt with a photo of Bush and above said "International" and below said "Terrorist". The Hungarian police rushed in to defend Bush until Schwarz showed him his US passport and informed them Free Speech applies to Hungary, too if directed at an American. Schwarz already knew where this Faux Event was being held and already had a ticket to attend. That was reported in the Budapest Sun, an English newspaper in Hungary. FYI... the Hungarians loved the t-shirt because their nation was being used and abused for CIA renditions and torture of innocent people.

2006 August: Hungarian investigative journalist breaks story that US Ambassador George Herbert Walker III bribed 2 key ministers to derail the Schwarz project in Hungary. Under Hungarian law such an act is a felony without any diplomatic immunity. Bush had to rush his cousin out of Hungary before being arrested and flee back to the US.

2006 August: Bush rushed to replace the corrupt cousin with April H. Foley a former classmate from Harvard. Her brother-in-law Tom Foley of Connecticut was the Iraq Assets Czar to oversee that the corrupt Bush backers got the Iraq assets under their control and no one else. Bush lost that war, too, and the assets.

2006 September 17: Hungarian Ministry MTV that controls all TV and radio. On this date they aired a secretly recorded conversation of recently re-elected PM Ferenc Gyurcsany scolding his cabinet that if the truth ever got out how much they lied to get re-elected in May 2006 there would be problems. His government ran all over Hungary bragging about their huge success in recruiting and getting a commitment from Schwarz to locate his company in Budapest and various sites around that nation. Simple truth is Austria and European Investment Bank were doing the recruiting and the Gyurcsany government had nothing to do with it. Hungary had a chance due to Schwarz's top chemist Dr. Istvan Lukovits PhD being on the team that got it done.

It was during the Gyurcsany government before re-elected that Bush cousin George Herbert Walker III bribed 2 key ministers and killed the project. Those 2 ministers were Janos Koka and Janos Veres.

2006 September 18: On this date was the last meeting with MFB and it was clear they were renegeing on their €125,000,000 bond issue commitment. In the room were 3 young females from MFB all under age 30, Schwarz, a major engineering company, major contractor, Vienna attorney for Schwarz and the EIB representative for their side of the €250,000,000.

2006 September 18: After the meeting ending, Schwarz was receiving phone calls from 8 cities in Hungary as to "thumbs up" or "thumbs down" on the matter. When the honest answer was thumbs down due to MFB and two US bribed ministers, thousands of people headed to Budapest and that night they set the MTV federal building on fire. Audible in the background the people were chanting the name of Schwarz's company as to why they were furious at their government for costing their nation 16,000 new high-tech jobs over 5 to 6 years.

2006 October 23: The real date for the 50th Anniversary of the Hungarian Uprising was a huge riot, over 500,000 people descended on Budapest. Lots of property damage and injuries. The police were ordered to open fire on their own citizens. Later that night Schwarz escorted his Russian girlfriend home and asked the police... “what idiot in your government had you playing the part of the Russians tonight to abuse your own citizens on the 50th anniversary?” That policeman responded... “We were just following orders”. Schwarz told him before walking away... “and look at the shit show you caused for following orders”. Trams, buses, police cars and much more totally destroyed, and the crowd were again chanting the name of Schwarz’s company and even had protest signs with one word “Patmos”.

2007 June: On a radio show with US host Schwarz revealed what Bush and sleazy cousin had done. Also revealed that the same Bush cousin was fined by the NASD for conducting business with Duke & Company, Florida based, NYC office and ties directly back to WTC and September 11, 2001.

2007 June 27: A Chinese delegation of 9 people came to Cologne Germany to meet with Karl Schwarz. They were 4 top level executives up to vice chairman of TEDA (Tianjin Economic Development Area where the main FAL for the Airbus 320 family of jets is located) plus 1 translator, 3 PhD scientists from NIBC (Nanotechnology Industrialization Base of China also based at TEDA) and 1 “mystery man” that only spoke Chinese to the 3 PhDs from NIBC. This meeting was for a joint venture at TEDA due to the Airbus operations there. Schwarz and his group were working on a €1.3 billion facility in Slovakia after George W. Bush and his sleazy cousin and CIA knifed Karl Schwarz in the back in Hungary.

Towards the end of the meeting the “mystery man” who was #2 man at the China Science & Technology Ministry in Beijing, fluent in English, Masters and PhD from Cal Tech asked a direct question as to how much of the Schwarz technology was in Phase 1a of that \$1.3 billion Euros plant in Slovakia, The answer was direct €165 million Euros but the total project was €1.3 billion and not 250 of our proprietary machines, would be 4,000 of those machines. This man from Beijing informed Schwarz he was authorized by his government to offer that amount to acquire the technology. Schwarz advised him that Austria was appraising the Industrial Process Patents to justify a non-repayable grant of €100,000,000 and had already confirmed the valuation would be over €1 billion. We could talk later or end the meeting. They came for a joint venture and went for takeover. The Austria appraisal came in at minimum worth €1.25 billion.

2007: CIA waging covert war against Iran and IPI and Pakistan due to CPEC. That was CIA DDO James Pavitt and his CIA Special Activities Division. Tenet, CIA counterterrorism Cofer Black and James Pavitt all testified before 9-11 Commission and all lied.

2007: During same time frame, Iran was pushing the IPI for Iran Pakistan India pipeline and part of that was to direct flow to Gwadar for a \$400 billion oil contract China has with Iran. India pulled out in 2009 due to “2 years of geopolitical pressures” from the United States.

2008 June: Major article about Schwarz and his company appears in a Russia high-tech magazine Sverkhnovaya Realnost (translation SuperNew Reality).

2008 July 1-31: The Pentagon holds war games in Georgia, EU and NATO wannabee Georgia. Apparently gave a Ukraine Neo-Nazi light armored group a free ride to Georgia on the far East end of the Black Sea.

2008 August 7: Georgia gun boats opened fire on a Russian freighter and were shortly thereafter eliminated by Russian Navy Black Sea fleet.

2008 August 8: At approximately midnight US private military mercenaries, Georgia, Ukraine Neo-Nazis opened fire on Abkhazia and South Ossetia. Before dawn had killed +2,200 Russian passport holders in South Ossetia alone. Both Abkhazia and South Ossetia voted in 1992 to remain with Russia Federation rather than Georgia and US, NATO, EU refuse to recognize their right to do so.

2008 August-Sept: Schwarz wrote multiple articles about this Bush fiasco and war crime. Bush had totally failed in Afghanistan and US was insistent on pushing pipelines thru Georgia to the Black Sea. Problem remained that just East of Georgia is the Republic of Dagestan, Russia Federation. Still blocked unless they cut a deal with Russia rather than try to “regime change” Dagestan, too, which the US tried several times.

The Georgia – South Ossetia fiasco was George W. Bush’s Hail Mary Plan B pipeline route having been defeated in Afghanistan and blocked by CPEC.

Due to the defeat in Afghanistan and loss of Gwadar Port to CPEC, CIA wages a covert war of terrorism aimed at Pakistan that continued into Obama Administration.





OSCE contacted Schwarz about Bush and Condoleezza Rice lies on this matter. He let OSCE talk to his source, a South Ossetian man, married to a Ukraine woman in Odessa. He was in South Ossetia for funeral of family member and due to Bush Gang, suddenly +2,200 more funerals needed.

Bush was trying to take over the Roki Tunnel to North Ossetia Russia Federation and South Ossetia because the latter is only 20 km from those pipelines. Daddy Bush's 'Operation Steppe Shield' and George W. Bush's "Pearl Harbor of September 11, 2001" TOTALLY FAILED.

After OSCE talked to Schwarz source, Europe told Bush and Condoleezza Rice to go to Hell with their lies.

2009 Spring: 9 CIA agents are arrested in Vienna, caught spying on Schwarz, the Austria Finance Ministry and their outside auditors Halpern Prinz. Schwarz saw the same CIA goon disrupting in Budapest Hungary enter the building across the street from the Austria Finance Ministry and alerted them. Austria Federal Police moved in, 9 arrests, all of them kicked out Austria *persona non grata*. That was reported in local media until US government demanded their release.

2009 July: Follow up article in same Russia high-tech magazine.

2009 November: Schwarz is invited by the Chairman of Germany Russia Business Alliance to be the keynote nanotechnology speaker at ILA Berlin 2010 in June 2010. This also involved a huge aerospace order Russia had executed for 80 of the Antonov Ruslan An-124-200 heavy airfreight jets with an option of 80 additional jets. Schwarz's company was to be a prime contractor on this until USA hit Ukraine with Kiev Maidan and all Antonov production at Gostomel Airport west of Kiev and the Jet Engine factor in Kharkov were moved to Russia.

2009 December 20: Jennifer Matthews, deceased: She led the UBL and al Qaeda tracking unit right after 9/11 and later became the chief of base at the CIA's station in Khost, Afghanistan. She'd been one of the original Alec Station members. She was seen by her colleagues as a hard ass and as a serious and vigilant analyst and operative. A CIA report criticized her for not sharing information with the FBI before 9/11, a charge she found ridiculous and insulting; after 9/11, she became a senior liaison officer to the Brits, and then volunteered for the Khost downrange assignment, partly to expiate the guilt she felt at being blamed for the 9/11 failure. An al Qaeda double agent (a Jordanian recruited by the U.S.) entered the base without being searched and blew himself up. Matthews and eight other CIA officers were killed.

This is from a set of interrogatories in our lawsuit:

“Interrogatory 299: Have you been aware at any time that the longest serving CIA person on the UBL Station, aka: ALEC Station, the Usama bin Laden hunters was killed in Khost Afghanistan along with 7 other CIA agents, which is much closer to where Osama bin Laden was than the mountains Bush was bombing, and was reported by the NY Post on December 20, 2009?”

2010 March 10: A one day event in Vienna hosted by WKO (Wirtschaftskammer Oesterreich, Austria Chamber of Commerce) titled “Austria Russia High-Tech Collaboration Conference. Over 150 Russian scientists cancelled their trip because they could not get one of 8 meetings for 30 minutes and already knew all parties would meet as long as they wished in Berlin. The scientists were advised about ILA Berlin 2010 and why they cancelled 1-day trip to Vienna.

2010 June 9 11:15am: Karl Schwarz presenting nanotechnology applications in aerospace and outer space to 600 in the auditorium and about 250,000 watching on big screens outside on the air show grounds. Lockheed just could not resist violating air show ground rules to show off their F22 Raptor and try to drown out the Schwarz presentation. THAT is how petty, shitty and pathetic the US government is. What blew the audience away was a new type of space propulsion system, fastest ever developed on this planet. The Germans then figured out why the Russian side invited Schwarz. Lockheed was later overheard on a mobile phone call home to Mama... “I just found out who controls that new space propulsion system... Karl Schwarz... WE are SO SCREWED!”

2010 September: Due to the ILA Berlin air show presentation that stunned an audience of aerospace experts, 2 federal Bundesministers in Germany begged Schwarz to give Germany a second chance. During a period of 14 months neither man honored their word, lost Chance #2 in Berlin. Schwarz focused on other parts of Germany where jobs were needed, and people were engaging professionally such as Halle and Leipzig Halle Airport who were also at the ILA Berlin 2010 air show.

2011 Dec 2, 10:35pm: Schwarz’s computer case is stolen in a set up robbery, the camcorder video of what really hit WTC 2 was among the stolen items. CIA is cited in the police report, same man harassing Budapest and caught spying and kicked out of Austria was at the scene of the robbery to make sure his 2 “assets” distracted Schwarz and stole the computer case.

2012 March: Schwarz secures a €1.3 billion loan commitment that was to have funded €250,000,000 x 4 and final tranche of €300,000,000. First wire transfer of €250,000,000 was blocked by US controlled SWIFT and the US bullied and threatened the lender to terminate and renege on the loan.

2012 November: Schwarz associate Debra K Simon is found murdered in her Maryland home. Missing were a large knife found nearby, her copy of the Canada video showing what hit WTC 2 and the still photos of same impact. A local drug addicts was arrested and charged with her murder. Problem is... that was close to \$600 in her purse and a drug addict would to after WTC video and still photos and not the money?

2012-2013: Schwarz company is invited to be anchor tenant in a new build Nanotechnology City north of Mumbai India, State of Gujarat. The PM Modi of India is from Gujarat and who contacted Schwarz grew up with Modi since age 5. India has a major problem of battered Hindu women and children. Some of these women were to be relocated to the Nanotechnology City and have solid jobs and better futures. The Central Bank of Malaysia and the Central Bank of Singapore each contributed \$200,000,000, total \$400,000,000 to this worthy cause.

When those funds were passing thru US controlled SWIFT they are confiscated by the US Department of Homeland Security and parked in JP Morgan Chase NYC. Schwarz contacted the general counsel's office at the NYC headquarters and explained the wrongful conduct of DHS. The woman asked that Schwarz call again the next day, same time.

The next day the woman in General Counsel's Office advised she spoke to DHS; the confiscation order was by the Deputy Director of DHS Noah Kroloff and ended the conversation with the statement "sue us".

2009-2013: Odessa Ukraine. EIB increased their commitment to €500 million for a huge 3-phase plant in Odessa next to their airport. In May 2013 Schwarz overheard US persons with State Dept, Pentagon and CIA collaborating with their Ukraine Neo-Nazi buddies as to what was coming in Kiev in Fall 2013. Now known as Kiev Maidan 2014 and then the CIA and Ukraine Neo-Nazis assaulted Donbas July 2014 killing over 40,000 according to UNHRW and Putin intervened February 2022.

August 2013: Germany lost Chance #3 and final swing while Schwarz was living east of Dusseldorf Germany in Ludenberg. Moved to Switzerland same month.

2013-2014: Schwarz and his entire team underwent a 6-months long due diligence process with London high-tech insurance experts. The head of the team was former Lloyds of London high-tech expert and underwrote the entire EU satellite system in spite of fierce attempts by US government and Loral Corporation to get the business.

Schwarz and his team were approved for up to €1 billion of Aaa-rated credit default insurance. With that commitment and verifiable on a phone call, 20 banks received that insured loan request. None would even reply to email or return phone calls. After about 60 days one bank did call and spoke in detail of the threats the US government made at them if they did the loan for Schwarz and his company.

2015 August 11: **What may have prompted such an apology by Defendant Whitman was Russia media group Sputnik put some facts on the line on August 11, 2015 with a headline that apparently no US media outlet thought was worthy of reporting or even commenting on: "Nearly 4 Thousand 9/11 First Responders Have Been Diagnosed with Cancer". 20:27 GMT 11.08.2015. [emphasis added]. Again, a US media failure to focus on a major matter.**

2016 Sept 10: **It was not until September 10, 2016, that former EPA Administrator Defendant Christine Todd Whitman apologized for misleading everyone about the air quality issues related to September 11, 2001 and the damage it had and was continuing to inflict on people that were around WTC on September 11, 2001 and afterwards.**

2016-2021: Former DEA Donald C. CIA could not find him, but CNN reporters did when CIA seemed to be stumped. World Trade Center 2

The following photo is the combustion chamber of a Boeing 737 engine. It landed blocks away at Murray & Church Street intersection. Both the landing gear and this engine are from a Boeing 737, not the alleged hijacked 767 from Boston Logan International Airport.



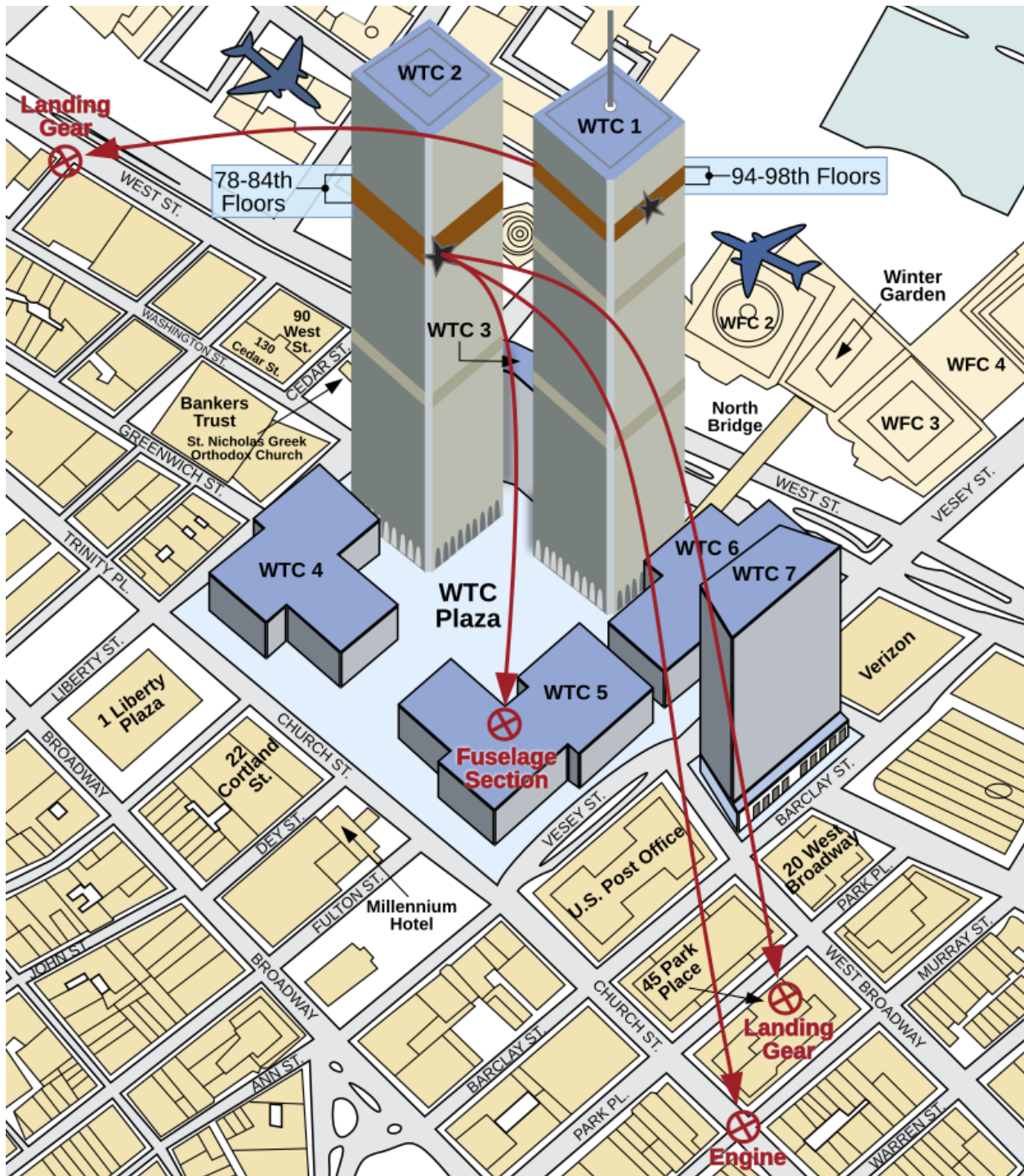
This is a Boeing 737 engine at their Renton Washington assembly plant relative to the size of a human.

The only component of the alleged hijacked Flight 11 (9-11-2001) is in all probability a landing gear from a Boeing 737.



An Air Traffic Controller from Boston Logan contacted Schwarz early 2005 from a state they did not live in and used a friend's landline. They had been threatened at work. The 2 alleged hijacked Boeing 767 jets went East towards Europe. When about 110-120 miles out over the Atlantic and the second flight

about 80-90 miles out, they both disappeared from radar. Even if transponders were turned off, should have still been visible on radar. The Boston Logan ATC had already checked distances and time of impact on WTC 1 and WTC 2 and knew that those Boeing 767 jets could not have been Flight 11 that hit WTC 1 or Flight 175 that allegedly hit WTC 2. The Boeing 767 is not capable of +Mach 1 speed and that would have been required to have arrived in NYC on time. The two Boeing 767 jets were even further away from NYC because they were flying the standard “Great Circle Route” across the Atlantic.

Several weeks later and due to many articles, radio shows, September 11, 2004 in NYC, Schwarz was contacted by a former official WTC photographer. Years before 9-11-2001, he was in the WTC 1 offices of Emory Roth & Sons Architects when federal agents came and confiscated all plans and specifications for the World Trade Center complex. Pentagon

The blurry Pentagon parking lot camera had been intentionally blurred. The pyramidal shape of this explosion is indicative of a bunker buster weapon detonation. Exploding jet fuel alone would not have enough blast force to blow through the concrete floors above and the roof, too.

Note in the photos above the engines of a Boeing 757 extend below the bottom of the fuselage of the commercial passenger jet. The engines of an A3 Skywarrior are same as the bottom of an A3 fuselage.

Additionally, no dual wheel front landing gear of a 757 was at the Pentagon, nor were 2 – 4-wheel landing gears as shown on the Boeing 757. All wheels at the Pentagon were single wheel landing gears exactly as shown on the A3 Skywarrior.

The canopy glass is military grade blast proof for an A3 Skywarrior and the only military jet to ever have this exact shape installed. This has never been installed on any Boeing 757 jet.



This is part of an A3 Skywarrior wing and is not a component of any Boeing 757 ever built. The metal device on the right is how wings and wing-mounted jet engines are attached to the fuselage of all types of jets whether commercial, private or military. The wing is far too narrow to be from a 757.



It is easy to paint any plane that is going to be coming at the Pentagon full blast as being American Airlines. The Operation Northwoods ploy to blame an attack on a commercial jet by Cuba to justify waging war proposed the exact same thing. President John F. Kennedy vetoed that plan and was dead months later.



This is part of the other A3 Skywarrior wing. It is relatively easy to prove this is not any component of any Boeing 757 ever built.



Due to acquisition of Hughes Aerospace, Raytheon has a fleet of A3 Skywarriors. The Pentagon still had 2 reported as operational as of September 11, 2001 and were used mainly by officers like a private jet.

The nose of the modified A3 Skywarrior is what is shown in the Pentagon video once the intentional blurring of the pixels was corrected.



Raytheon had record revenues and record profits due to George W Bush war policies.

There was the following “bumper” device at the Pentagon. There was also an A3 Skywarrior “landing hook” so it can land on aircraft carriers. Such a device has never been installed on any Boeing 757 ever built.

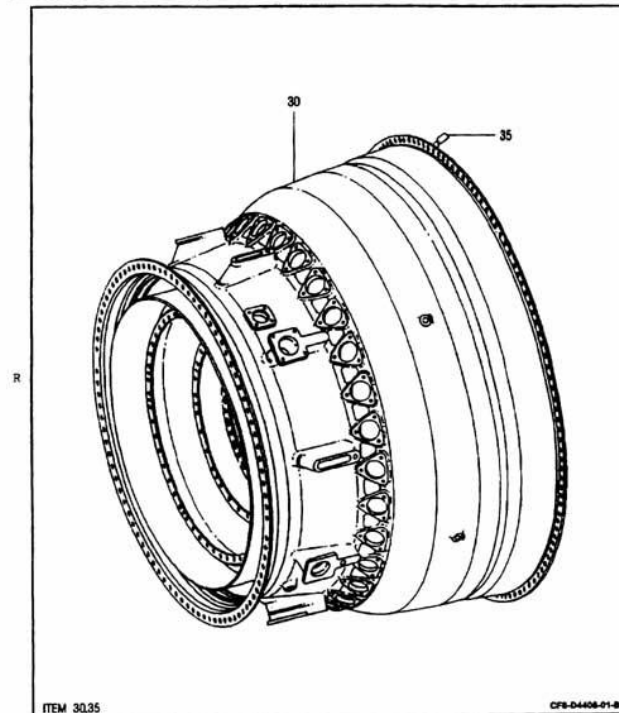


This is fore chamber of a Boeing 757 combustion chamber for the high-bypass CF6 engine installed on that commercial jet. It was never installed on any A3 Skywarrior ever built. The triangular bezel shapes all the way around are air intakes. This component is indestructible. This photo is inside the Pentagon, and is a JT8D turbojet combustion chamber of an A3 Skywarrior. This engine model has never been installed on any Boeing 757 ever built. The holes are air intakes of an older generation of jet engine design.

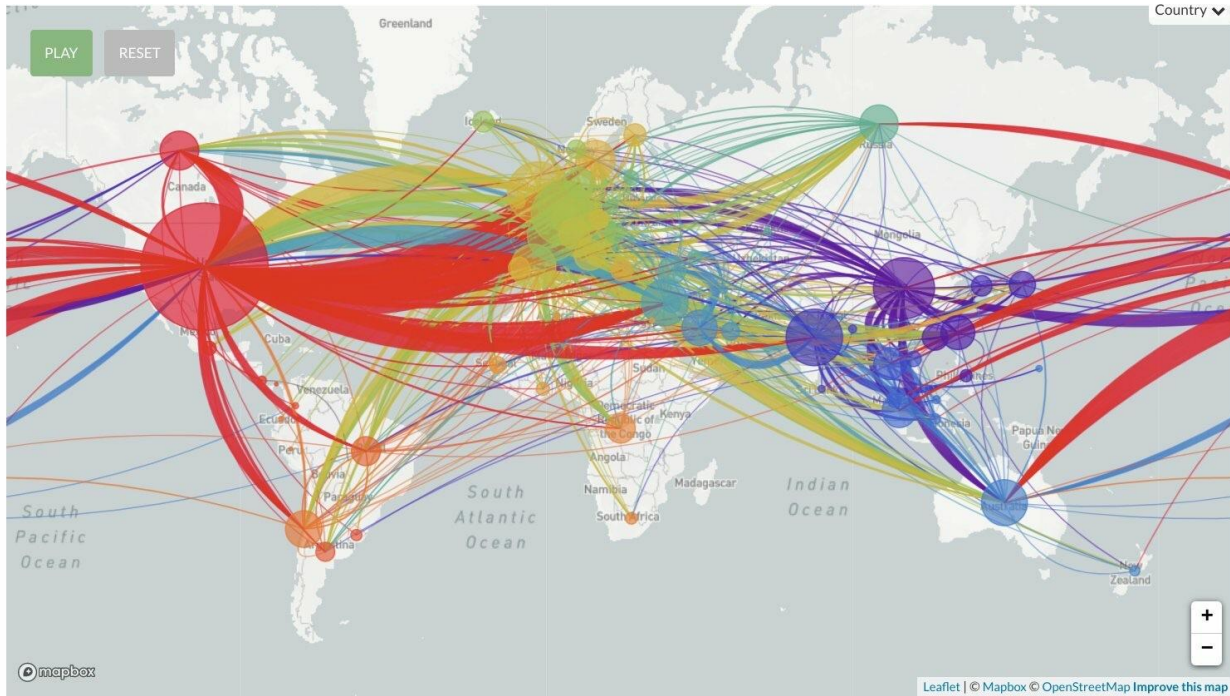
