Hello Mr. Weldon,

I have copied multiple parties since we are all focused on 9-11 Truth.

One of my favorite quotes by Mark Twain was "The two most important days of your life are the day you were born, and the day you find out why."

My second "day" was moving into nanotechnology in 2000, my company and scientists considered in the right circles to be #1 in the world. By December 2003 we had set the bar so high that even here in 2025 there is not 1 competitor or government that could go head-to-head with us. However, I have been in a huge battle since 2004 with Bush and CIA trying to destroy me due to what I know about September 11, 2001. When I was still living in the US, my non-US scientists and I were DARPA and Pentagon TSWG level. There are some surprise emails in my book that prove that.

Since you were a high ranking member of the US House and Armed Service Committee, I trust you know who RNC Treasurer William McManus was, "Mr. Mac". We were close friends for many years and why my office was in DC from March 1990 to June 1996. In addition to my Virginia LLC being a direct affiliate of Smith Barney, I was an outside strategic planner for Mr. Mac. At times Mr. Mac, former head of RNC Finance John Moran and I had long meetings about the 1994 midterms.

You are 100% correct, Sandy Berger was a traitor, but so were most in the Clinton Admin and George W. Bush Admin. You will see in the attached PowerPoint the "Donald C. Canestraro Declaration". Just as an aside but is in the chronology leading up to 9-11-2001, Mr. Mac had been long time friends with former FBI Director William Sessions, who was summarily fired by Bill Clinton due to him launching an internal investigation directly tied to the February 26, 1993 bombing of WTC 1, North Tower. You will see that in the attached PowerPoint that I prepared.

Mr. McManus offered me full RNC funding to take on Clinton in 1984 and again in 1986. I had to decline due to personal and corporate contractual commitment reasons.

I am originally from Little Rock AR and was known very well in my home state. Clinton blackmailing sitting presidents started with Reagan regarding Iran Contra, Mena AR airport, guns and ammo going out and huge cocaine shipments coming back into my home state. Then he bluffed and blackmailed George H W Bush, relegated to being a 1-term president because Iran Contra was a Bush - CIA operation that Reagan did not know about until it blew up in his face.

Imagine how small this world truly is with this fact. I own property in Canada and the next door neighbor to the West is the son of a deceased US Ambassador to Honduras and was right in the middle of the Iran Contra fiasco.

I designed the strategic plan that took the House and Senate from Clinton, as a civic duty. I am the author of 'One Way Ticket to Crawford Texas' published in 2004 and the first Conservative Republican to publicly come out against George W. Bush and Dick Cheney. Over the years as new evidence was found and confirmed, I have written about 200 articles and have been the featured guest on about 200 radio shows for 1 to 2 hour segments of their broadcast day.

My evidence trail started 1993-1996, got a huge accidental boost in November 1999. I knew something like 9-11 was coming, but not the target but I did know why Afghanistan was a primary target..

I just watched your excellent interview with Tucker Carlson and sending you information that will fill in some of the blanks. Alex Jones was not the first to predict 9-11-2001. Radio show host Bill Cooper of Colorado was and he was murdered, probably more accurately terminated. He reported about a certain activity going on at a certain Colorado airport that was directly involved in what happened on 9-11-2001. I have been to that airport to see if what was reported to me was true. It was.

I am a former architect-engineer, studied under and worked for a Frank Lloyd Wright protege E. Fay Jones. My structural professor for steel and concrete design was so fascinated by the WTC towers structural brilliance we had to do it all from scratch so we understood how it worked.

There were no structural columns in any of the 4 walls of those two 110 story towers.

I knew when I saw molten metal flowing out of one of the towers exactly what they had done. That was not a thermite bomb, they used a slow form of thermite reaction to degrade the strength of the massive central superstructure of the towers. The 1993 explosion did not even dent that core superstructure, no structural repairs were needed.

The trails we followed were not the ones most of the 9-11 Truth groups focused on. They did a great job on their path and we found prosecutable evidence and names.

I am in direct contact with Richard Gage of AE911Truth, and sent him a PowerPoint I prepared for 2 interviews I did with Brian Gerrish of UK Column on April 3 and 10, 2025. I have also sent same to Piers Robinson of International Center for 911 Justice, Dan Hanley of 911 Pilot Whistleblowers and 911 Families for Justice. That is the same PowerPoint I have attached for you.`

After my book came out in 2004, I was contacted by many people but especially the following three people:

1. Air traffic controller Boston Logan International on duty September 11, 2001. They had been threatened to never reveal what they saw on the radar screens. Threatened to the point the call to me was from a relatives phone in another state because they felt certain their phone and mobile were tapped; and
2. The Official Photographer of the World Trade Center. We communicated for months even after he went into hiding. He was in the WTC 1 North Tower office of Emory Roth Architects when federal agents came and confiscated all plans and specifications of the World Trade Center. Due to the structural designs, plans and specifications would be needed to plan a controlled demolition of all three buildings. That was well before 9-11-2001; and

3. I received an email one day that was sort of feeling me out to see if I would be "friend or foe". The reason was a certain spouse was dead and was directly involved in something about 1 hour after WTC 7 was a rubble pile. The email exchange went on for days as he was relaying to me information of some woman he worked with and was double checking everything he was writing to me or responding to me as to my questions.
